REGULATIONS

TO BE OBSERVED AT THE QUEEN'S DRAWING ROOMS TO BE HELD, ON BEHALF OF HER MAJESTY, BY HER ROYAL HIGHNESS THE PRINCESS L'UIS OF HESSE (PRINCESS ALICE OF GREAT BRITAIN AND TRELAND), AT ST JAMES'S PALACE.

By Her Majesty's Command.

The Ladies who propose to attend Her Majesty's Drawing Rooms, at St James Palace, are requested to bring with them two large cards, with their names clearly written thereon, one to be left with the Queen's Page in Attendance in the Corridor, and the other to be delivered to the Lord Chamberlain, who will announce the name to The Princess.

PRESENTATIONS.

Any Lady who proposes to be presented must leave at the Lord Chamberlain's Office, before twelve o'clock, two clear days before the Drawing Room, a card with her name written thereon, and with the name of the Lady by whom she is to be presented. In order to carry out the existing regulation, that no presentation can be made at a Drawing Room excepting by a Lady actually attending that Court, it is also necessary that a letter from the Lady who is to make the presentation, stating it to be her intention to be presenta-should accompany the presentation card above referred to, which will be submitted to the Queen for Her Majesty's approbation. It is Her Majesty's Command that no presentations shall be

made at the Drawing Rooms, except in accordance with the above regulations.

It is particularly requested that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them to The Princess.

It is not expected that Gentlemen will present themselves at the Drawing Rooms, except in attendance upon the Ladies of their families.

The State Apartments will be open for the reception of Company coming to Court at one o'clock.

The Secretary of State for Foreign Affairs has received, from Her Majesty's Consul-General at Bucharest, the translation, as follows, of a communication received by him from the Prefect of Police regarding the Passport system in Wallachia:-

Bucharest, April 20, 1867. (o. s.)

Monsieur le Consul-General,

The Minister of the Interior, by his note No. 8211, has communicated to the undersigned the decision which the Council of Ministers took at its sitting of the 14th instant, with respect to the re-establishment of all the former regulations concerning the visa of passports, which had been previously suppressed, by a decision of the Council of Ministers, on the 22d March 1866; and the Minister at the same time orders that measures be taken to execute the formalities connected with passports and patents of protection in the capital, with the only exception that the pass ports of French subjects will be countersigned without the payment of the tax.

The undersigned having in consequence issued orders to the Captains at the gates of the city, and to the Commissaries of Police, has the honour to communicate the above-named decision of the Government to the Honourable Consulate General, requesting that it may be made known to those under its jurisdiction, in order that they may conunder its jurisdiction, ...

Alteration in the Low Light at Spurn Point.

The Corporation of the Trinity House, London, has given notice that, from the 1st day of September 1867, the following alteration will take place in the Low light at Spurn Point, entrance of the Humber river :-

The light will be coloured red, visible from seaward between the bearings N.W. by N. (cutting 2 cables N.E. of the Sand Hayle buoy), round Northerly to S.E. by E. 2 E., on which latter bearing it will cut one cable North of Grimsby pier.

Alteration in the Low Light at Orfordness.
