By the Lords of Her Majesty's Most Honourable Privy Council.

Packet Company's vessels called the "Tasmanian," has lately arrived from the West Indies in the Southampton Water, in the county of Hants, and has been directed to proceed to and remain under quarantine at the Motherbank, off the Isle of Wight, and during and in the course of her voyage from the West Indies, the Yellow Fever, being a dangerous and infectious disease, appeared on board the said vessel, and attacked several persons on board thereof, and the said vessel arrived under alarming and suspicious circumstances; and whereas several persons who were on board the "Tasmanian," on her arrival, being all the persons on board the said ship who were known to be or suspected of being affected by the said disease, have since been ordered to be removed to the Quarantine Lazarette or Hulk called the "Menelaus," lying at the Motherbank, off the Isle of Wight:

And whereas it is expedient to make provision for the disposition of the other persons remaining on board the said ship:

Now, therefore, the Lords of Her Majesty's Most Honourable Privy Council, in exercise of the powers vested in them, do hereby order

- 1. That the said vessel, called the "Tasmanian," shall remain and continue at the Motherbank aforesaid, until the Lords of Her Majesty's Most Honourable Privy Coencil, or any two or more of them, shall make further order.
- 2. That the persons now on board the said vessel called the "Tasmanian," not ordered to be removed to the "Menelaus," shall be removed to the ship called the "Parana," or the ship called the "Æolus," unless ordered to remain on board the "Tasmanian" by the Medical Superintendent of Quarantine, at Southampton.
- 3. That the persons so removed on board the "Menelaus" Quarantine Hulk, or who shall hereafter be removed on board the said Hulk, or on board the "Parana," or the "Æolus," and who shall have been on board the "Tasmanian,"

shall be kept and detained on board the said Hulk, or the "Parana," or the "Æolus," until the said Lords of the Council, or any two or more of them, shall make further order.

And the Right Honourable the Lords Commissioners of Her Majesty's Treasury, and the Lords Commissioners of the Admiralty, are to give the necessary directions herein as to them may respectively appertain.

The Lords of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Acts, and of every other power enabling them in this behalf, and under and in pursuance of The Consolidated Cattle Plague Order (Scotland) of September 1867, do hereby define the part of the Port of Leith, in the county of Edinburgh, within which foreign cattle may be landed, as follows:—

All that space occupied by the docks, quays, and buildings, and the west pier, belonging to the Leith Dock Commissioners, and the sheds and road on the west side of the docks between the said docks and the property of the Caledonian Railway Company, in the parish of North Leith, and burgh of Leith, all which space is coloured light brown on the plan of Edinburgh and Leith, deposited at the Privy-Council Office, a copy of which is deposited at the office of the Town-Clerk of the burgh of Leith.

Also the under-mentioned streets or places, namely:—

The road or street called Commercial Street, the Draw-bridge across the harbour of Leith between the east end of Commercial Street and the west end of Bernard Street, the street of roads called Bernard Street and Baltie Street the portion of Constitution Street where that street a crossed from Bernard Street to Baltie Street, and

the part of the road or street called Salamander Street, extending from Baltic Street to the eastern end of the Leith Public Slaughter houses, and the said Public Slaughter-houses, which streets or places are coloured dark brown on the plan and copy so deposited as aforesaid;

And prescribe as follows:-

1. All foreign cattle landed within the said defined part of the port shall be slaughtered within four days after the landing thereof, exclusive of the day of landing, unless they are taken to a licensed market or sale within that defined part within such four days, and they shall be so taken if a market or sale is held there within the said period of four days, but if there is no such licensed market or sale within that defined part, or if no such market or sale is held there within the said period of four days, then all such foreign cattle shall be slaughtered within that defined part within the said period of four days: Provided, nevertheless, that foreign cattle may be removed out of the said defined part to the Public Slaughterhouse at Edinburgh, for the purpose of being there slaughtered, and for no other purpose, by the following route, namely:—

Along the Caledonian Railway, by the shortest route of that railway, from Leith to the Lothian Road Station of the Caledonian Railway in Edinburgh, thence, by the shortest way, from the southern end of the buildings of the said station through property of the Caledonian Railway Company, across Castle Barns, and along Semple Street, part of Fountain Bridge, and part of Ponton Street, to the Edinburgh Public Slaughterhouse:

And they shall be brought along the said railway, without stopping, in trucks or carriages exclusively s t apart or used for the purpose of conveying foreign cattle, and coloured with a red stripe two feet wide all round, to designate them as so appropriated; and such trucks and carriages shall, after they have been used for the purpose of conveying any cattle to the said Edinburgh Public Slaughter house, be cleansed and disinfected in manner provided by Article 50 of the said Consolidated Order, and if any truck or carriage is at any time used in contravention of any of the provisions of this Article, the Company or person by whom it is so used shall, for each time it is so used, be lia le to a penalty not exceeding five pounds.

2. Cattle, other than foreign cattle, within the said defined part shall not be removed therefrom alive, except in accordance with the proviso for removal to the Public Slaughter house at Edinburgh herein before contained.

The Lords of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Di. eases (Animals) Acts, and of every other power enabling them in this behalf, and under and in pursuance of The Consolidated Cattle Plague Order (Scotland) of September 1867, do hereby

define the part of the Port of Granton, in the county of Edinburgh, within which foreign cattle may be landed, as follows:—

All that space on the estate of His Grace the Duke of Buccleuch, at Granton, in Edinburghshire, lying between the water forming the West Harbour of Granton, and a line commencing at the said water at a point on the Granton Pier, at the south-western corner of the building called the First Stone Warehouse, and running due east to the central wall of the Granton Pier, thence southward along the central wall of the Granton Pier to the south-eastern corner of the West Harbour, thence westward along the northern boundary of the railway to the old road from Broom Park Cottage to the shore, thence in a north-easterly direction along the eastern boundary of the said road to the south side of the West Harbour of Granton at a point forty yards to the north of the north-eastern corner of the slaughter-house for foreign cattle at Granton, all which space is coloured pink on the plan of part of the estate of His Grace the Duke of Buccleuch, deposited at the Privy Council Office, copies of which are deposited at the offices of the Town-Clerk of the city of Edinburgh and the Clerk of Supply of the county of Edinburgh;

And prescribed as follows:-

1. All foreign cattle landed within the said defined part of the port shall be slaughtered within four days after the landing thereof, exclusive of the day of landing, unless they are taken to a licensed market or sale within that defined part within such four days, and they shall be so taken if a market or sale is held there within the said period of four days, but if there is no such licensed market or sale within that defined part, or if no such market or sale is held there within the said period of four days, then all such foreign cattle shall be slaughtered within that defined part within the said period of four days: Provided, nevertheless, that foreign cattle may be removed out of the said defined part to the Public Slaughterhouse at Edinburgh, for the purpose of being there slaughtered, and for no other purpose, by the following route, namely:-

Along the Caledonian Railway, by the shortest route of that railway, from Granton to the Lothian Road Station of the Caledonian Railway in Edinburgh, thence, by the shortest way, from the southern end of the buildings of the said station, through property of the Caledonian Railway Company, across Castle Barns, and along Semple Street, part of Fountain Bridge, and part of Ponton Street, to the Edinburgh Public Slaughter-house.

And they shall be brought along the said railway, without stopping, in trucks or carriage exclusively set apart or used for the purpose of conveying foreign cattle, and coloured with a red stripe two feet wide all round to designate them as so appropriated; and such trucks and carriages shall, after they have been used for the purpose of conveying any cattle to the said Edinburgh Public Slaughter-house, be cleansed and disinfected in manner provided by Article 50 of the said Consolidated Order, and if any truck or carriage is at any time used in contravention of any of the provisions of this Article, the Company or person by whom it is so used shall, each time it is so used, be liable to a penalty not exceeding five pounds.

2. Cattle other than foreign cattle within the | said defined part shall not be removed therefrom alive, except in accordance with the proviso for removal to the Public Slaughter-house at Edinburgh hereinbefore contained.

The Lords of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Acts, and of every other power enabling them in this behalf, and under and in pursuance of The Consolidated Cattle Plague Order (Scotland) of September 1867, do hereby define the part of the Port of Glasgow, in the county of Lanark, within which foreign cattle may be landed, as follows:

All that space in the city of Glasgow lying within a line commencing on the River Clyde at the south-western corner of the Victoria Bridge, and running along the southern bank of the River Clyde to the western side of the Ferry Steps, near the northern end of West Street, thence in a southerly direction for a distance of forty-three yards, to the north-western corner of the Clyde View Buildings, thence in an easterly direction along the southern side of the streets or roads called Clyde Place, Carlton Place, and Clyde Terrace, to the eastern end of Clyde Terrace, thence in a north-easterly direction to the south-eastern corner of the Victoria Bridge, thence in a northerly direction along the eastern side of the Victoria Bridge to the western end of East Clyde Street, thence in an easterly direction along the south side of East Clyde Street to Market Lane, thence northward along the east side of Market Lane to the north-west corner of the Courthouse, thence westward across Market Lane, and along the northerly boundary of the Glasgow Central Slaughter-house to Merchant Lane, thence southward along the east side of Merchant Lane to East Clyde Street, thence westward along the northern side of East Clyde Street to the southwestern corner of Park's Place, thence in a straight line to the north-western corner of Victoria Bridge, thence southward along the western side of the said bridge to the south-western corner of the Victoria Bridge aforesaid, all which space is coloured purple on a plan of part of the city of Glasgow, deposited at the Privy-Council Office, a copy of which is deposited at the office of the Town-Clerk of the city of Glasgow;

And prescribe as follows:-

1. All foreign cattle landed within the said defined part of the port shall be slaughtered within four days after the landing thereof, exclusive of the day of landing, unless they are taken to a licensed market or sale within that defined part within such four days, and they shall be so taken if a market or sale is held there within the said period of four days, but if there is no such licensed market or sale within that defined part, or if no such market or sale is held there within the said period of four days, then all such foreign cattle

shall be slaughtered within that defined part within the said period of four days.
