By the Lord Lieutenant and Privy Council of Ireland.

ABERCORN,

HEREAS by an Order in Council bearing date the 15th day of March 1866, made in pursuauce of the Acts of Parliament therein mentioned or referred to, that is to say, "The Cattle Disease Act (Ireland), 1866," and the Acts therein partly recited, it is amongst other things ordered that from and after the date of the publication of said Order in the Dublin Gazette it should not be lawful to import Swine into Ireland from any port or place within that part of the United Kingdom called Great Britain.

And whereas it is now deemed expedient to permit the importation of Swine subject to certain restrictions.

Now we, James, Marquis of Abercorn, Lord Lieutenant of Ireland, by and with the advice of Her Majesty's Privy Council in Ireland, do hereby, in exercise of the powers given to us by the Statutes aforesaid, order as follows :----

That from and after the date of the publication of this Order in the Dublin Gazette, it shall be lawful to import Swine into Ireland from any port or place within that part of the United Kingdom called Great Britain, and all Swine so imported shall be disembarked in such ports or places in Ireland as the Lord Lieutenant shall from time to time direct, such importation to be subject to the restrictions and conditions hereinafter mentioned and set forth, that is to say :-

Such Swine shall be examined in the port or place of proposed debarkation in Ireland by an Inspector appointed by the Lord Lieutenant for that purpose, and no Swine shall be allowed to enter Ireland from the seabord if any of such Swine shall be found by such Inspector to be suffering from disease, even in a latent form ; and if such Inspector be of opinion that there is not any disease existing

the ship or vessel, are free from disease, which Certificate is to be countersigned by the said Captain or Ship-owner's Agent, and thereupon, and previous to the debarkation, to be handed over to the Collector of Customs, or one of his officers. All such Swine while they are on board of such ship or vessel, and in the port or place in Ireland aforesaid, shall be disinfected under the supervision of the Inspector, or in the presence of an officer of Her Majesty's Customs, by each and every of such Swine being dipped in a solution of carbolic acid made according to the formula of two ounces of the carbolic acid of commerce to one gallon of water, well mixed, and the expense of such disinfection shall be borne by the Consignee, his Agents, or others importing such Swine.

And we do hereby further order that, in the event of any of such Swine as aforesaid being found suffering from disease, or evincing such symptoms as would lead such Inspector to suspect the existence of disease even in a latent form, and that it be, in his opinion, of an infectious or contagious nature, none of the Swine belonging to the cargo shall be landed; and such Swine as aforesaid, affected or suspected to be affected with infectious or contagious disease, or which have been in the same vessel with any animals affected or suspected to be affected with infectious or contagious disease, may be treated and dealt with according to the Order in Council of the 22d day of May 1866, and the ship or vessel containing such animals, and all contained therein, may be treated and dealt with as being within a proclaimed or infectious district, according to the said Order dated the 22d day of May 1866.

And we do hereby further order that any and every Ship-owner, Ship-agent, and Ship-captain, or any other person or persons disembarking, landing, or attempting to disembark or land any Swine in Ireland from Great Britain or elsewhere, without observing and performing the restrictions and conditions in this Order contained, and also every opinion that there is not any disease existing portions in this Order contained, and also every in such Swine, or in any other animals forming part of the live cargo of the vessel, he shall give to the Captain of the ship or vessel, or to the Ship-owner's Agent, a Certificate in the form annexed hereto, stating that in his opinion such Swine, and all other animals in than four, a penalty not exceeding \mathcal{L}_2 for each of the provisions of this Order be main than four, a penalty not exceeding \mathcal{L}_2 for each other than four, a penalty not exceeding \mathcal{L}_2 for each other than four a penalty of the provisions of the provision of the provisio animal may be imposed instead of the said penalty | Deputy-Assistant Superintendent of Stores F. New Rock in Kúrusima Strait.

Notice is hereby given that a rock has been discovered (by H.M.S. "Perseus" striking on it,) in the Kurusima Strait, leading from the Misiminada to the Bingo-nada of the inland sea, and, as it lies in the fairway of ships, is of much importance.

The rock, which is named the Perseus Rock, is about 20 feet in circumference, and has only 7 feet on it at low-water springs; it lies E. $\frac{1}{2}$ N., a third of a mile from the north point of Kosima, with the following bearings :---

UNITED STATES.-FLORIDA.

Range Light on Amelia Island.

The United States Government has given notice that a range light, consisting of a steamer lens, is now exhibited in front of Amelia Island Lighthouse, north-east coast of Florida.
