NOTICE is Hereby Given, that Application is intended to be made to Parliament in the ensuing Session for an Act to incorporate a Company (hereinafter called "the Company"), and to confer on the Company all or some of the following powers (that is to say):

To acquire the exclusive right of depositing, breeding, dredging, and fishing for oysters within the limits or boundaries hereinafter described, or some part or portion thereof (that is to say):

To make, maintain, and provide dams, embankments, sea walls, oyster pits, oyster beds, buildings, workshops, stores, sheds, wharves, lay-byes, locks, sluices, gates, flood-gates, openings, cranes, approaches, piers, and other apparatus, or works necessary or convenient for any purposes of the Company

To purchase and take compulsorily, or by agreement, lands, houses, buildings, or other works, and waters situate within or abutting on the aforesaid parishes and other places, or some of them, and any tolls, rights, franchises, or privileges relative thereto;

To purchase or take on lease any undertaking or property necessary or expedient belonging to any other Company, person, or persons, or Corporation, and to enter into agreements in regard thereto;

To confer, vary, or extinguish any rights or privileges which may be affected by, or may affect, the purposes of the Company;

To prohibit all persons, other than those acting under the authority of the Company, from dredging or fishing within the said limits or boundaries otherwise than by line and hook, or with nets solely adapted for taking floating fish, and from doing other acts prejudicial to the fishery, and to create penalties.
