THE following Addresses of Congratulation to the Queen, in reference to the atrocious attempt upon the life of His Royal Highness the Duke of Edinburgh, having been transmitted to the Right Honourable Gathorne Hardy, Her Majesty's Principal Secretary of State for the Home Department, for presentation, have accordingly been presented by him to Her Majesty, who has been pleased to receive the same very graciously :-

To The QUEEN's Most Excellent Majesty. The Loyal and Dutiful Address of the Highland Society of London, unanimously adopted at a General Court of the Society holden on Tuesday the 5th day of May, in London.

May it please your Majesty,

A COWARDLY attempt to assassinate His Royal Highness the Duke of Edinburgh has filled the hearts of all your Majesty's loyal subjects, throughout the wide-spread dominions of the British Crown, with indignation and alarm.

On so unprecedented and sinister an event the Highland Society of London desires to express its

respectful sympathy and condolence.

It is a matter of congratulation to the Highland Society of London that your Majesty's Royal Person and House are nowhere more secure than in that country whence your Majesty derives your title to the Throne of the United Kingdom.

The Highland Society of London congratulate your Majesty on the escape of His Royal Highness, who is one of the Members of its body, and rejoice that the iron hand of Justice holds firmly in its grip a miscreant whose fate will be deterrent to those whose trade is secret conspiracy and dastardly assassination.
