letters on the sides. During the day a ball will be hoisted at the mizen and a yellow flag with a blue cross on the mainmast.

The vessel would be moored on the north-west extremity of the north-west bank, and the position, as given in lat. 63° 26<sup>3</sup>/<sub>4</sub> N., long. 20° 45<sup>3</sup>/<sub>4</sub> East of Greenwich.

In foggy weather and when the night is thick a bell will be sounded on board.

The vessel is removed for the winter months on the 20th October; and if, from other causes, her position is changed, the light will not be exhibited or the yellow flag hoisted.
