THE Secretary of State for Foreign Affairs has received, from the Acting British Consul-General at Havana, the following circular, giving notice that all persons arriving at that Port must be provided with passports viséd by a Spanish Consul:—

The Captain-General to Acting Consul General Crawford.

#### (TRANSLATION.)

THE abuse which is being constantly committed by masters of steamers and sailing-vessels arriving at the Ports of this Island, of admitting passengers without passports, or without these documents being viséd by the Spanish Consul at the places from whence they embark, thereby openly contravening the laws of this Island, which every one should respect, has obliged me to issue orders this day requiring all shipmasters to retain on board of their ves els, for reconveyance away from this Island, all persons who may be found so circumstanced, excepting those persons whose admission may be deemed allowable after previous guarantee of their respective Consuls, or a certificate of responsibility from two persons of respectability at the place where they arrive.
