PRESENT,

The QUEEN's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the ninth of November one thousand eight hundred and sixty-eight, in the words following, viz.:—

"Whereas by your Majesty's Order in Council, dated the sixteenth day of February one thousand eight hundred and sixty-six, it is provided that Officers who accept the Greenwich Hospital Pension shall be allowed to retain it notwithstanding promotion. And whereas we are of opinion that it would be expedient to place these pensions in all respects on the same footing as naval pensions, which are forfeited on promotion. We do therefore beg leave to recommend that your Majesty will be graciously pleased, by your Order in Council, to cancel the provision in question, and to direct that in future Greenwich Hospital Pensions, as well as naval pensions, be forfeited on promotion, except in the case of the Ten Greenwich Hospital Pensions for Flag Officers."

Her Majesty having taken the said Memorial into consideration, was pleased, by and with the advice of Her Privy Council, to approve of what is therein proposed. And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.
