sioners power to hold property, to sue and be sued, and to have a Common Scal, and all other powers, rights, and privileges usual or necessary, and to prescribe their duties.

To vest in the Commissioners the power and right of supplying with Water the Parliamentary Burgh of Dundee, as such Burgh is defined by the Public Act 2 and 3 William IV., cap. 65, the Harbour of Dundee, and Shipping frequenting the same, and district and places adjacent to the said Parliamentary Burgh, including the Burgh of Broughty Ferry, as fixed under the provisions of the Public Act 25 and 26 Vic., cap. 101.

To transfer from the Commissioners under the said Act, 1 Victoria, cap. 126, and the Corporation, and from each of them, to and vest in the Commissioners under said Bill, or to provide for transferring to and vesting in the Commissioners absolutely from such date, and without compensation or consideration, or for such price, compensation, or other consideration, and upon such terms and conditions as have been or may be agreed upon, or as may be fixed by or under the provisions of the said Bill, the ground and property called the Ladywell, situated on the west side of the Hilltown of Dundee, with the Tanks, Reservoirs, Water, Sources of Water, Pipes for distributing the same, and the several Wells and erections, and all other property, presently vested in the Commissioners under the said Act, and the Corporation or either of them, for supplying the said Burgh of Dundee with Water, and all the rights, powers, and privileges which now are, or at the date of transfer may be vested in the Commissioners under the said Act and the Corporation or either of them in relation thereto.

To transfer from the Dundee Water Company, incorporated by the Act (local and personal) 8 and 9 Victoria, caput 137 (hereinafter called "the Company"), to and vest in the Commissioners, or to provide for transferring to and vesting in the Commissioners, by sale and purchase absolutely (compulsorily or by agreement), or to empower the Company to sell to the Commissioners, and the Commissioners (compulsorily or by agreement), to purchase from the Company, from such date, and for such price, compensation, Annuities, or other consideration, and upon such terms and conditions as have been or may be agreed upon, or as may be fixed by, or under the provisions of the said Bill, the Undertaking of the Company, and the Streams of Water, Springs, Rights to Water, Reservoirs, Aqueducts, and other Works, Conduits, Cisterns, Mains, Pipes, Lands, Houses, Buildings, and other Property, Plant, Estate, and Effects, which now are, or at the date of the transfer, may belong to the Company, or such parts of the said Undertaking and others foresaid as may be specified in the Bill, and all or some of the powers, rights, and privi-leges which now or at the date of transfer may be vested in or exercised by the Company under and in virtue of the several Acts relating to the Company hereinafter mentioned, or in any other way, and to prescribe the mode of settling the price, compensation, Annuities, or other consideration, by arbitration or otherwise.

To enact and provide for all such powers, provisions, matters, and things as may be necessary, convenient, or proper for effecting the transference to and vesting in the Commissioners of the ground and property, tanks, and others before-mentioned by a tributary burn (commonly called Auchterhouse Burn), on which the Mill of Dronly is situated,

of the Commissioners under the said Act, 1 Vict., cap. 126, and the Corporation, or either of them, all, or some of them, and the transference to and vesting in the Commissioners, or sale and purchase as aforesaid, of the Undertaking, Streams, Springs, Reservoirs and others before-mentioned of the Company, all or some of them, and of all rights, powers, and privileges in relation thereto respectively, and to authorise and empower the Commissioners on the one hand, and the Commissioners under said Act, 1 Vict., cap. 126, the Corporation and the Company, or any one of them, on the other, to enter into and execute all agreements, conveyances, and other deeds and writings which may be necessary for effecting the objects aforesaid, and to confirm any such agreement or agreements which may have been or may be entered into between them prior to the passing of the

To repeal wholly or partially, or to continue, or to alter, and amend the several Acts relating to the Company, or any one or more of them, viz. (local and personal) 8 and 9 Vict., cap. 137; 16 Vict., cap. 50; 25 Vict., cap. 43; 29 and 30 Vict., cap. 133, and to dissolve or make provision for the dissolution and winding up of the Company.

To enable the Commissioners to maintain, repair, alter, and enlarge the Works of the Commissioners under said Act, 1 Vict., cap. 126, and of the Corporation and of the Company respectively, to be vested in the Commissioners by or under the provisions of the said Bill.

To enable the Commissioners to acquire by Agreement, lands, houses, streams, springs, and other property, or rights therein, for the purpose of enabling them the better to supply with Water for domestic, trading, and other purposes, the area within the limits to be prescribed in the Bill, and to empower the Commissioners, and the Owners of, and other Parties interested in such lands, houses, streams, springs, and other property, and any Companies, Corporations, Commissioners, Trustees, and other bodies or persons, whether under legal disability or not, to contract and agree with each other for the acquisition by the Commissioners, under the Bill, of such lands, houses, streams, springs, and other property, or rights therein, absolutely, or by way of feu, lease in perpetuity, or otherwise, at such price, and subject to such feu-duty, ground annual, or rent, or for such other consideration as may be fixed upon, and to execute all agreements, conveyances, contracts of feu and of ground annual, leases, and other deeds necessary for these purposes.

To enable the Commissioners to execute Works on the Lands which may be acquired by them by the operation of, or under the authority of the provisions in the Bill, or on the Lands of others consenting to such Works, for the better carrying out of the purposes of the Bill.

To empower the Commissioners to supply Water to the Parliamentary Burgh of Dundee, as the boundaries thereof are fixed by the said Public Act 2 and 3 Will. IV., cap. 65, and the District and Places adjacent thereto, all lying and comprehended within the following boundaries—that is to say, the Water of Dighty, from where it runs into the Frith of Tay, in the Parish of Monifieth, up to a point where it is joined by a tributary burn (commonly called Auchterhouse Burn), on which the Mill of Dronly is situated,
