

debts of the Trust, and the payment of interest thereon, and of the further sums which the Trust are still entitled to borrow and raise thereunder, and to authorise the payment out of any sums already raised, or hereafter to be raised, of interest on the sums for the time being raised or owing by the Trust for the purposes of the Additional Works Act, and that until such additional works shall have been completed and in operation, or as shall be defined by the Bill.

Ninth,—To repeal, or alter, or amend the 100th section of the Transfer Act providing for the formation of a sinking fund, and to make other provisions instead thereof, and to postpone the period for the commencement of a sinking fund.

Tenth,—To incorporate with the Bill some of the provisions of "The General Police and Improvement (Scotland) Act, 1862," and particularly section 91 of that Act relating to assessments of fractions of one pound.

Eleventh,—To repeal or alter, vary, and amend sections 85 and 87 of the Water Works Clauses Act, 1847, and to make other provision for the recovery of penalties and determination of questions now only competent before the Sheriff of the County of Renfrew, and to provide that all things in the said Act, or in the Transfer Act, or Additional Works Act, or in any Acts or Act incorporated therewith, or with either of them, authorised or required to be done by the Sheriff of the County of Renfrew, may and shall be done by the Magistrates of the Town of Greenock.

Twelfth,—To amend, alter, or repeal the proviso to section 39 of the Transfer Act prohibiting the Trust from increasing the height of the embankment of any existing reservoir, and to make other provision with reference thereto.

Thirteenth,—To alter, vary, or extinguish all rights and privileges which would or might prevent, impede, or interfere with any of the objects aforesaid being carried into effect, and to confer all other rights and privileges necessary or expedient for effecting the said objects, or in relation thereto.

Fourteenth,—To incorporate with the Bill the necessary provisions of "The Commissioners Clauses Act, 1847."

EDINBURGH PARISH POORHOUSE WATER SUPPLY.

(Empowering the Parochial Board of the Parish of Edinburgh to obtain from the Edinburgh Water Company Water for the Supply of the New Poorhouse and Grounds and Buildings in connection therewith, erected, or to be erected, at Craiglockhart; New Works; Power to enter into Agreements; Extension of Area for Water Supply; Amendment or Repeal of Acts; other purposes.)

NOTICE is Hereby Given, That application is intended to be made to Parliament in the next Session for leave to bring in a Bill for the following purposes, or some of them, viz. :—

To authorise and empower the Parochial Board of the Parish of Edinburgh (hereinafter called "The Board"); and David Curror, the present Chairman, and James Blackadder, Joseph Hood Stott, James Brown, George Meldrum, Alexander Boswell, James Gray, senior, James Gray, junior, and James Tait, junior—all now or lately residing in Edinburgh, and now or formerly members of The Board, and Disponees in Trust for The Board, of the lands of Craiglockhart, situated within the parish of Colington or Colinton, and County of Edinburgh (hereinafter called "The Trustees"), or some of them to obtain from The Edinburgh Water Company (hereinafter called "The Water Company") water for the supply of the new Poorhouse and grounds and buildings in connection therewith, erected, or to be erected, on the lands of Craiglockhart, and to take such supply of water from a pipe called the Swanston Main Pipe, belonging to the Water Company, at or near a point on the farm or lands of Comiston where such main pipe crosses the public road leading from Edinburgh to Hunters' Tryst, and situated about 200 yards or thereby in a north-westerly direction from Hunters' Tryst, in the parish of Colington or Colinton aforesaid; and in order to carry into effect the objects and purposes of the said Bill, power will be taken to construct and maintain the following works, or some of them, viz. :—

1. A pipe or conduit of six inches in diameter or thereby to be connected with and carried from the said Swanston Main Pipe, commencing at the point hereinbefore described, and extending therefrom in a north-westerly direction 10 yards or thereby, and terminating in the reservoir, cistern, or tank second hereinafter described, together with a meter, scouring apparatus, and all necessary appliances in connection therewith.

2. A reservoir, cistern, or tank, 30 ft. x 12 ft. x 10 ft., or thereby (interior measurement), in connection with the pipe or conduit No. 1, situate on the lands and estate of Comiston, and parish aforesaid, and 10 yards or thereby north-west from the point of connection with the said Swanston Main Pipe before described, extending for 30 ft. further or thereby in a north-westerly direction, and connecting the said pipe or conduit No. 1 with that immediately hereinafter described in No. 3.

3. A pipe or conduit three inches in diameter or thereby, commencing in the said reservoir, cistern, or tank No. 2, and extending therefrom in a north-westerly direction 1700 yards or thereby through the farms and lands of Comiston, Oxgangs, and Colinton Mains, all in the said parish of Colington or Colinton, and terminating in the central tower of the said new Poorhouse on the lands of Craiglockhart; all which works will be situated in the parish of Colington or Colinton aforesaid, and county of Edinburgh.

And it is proposed by the Bill to take the following, or some of the following, among other powers:

To deviate laterally from the lines of the works to the extent shown in the plans, and to deviate vertically from the levels to the extent shown in the sections, hereinafter mentioned and described in the Bill:

To make and maintain all necessary cuttings and embankments, to cross under, over, or on the level of, and divert, alter, or stop up, whether temporarily or permanently, all turnpike or other roads and footways, streams, brooks, and water courses within the aforesaid parish in the line of
