DUBLIN CASTLE, December 15, 1868.

This day the Privy Council assembled, when His Grace Richard Chenevix, Lord Archbishop of Dublin; General the Right Honourable Lord Strathnairn, G.C.B., G.C.S.I., Commanding Her Majesty's Forces in Ireland; and the Right Honourable Jonathan Christian, Lord Justice of Appeal, were sworn Lords Justices of Ireland.

Board of Trade, Whitehall, December 11, 1868.

The Right Honourable the Lords of the Com mittee of Privy Council for Trade have received, through the Secretary of State for Foreign Affairs, from Her Majesty's Ambassador at St Peters-burgh, an extract from the "Journal de St Pétersbourg," of the $\frac{18}{30}$ th November last, of which the following is a translation :-

A decision of the Council of the Empire, which received the sanction of His Majesty the Emperor on the 14th November last, suppresses the free importation of foreign salt into the ports of the White Sea, with the exception of the Murmansk Coast and the town of Kola, where the importation will continue free, as hitherto. The prohibition will come into force on and after the 14th October 1869. Salt coming from the Government Salt Works at Archangel, which shall be forwarded at the Murmansk Coast, shall be exempt from excise duty, provided that every dispatch shall weigh 1,000 pouds at least, and shall be effected, with the permission of the local administration of excise, at one of the following ports, viz. :--Archangel, Onega, Sumskoï, Kem or Kola.

Sea salt from the sea coasts of the White Sea and Arctic Ocean, destined for the salting of fish upon the spot, or forwarded to the Murmansk Coast or to Kola, shall be also exempt from the excise duty.
