Flashing Light on Les Roche Douvres.

With reference to Notice to Mariners, No. 77, dated 15th August 1868, the French Government has given notice that, from the 15th day of December 1868, the light would be exhibited from the lighthouse on the Plateau des Roche Douvres, North Coast of France.

The light is a *flashing* white light, the eclipses succeeding each other every five seconds; it is elevated 144 feet above high water, and in clear weather should be seen from a distance of 14

The tower is iron, painted white, and 148 feet high; its position is in lat. 49° 6′ 28″ N., long. 2° 48' 54" West of Greenwich.

In consequence of the state of the weather the lighthouse has not been completed to its proposed height, and it is intended in the course of next year to raise the focus of the light to 180 feet above high water, when a more powerful illuminating apparatus will be substituted for the one at present in use.
