The Board of Trade have received, from the Secretary of State for Foreign Affairs, the following copy of a Despatch from Her Majesty's Ambassador in Constantinople, with reference to the establishment of Refuge-houses at the entrance of the Black Sea:—

INTERNATIONAL COMMISSION OF THE BOSPHORUS.

Notice to Mariners.

With the view of rendering assistance to vessels that may be wrecked on the desert shores of the Black Sea, in the vicinity of the entrance to the Bosphorus, the International Commission have had eight refuge houses constructed at the following places:—

On the Asiatic coast at Ahal hulta, Galarabournou, Adajicklar, and Kara-bouroun. On the European coast at Marmarjick, Agatchli Chiflick, Coondooz, and Chesmedjick. The houses on the Asiatic coast are painted white, and those of the European in red and white horizontal bands. As a means also of further distinction between those

coasts, the Commission have had painted, in addition to the rocks on the coast of Asia mentioned in the Notice of the 19th May last, those of Ada-jicklar, and Islet off Shilly. One of the aqueducts at Kilios has been painted in red and white horizontal bands.
