Now therefore Her Majesty, in exercise of the power vested in Her by the said recited Act, by and with the advice of Her Privy Council, is pleased to direct that upon the lighting of the said light there shall be paid in respect thereof, for every vessel, whether British or Foreign, which may pass or derive benefit therefrom, the toll of eight-sixteenths of a penny per ton of the burthen of every such vessel, for each time of passing or deriving benefit therefrom, if on an oversea voyage, and one-sixteenth of a penny per ton for each time of passing or deriving benefit therefrom if on a coasting voyage.
