Board of Trade, Whitehall, October 8, 1869.

The Lords of the Committee of Privy Council for Trade have received, from the Secretary of State for Foreign Affairs, an Official Notice of the establishment of a Coast Semaphore Station on the Island of Osco, in Norway, a translation of which is subjoined:—

#### (TRANSLATION.)

Public Notice from the Director of Norwegian Telegraphs.

From 1st October 1869, will be opened a Semaphore Telegraph Coast Station on the island of "Osco," off Christiansand.

Besides exchanging ordinary telegrams from and to the station, the station will also be able to exchange signals to and from vessels passing at sea by means of the International Commercial Code of Signals at present in use by the commercial marine of all Nations.

The text of the telegram can, at the option of the sender, be drawn up either in ordinary language (in which case only in Norwegian), in cipher, or in groups of combinations, as directed in the signal book.

When such a maritime telegram is destined for the master of a ship, his name need not be inserted; but the address must always contain the description of the vessel's rig and port of registry.

Maritime telegrams are treated and charged as ordinary telegrams, with an extra charge however of 44 skillings for transmission to and from sea for an ordinary telegram of twenty words, and an additional 22 skillings for every ten words in excess.

The charge for the telegram sent from sea will be collected from the receiver.
