## TREASURY WARRANT.

WHEREAS by an Act of Parliament made and passed in the session of Parliament holden in the third and fourth years of the reign of Her Majesty, chapter 96, for the regulation of the duties of postage, power is given to the Commissioners of Her Majesty's Treasury, from time to time, by Warrant under their hands, to alter and fix any of the rates of British postage or inland postage payable by law on the transmission by the post of foreign or colonial letters or newspapers, or of any other printed papers, and to subject the same to rates of postage according to the weight thereof, and a scale of weight to be contained in such Warrant, and from time to time by Warrant as aforesaid to alter or repeal any such altered rates, and make and establish any new or other rates in lieu thereof, and from time to time by Warrants aforesaid to appoint at what time the rates which may be payable are to be paid.

And whereas further powers are given to the Commissioners of Her Majesty's Treasury by another Act made and passed in the session of | Parliament holden in the tenth and eleventh years of the reign of Her Majesty, chapter 85, for giving further facilities for the transmission of letters by post, and for the regulating the duties of postage thereon, and for other purposes relating to the Post-office.

And whereas it is expedient to reduce the rates of postage now chargeable upon certain letters transmitted by the post between the United Kingdom and Canada, Nova Scotia, and New Brunswick, in the manner hereinafter mentioned.

Now we, the Commissioners of Her Majesty's Treasury, in exercise of the powers reserved to us in and by the said hereinbefore recited Acts of Parliament respectively, and each of them, and of all other powers enabling us in this behalf, do, by this Warrant, under the hands of two of us, the said Commissioners (by the authority of the Statute in that case made and provided), order, declare, and direct as follows, that is to say :

1. On every letter not exceeding one half of an ounce in weight, posted in the United Kingdom addressed to Canada, Nova Scotia, or New Brunswick, or posted in Canada, Nova Scotia, or New Brunswick, addressed to the United Kingdom, and transmitted by the post between the United Kingdom and Canada, Nova Scotia, or New Brunswick, by British or Canadian packet-boat, or by private ship, and without passing through a foreign country, there shall be charged, taken, and paid an uniform rate of postage (British and Colonial combined) of threepence.

2. On every letter not exceeding one half of an ounce in weight, posted in any of Her Majesty's colonies or in any foreign country, addressed to Canada, Nova Scotia, or New Brunswick, or posted in Canada, Nova Scotia, or New Brunswick, addressed to any of Her Majesty's colonies or any foreign country, and transmitted by the post between any of Her Majesty's colonies or any foreign country and Canada, Nova Scotia, or New Brunswick, through the United Kingdom, the said letter being conveyed between the United Vin adverse and Ocean New Section of New Kingdom and Canada, Nova Scotia, or New Brunswick, by British or Canadian packet-boat, or by private ship, and without passing through a foreign country, there shall be charged, taken, and paid for such transmission thereof respectively between the United Kingdom and Canada, Nova Scotia, or New Brunswick, an uniform rate of postage (British and Colonial combined) of twopence.

3. On every such letter transmitted as herein-after mentioned between the United Kingdom and Canada, Nova Scotia, or New Brunswick, exceeding one half of an ounce in weight, there shall be charged, taken, and paid the several further and additional and progressive rates of postage hereinafter mentioned, (that is to say)-

- On every such letter exceeding one half of an ounce and not exceeding one ounce in weight, there shall be charged, taken, and paid two rates of postage;
- And on every such letter exceeding one ounce and not exceeding one ounce and the half of another ounce in weight, three rates of postage;
- And on every such letter exceeding one ounce and the half of another ounce and not exceeding two ounces in weight, four rates of postage;
- And for every additional half of an ounce in weight of any such letter above the weight of two ounces, there shall be charged, taken, and paid one additional rate of postage, and every fractional part of such additional half now chargeable by law thereon.

of an ounce in weight shall be charged as an additional half of an ounce in weight; and each progressive and additional rate chargeable under this clause shall be estimated and charged at the sum which any such letter would be charged with under this Warrant if not exceeding one half of an ounce in weight.

4. On every letter transmitted by the post between any of Her Majesty's colonies or any foreign country and Canada, Nova Scotia, or New Brunswick, through the United Kingdom, the said letter being conveyed between the United Kingdom and Canada, Nova Scotia, or New Brunswick, by British or Canadian packet-boat, or by private ship, and without passing through a foreign country, there shall be charged, taken, and paid, over and above the uniform rates of postage payable thereupon, under the provisions of this Warrant hereinbefore contained for the transmission thereof between the United Kingdom and Canada, Nova Scotia, or New Brunswick, such further or additional rates of postage for the con-veyance of every such letter between the British colony or foreign country from or to which the same shall be forwarded, and the port in the United Kingdom of the arrival or departure of the packet-boat or private ship conveying the same between such colony or foreign country and the United Kingdom, as shall from time to time be charged and payable for British postage on letters posted in or addressed to such colony or foreign country, and transmitted to or from such port of arrival or departure in the United Kingdom.

5. The postage of every letter posted in the United Kingdom addressed to Canada, Nova Scotia, or New Brunswick, or posted in Ćanada, Nova Scotia, or New Brunswick, addressed to the United Kingdom, shall be paid at the time of the same being posted, but if any such letter shall be posted for transmission by the post under the authority of this Warrant without any postage having been paid thereon, or with a postage paid thereon less in amount than the rate or rates of postage to which the same would be liable under or by virtue of this Warrant, every such letter shall be charged with the deficient postage, together with a further and additional rate of postage of threepence.

6. Nothing herein contained shall be construed to extend to any letters posted in or addressed to France, or to any letters transmitted through France, otherwise than in closed mails, nor in anywise to annul, prejudice, or affect any of the exemptions or privileges granted by or under the said hereinbefore recited Acts, or either of them, or by or under any other Acts of Parliament relating to the Post-office, or to annul, prejudice, or affect any of the privileges to which scamen, soldiers, and others employed in Her Majesty's service, are by law entitled of sending and receiving letters by the post, subject to the regulations and restrictions made and in force for the time being in respect of the same.

7. The several terms and expressions used in this Warrant shall be construed to have the like meaning in all respects as they would have had if inserted in the said recited Act passed in the fourth year of the reign of Her Majesty, chapter 96.

8. The rates of postage fixed by this present Warrant on the letters transmitted as herein respectively mentioned shall be in lieu of those

#### TREASURY WARRANT.

WHEREAS by an Act of Parliament passed in the fourth year of the reign of Her Majesty, chapter 96, for the regulation of the duties of postage, certain scales of weight and rates of postage were fixed and made chargeable and payable upon, for, or in respect of letters, newspapers, parliamentary proceedings, and printed papers, transmitted and forwarded by the post, and various regulations were made for facilitating the transmission of such letters and papers by the post, and by the same Act powers were given to the Commissioners of Her Majesty's Treasury from time to time, by Warrant under their hands, to alter and fix any of the rates of postage therein mentioned.

And whereas further powers were given to the Commissioners of Her Majesty's Treasury by another Act of Parliament passed in the eleventh year of the reign of Her Majesty, chapter 85, for giving further facilities for the transmission of letters by post, and for the regulating the duties of postage thereon, and for other purposes relating to the Post-office.

And whereas it is expedient to reduce the postage now chargeable on packets consisting of patterns or samples transmitted by the post within the United Kingdom.

Now we, the Commissioners of Her Majesty's Treasury, in exercise of the powers reserved to us in and by the said hereinbefore recited Acts of Parliament and each of them, and of all other powers enabling us in this behalf, do, by this Warrant, under the hands of two of us, the said Commissioners, by the authority of the Statute in that case made and provided, order and direct as follows; that is to say :--

1. All packets, consisting of patterns or samples, posted in the United Kingdom, may be transmitted by the post within the United Kingdom subject to the several rates of postage, and to the several orders, directions, regulations, and restrictions hereinafter mentioned and contained; that is to say:—

- 2. On every such packet, if not exceeding four ounces in weight, there shall be charged and taken one uniform rate of postage of one penny;
- And on every such packet, if exceeding four ounces and not exceeding eight ounces in weight, there shall be charged and taken one uniform rate of postage of twopence;
- And on every such packet, if exceeding eight ounces and not exceeding twelve ounces in weight, there shall be charged and taken one uniform rate of postage of threepence;

3. No such packet shall exceed twelve ounces in weight, nor (unless under the special authority of the Postmaster-General) shall any such packet exceed two feet in length, or one foot in breadth or depth.

4. There shall be no enclosure, sealed or otherwise closed against inspection, nor any other enclosure not authorized by this Warrant, sent in or with any such packet.

5. There shall be no writing or printing upon any such packet or on the cover thereof, except the address of the person for whom it is intended, the address of the sender thereof, a trade mark, and number and price of the pattern or sample contained therein, nor shall there be any writing or printing in any such packet, except the address of the sender thereof, a trade mark, number, price, and description of the pattern or sample contained therein, which may be either written or printed; but any such permitted writing or printing in any such packet, except such description, shall be on labels attached to the pattern or sample.

6. All such packets shall be sent in covers open at the ends, so as to be easy of examination; nevertheless samples of seeds, drugs, and such other articles and things as cannot be sent in open covers, may be enclosed in boxes, or in bags of linen or other material, which shall be fastened in such a manner that they may be readily opened; but closed bags, if transparent, may be used for the purpose.

7. If any packet sent, or tendered or delivered in order to be sent by the post, under the provisions aforesaid, shall exceed twelve ounces in weight, or shall (save as before excepted) exceed two feet in length or one foot in breadth or depth, or if there shall be any writing or printing upon any such packet, pattern, or sample, or label attached thereto, or on the cover thereof, except as in the fifth clause of this Warrant mentioned; or if any such packet shall not be sent in covers open at the ends, so as to be easy of examination, (except samples of seeds, drugs, and such other articles and things as cannot be sent in open covers, and which may be enclosed in boxes, or in bags of linen or of other material, which shall be fastened in such a manner that they may be readily opened, or for which closed transparent bags may be used,) or in case of boxes or bags (except closed trans-parent bags) being used, if such boxes or bags shall be so closed that they cannot be readily opened, every such packet shall and may be detained and opened, and (at the option of the Postmaster-General) be either returned or given up to the sender thereof, or be given up to the person to whom it shall be addressed, or be forwarded to the place of its destination ; and every such packet on being so returned, given up, or forwarded, shall, at the discretion of the Postmaster-General, be chargeable with any rate or amount of postage he shall think fit, not exceeding a postage of double the amount of postage to which it would have been liable as a letter if the postage had been paid when posted, nor less than the rate of postage which such packet would have been chargeable with if authorized to be transmitted by the post.

8. If any packet sent, or tendered or delivered in order to be sent by the post, under the provisions aforesaid, shall contain any enclosure, sealed or otherwise closed against inspection, or any other enclosure not authorized by this Warrant, every such enclosure may be taken out by any officer of the Post-office, and either returned or given up to the sender thereof, or be forwarded to the address on the packet, charged not only with the full rates of postage as an unpaid letter but also with a further and additional rate of postage of one penny, and the remainder of the packet, if duly prepaid by stamps, may be forwarded to the place of its address without any extra charge.

9. The postage of all such packets as aforesaid shall in every case be paid at the time of the same being posted, not in money, but by being duly stamped with the proper postage stamp or stamps affixed thereto, which stamp or stamps shall in every case be affixed or appear on the outside of every such packet, near the address or direction, and shall be of the value or amount of the postage duly payable thereon under or by virtue of this Warrant.

10. If any packet sent, or tendered or delivered in order to be sent by the post, under the pro-visions aforesaid, shall be posted without having thereon or affixed thereto any postage stamp, every such last-mentioned packet shall be forwarded charged with a postage of double the amount of postage to which it would have been liable under and by virtue of this Warrant if the postage had been paid by stamps when posted. And if any such packet shall be posted having thereon or affixed thereto a stamp or stamps, the value of which shall be less in amount than the rate of postage to which such packet would be liable under and by virtue of this Warrant, but equal in amount to one penny at the least, every such last-mentioned packet shall be forwarded charged with the amount of the difference between the value of such stamp or stamps so being thereon or affixed thereto, and the postage to which such packet would be liable as aforesaid, together with a further and additional rate of one penny.

11. Any packet posted in the United Kingdom containing any razor, scissors, knife, fork, or other sharp or pointed instrument, keys, watch machinery, metal, metal tubing, or ore, or such like, shall and may (notwithstanding anything in a certain Warrant of the Commissioners of Her Majesty's Treasury bearing date the 28th day of November 1844, contained to the contrary) be transmitted by the post within the United Kingdom, subject to the several rates of postage, and to the several orders, directions, regulations, and restrictions hereinbefore mentioned and contained: Provided that every such razor, scissors, knife, fork, or other sharp or pointed instrument, keys, watch machinery, metal, metal tubing or ore, or such like, so contained in any packet, be securely packed and guarded. And every such packet shall not only conform in every respect to the several orders, directions, regulations, and restrictions hereinbefore contained, but the same shall also furnish sufficient protection against injury to the officers of the Post-office, and to the contents of the mail bags : Provided always, that nothing herein contained shall extend to authorize the transmission by the post within the United Kingdom of any packet containing any explosive or other dangerous material or substance.

12. If any packet sent, or tendered or delivered in order to be sent by the post, under the authority of the eleventh clause of this Warrant, shall be posted or transmitted by the post without being securely packed and guarded, and without furnishing sufficient protection against injury to the officers of the Post-office, and to the contents of the mail bags, as in such eleventh clause of this Warrant provided (of which the Postmaster-General shall be the sole judge), every such respective packet shall and may be detained and opened, and (at the option of the Postmaster-General) shall be either returned or given up to the sender thereof, or be given up to the person to whom it shall be addressed; and every such packet, on being so returned or given up, shall be chargeable with any rate or amount of postage the Postmaster-General shall think fit, not exceeding the letter rates of postage.

13. In order to prevent any obstacle to the due and regular transmission of letters by the post, any officer of the Post-office may delay the transmission of any packet posted or forwarded by the post under the provisions of this Warrant for the space of twenty-four hours after the time at which the same ought to be despatched in due course of the post, whenever it may be necessary so to do, or (at his option) until the despatch of the mail next after that by which the same ought in due course of the post to be forwarded by him.

14. In all cases in which any question shall hereafter arise whether any packet, or any pattern or sample contained therein, transmitted under or by virtue of this Warrant, is entitled to the privileges of this Warrant, and to be so transmitted within the intent and meaning thereof, such question shall be referred to the determination of the Postmaster-General, whose decision thereupon shall be final and conclusive upon all parties.

15. All packets transmitted by the post under the provisions aforesaid shall in all respects (save and except as is hereinbefore mentioned and directed) be transmitted in conformity with, and under and subject to the same or the like orders, directions, regulations, and conditions for the time being in force, and applicable to packets consisting of books, publications, or works of literature or art transmitted by the post within the United Kingdom.

16. The several terms and expressions hereinbefore used in this Warrant shall be construed to have the like meaning, in all respects, as they would have had if inserted in the said Act passed in the fourth year of the reign of Her Majesty, chapter 96.

17. So much of the Warrant of the Commissioners of Her Majesty's Treasury bearing date the 3d day of February 1866, as relates to packets consisting of patterns or samples transmitted by the post within the United Kingdom, shall be and the same is hereby repealed.

18. The Commissioners for the time being of Her Majesty's Treasury may, by Warrant under their hands duly made, at any time hereafter alter, repeal, revoke, or modify any of the rates of postage hereby fixed, or any of the regulations hereby made, and may make and establish any new or other rates or regulations in lieu thereof, and from time to time may appoint at what time the rates which may be payable are to be paid.

19. This Warrant shall come into operation on the first day of February one thousand eight hundred and seventy.

# Buoys.-Manukau Harbour.

The Colonial Government of New Zealand has given notice that all the buoys connected with Manukau harbour have recently been repaired and moored in their proper position; the red buoys and beacons being on the starboard side, Hydrographic Office, Admiralty, London, and the black buoys on the port side of the channel, going inwards.

The Tranmere shoal buoy, black, is now moored in 4 fathoms at low water springs, close to the south-east point of the shoal, and Mariners are cautioned to avoid the more southern part of the shoal, by attending to the pointing of the Sema-phore arms at the signal station, or by keeping the South head beacons open about 3 breadths southwards.

The ways oft he South head beacons will in a short time be extended, and the beacons adjusted to the course of the channel, of which due notice will be given. The least water now in the South channel is 3 fathoms at low water springs, deepening quickly to 4 and 5 fathoms.

Mariners are cautioned to place no dependence on the buoys, as they frequently break adrift, and to exercise the greatest care in entering, attending strictly to the steering signals from the pilot station, and keeping the lead constantly going.

None but those thoroughly acquainted with the local signals should attempt to cross the bar of Manukau harbour.

## Buoy off Tipara Reef.

The Colonial Government of South Australia has given notice that a buoy has been placed outside (to the westward) of a rocky patch, with 12 feet water on it at low water springs, situated to the westward of the Tipara Reef, Spencer's Gulf.

The buoy, chequered red and black, is moored in 4 fathoms, and its approximate position is with the Tipara light vessel bearing S.E. by E. 1 E., distant one and two-third miles.

Mariners are cautioned not to approach the reef to a depth less than 7 fathoms, as the ground, to a considerable distance from the reef, is uneven.

Alteration of Buoyage in St George's Channel.

The Trinity House, London, has given notice that, in accordance with the general system of buoyage adopted by that Corporation, the buoys in St George's Channel will, during the months of March and April 1870, be altered in conformity therewith.

The principal features of this system are, that the starboard side of channels entering from seaward will be marked by black or red buoys only, the port side by black or red buoys chequered or striped vertically with white, and middle grounds by black or red buoys with horizontal bands of white.

When beacons are considered necessary to be placed on buoys, the starboard side entering will be distinguished by globes, the port side entering by cages, and middle grounds by diamonds or triangles.

It is to be observed that only one colour, either black or red, will be used in the same channel.
