PRISON OF GREENOCK.

The Right Honorable Henry Austin Bruce, one of Her Majesty's Most Honorable Privy Council and Principal Secretary of State, &c., &c., &c.

WHEREAS in the Town of Greenock, in the County of Renfrew, and adjoining to the Court-house there, a BUILDING has been recently erected for the purposes of a PRISON, in conformity with plans which received the approval of one of Her Majesty's Principal Secretaries of State, the said Building having within the boundary wall thereof the accommodation following; viz.:—*1st.* Thirty Cells for the detention of Male Criminal Prisoners; *2d.* Thirty Cells for the detention of Female Criminal Prisoners; *3d.* A Reception Cell for Male Criminal Prisoners; *4th.* A Reception Cell for Female Criminal Prisoners; *5th.* Two Punishment Cells for Male Criminal Prisoners; *6th.* Two Punishment Cells for Female Criminal Prisoners; *7th.* A Bath-room for Male Prisoners; *8th.* A Bath-room for Female Prisoners; *9th.* A Chapel; *10th.* A Hospital for Male Prisoners; *11th.* A Hospital for Female Prisoners; *12th.* One Room for a Male Officer; *13th.* Two Rooms for Female Officers; *14th.* An Airing-yard for Male Prisoners; *15th.* An Airing-yard for Female Prisoners; *16th.* A Washing-house and Store-room.

In virtue of the powers contained in the Prisons (Scotland) Administration Act, 1860, I do hereby Order and Intimate that, on and after the 21st day of March 1870, the said BUILDING shall, under the designation of The PRISON of GREENOCK, be a LEGAL PLACE OF DETENTION for Criminal Prisoners; Provided that, in the case of such Prisoners undergoing sentences of Imprisonment, the same shall only be a legal place of detention for periods not exceeding sixty days from the date of their respective sentences; and that every Prisoner under a sentence exceeding sixty days from the date thereof, be removed from the said Prison of Greenock to the Prison of Paisley, by or under the direction of the Prison Board of the County of Renfrew: Farther, I hereby Order and Intimate that the Building heretofore used as the Prison of Greenock, and as such referred to in an Order of the late General Board of Directors of Prisons, dated on the 1st day of June in the year 1857, shall, on and after the 24th day of March

1870, CEASE to be a LEGAL PRISON; and before that day all Prisoners confined therein shall, by or under the direction of the said Prison Board, be removed to the Building hereby rendered a Legal Prison.

Board of Trade, Whitehall,

The Board of Trade have received, from the Secretary of State for Foreign Affairs, copy of an announcement of the Committee for the supervision of the construction of the Harbour at St Michael's, stating that, from the 1st of March next, additional dues will be levied on all shipping entering the basin at Ponta Delgada.

The following is a Translation of the announcement, which is dated the 29th January 1870:—

Artificial Harbour of P. Delgada.

In conformity with the 5th Article of the Regulation for this artificial Port, which article is part of the decree of May 26, 1869, this administration will commence to levy from the 1st of next March, from the consignees of vessels entering inside the basin, the following:—From the 1st of April to the 30th September, 10 reis for each cubic metre on vessels of less tonnage than 60 metres, and 30 reis on those exceeding that figure; and from the 1st of October to the 31st of March, 20 reis per cubic metre on the smaller vessels. These dues will apply to a delay in the basin not greater than ten days; and for each day after that the respective dues will increase 5 per cent., no account will be made of any fraction of the day of entry and of that of leaving the basin.

The measurement of the tonnage will be by that shown by the official documents which vessels bring with them.

Those which are in the basin on the aforesaid 1st of March next will be considered as having entered on that day.

For those whose delay in the basin includes days of the two periods to which different dues apply, the dues of the day of entry will apply to the ordinary period (not exceeding ten days), and for the days of excess the dues applicable to them.
