By the Lords of Her Majesty's Most Honorable Privy Council.

PRESENT,

Mr. Göschen. Mr. Forster.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1869 (in this Order referred to as the Act of 1869), and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :-

- 1. Words in this Order have the same meaning as in the Act of 1869.
- 2. Where a Local Authority is authorized by the Privy Council to slaughter cattle that have been in contact with cattle affected with pleuropneumonia, such Local Authority may cause all cattle that have within thirty days been in contact with cattle affected with pleuro-pneumonia within their district to be slaughtered, subject to the following provisions:-
 - (1.) The owner of any animal so slaughtered may either dispose of the carcase on his own account, with a licence from some officer, appointed in that behalf by the Local Authority, or may require the Local Authority to dispose of the same, in which latter case the Lecal Authority shall, by way of compensation for every such animal, pay to the owner thereof such sum, not exceeding thirty pounds, as may equal three-fourths of the value of the animal slaughtered.

(2.) The Local Authority may require the value

- officers, or by arbitration, and generally they may impose conditions as to evidence of the slaughter and value of any such animal.
- 3. The expenditure of a Local Authority in pursuance of this Order in respect of compensation shall be defrayed out of the Local Rate.
- 4. Where the Local Authority in pursuance of this Order cause any cattle to be slaughtered, the owner thereof shall not be entitled to recover in respect of the insurance thereof any sum which, together with the payment which he receives for the same under this Order, would exceed the sum which he would have been entitled to receive in respect of the insurance.
- 5. Every Local Authority shall keep, in such manner and form as the Privy Council from time to time direct or approve, a record, stating the date of any order made by them for slaughter under this Order, and the execution of the order, and other proper particulars; and such record shall be evidence if any question arises concerning an order for the slaughter of any such animal, or concerning compensation in respect thereof.

THE RAILWAY CLEARING SYSTEM SUPERANNUATION FUND ASSOCIATION.

OTICE is hereby given, that application is intended to be made to Parliament in the ensuing Session for an Act for all or some of the following purposes, that is to say:-

To provide by means of a superannuation fund or otherwise for superannuation or other allowances to the salaried officers and clerks of the 'Clearing Committee mentioned in the Railway Clearing Act, 1850,' partly by means of contributions by such officers and clerks, and partly by contributions by the said Committee out of the funds of the Clearing System, established under the said last-mentioned Act, and as part of the expenses thereof.

To make (either by the Act, or by a scheme to be appended by way of schedule thereto) or to authorize to be made, from time to time, under provisions to be contained in the Act, all necessary and proper rules and regulations as to the contributions to be made to such fund, and the benefits to be derived therefrom by contributing members or their representatives, and the management and disposition thereof, and otherwise in relation thereto.

And to authorize the establishment and maintenance of a Committee for the management of the said fund, and the appointment from time to time of a secretary, medical officer, actuaries, and other officers in connection with the management of the fund.

To appoint by the Act trustees of the fund, and to make provisions for filling up the trust, and to confer all proper powers as to investment and otherwise on the trustees.

To authorize the alteration from time to time of such scheme and rules and regulations, whether contained in or appended to the Act, or made under the provisions thereof, and to create all necessary and proper powers and provisions for or

incident to any such alteration.

To make provisions whereby, on proper terms and under proper rules and regulations, to be contained in or made under the authority of the Act, the salaried officers and clerks of any railway companies which are now or may hereafter be admitted parties to the Clearing System, and the salaried officers and clerks of existing or future joint committees for railway purposes, whether established under Acts of Parliament, or otherwise, having separate staffs of salaried officers and clerks, may become contributing members of the fund, and obtain the benefits thereof; and

To authorize the alteration from time to time of such last-mentioned rules and regulations, to create all necessary and proper powers and provisions for or incident to any such alteration, and to authorize contributions to the fund by such railway companies and joint committees respectively.
