(Power to work Tramways by Locomotive Engines or other Mechanical Power: Repeal of certain Provisions of 'The Vale of Clyde Tramways Act, 1871,' and Acts incorporated therewith: Amendment of Acts, etc.)

NOTICE is Hereby Given, That Application is intended to be made to Parliament in the ensuing Session by 'The Vale of Clyde Tramways Company,' hereinafter called 'the Company,' for an Act to effect all or some of the purposes following, viz.:--

To authorize the Company, and all Persons, Corporations, and Companies lawfully using the Tramways authorized by 'The Vale of Clyde Tramways Act, 1871,' or some or one of them (subject to such conditions and restrictions as may be provided in the intended Act), to work such Tramways, or some or one of them, for the purposes of traffic of every description or for the purposes of such traffic as may be limited and prescribed by the intended Act, by means of locomotive engines or other mechanical power.

To repeal so much of 'The Vale of Clyde Tramways Act, 1871,' and the Acts incorporated therewith, as provides that the authorized Tramways of the Company shall be worked by animal power only.

To vary or extinguish all rights and privileges Road is carried over the said portion of the which would interfere with or prevent the execution Caledonian Railway; with all proper walls, of the purposes of the intended Act, and to confer banks, sewers, drains, gas and water pipes, tele-

To amend, extend, and enlarge, or to repeal (so far as may be necessary), for the purposes of the intended Act, 'The Locomotives Act, 1861;' 'The Locomotives Act, 1865;' 'The Greenock Police and Improvement Act, 1865;' 'The Glasgow Police Act, 1866;' The Tramways Act, 1870;' 'The Vale of Clyde Tramways Act, 1871;' and the Acts incorporated therewith; 'The Greenock Street Tramways Act, 1871;' 'The Glasgow, Renfrew, and Three Mile House Turnpike Roads Act, 1872.'

LANARKSHIRE AND GLASGOW ROADS.

(ALTERATION OF AITKENHEAD ROAD.)

(Power to make New Road or Street in lieu of Portion of existing Aitkenhead Road; to discontinue as a Public Thoroughfare a Portion of that Road; vesting of new Road or Street and of discontinued Road; Agreements between Board of Police of Glasgow, Lanarkshire Statute Labour Trustees, and William Smith Dixon and others; Maintenance of Portions of New Road or Street by Board of Police of Glasgow, and Lanarkshire Statute Labour Trustees respectively; Application of their Funds; Agreements between the Parties before mentioned, the Lord Provost, Magistrates and Council of the City of Glasgow, the Glasgow Corporation Water Works Commissioners, and the Caledonian Railway Company; Incorporation and Amendment of Acts.)

NOTICE is Hereby Given, That Application is intended to be made to Parliament in the ensuing Session for leave to bring in a Bill for the purposes following or some of them, that is to say,

To authorize the making of a new Road or Street commencing by a junction with the Statute Labour Road leading from Hangingshaw to Glasgow, commonly called the Aitkenhead Road, otherwise the Hangingshaw Road, at or near a point on that Road, Thirty yards southward of the northern face of the southern abutment of the Bridge by which that road is now carried over that portion of the Caledonian Railway, known as the Polloc and Govan Railway, and terminating by a Junction with the Road leading from Cathcart to Glasgow, commonly called the Cathcart Road, at or near a point on that Road, Thirty yards southward of the northern face of the southern abutment of the Bridge by which that Road is carried over the said portion of the Caledonian Railway; with all proper walls, banks, sewers, drains, gas and water pipes, tele-

therewith; which new Road or Street and works connected therewith, and the lands, houses, and other property, which may be taken for the purposes thereof will be and are situate wholly in the Parish of Govan and County of Lanark, and partly in the City of Glasgow.

To authorize the Board of Police of Glasgow (hereinafter called 'the Board of Police'), and the Trustees for executing an Act passed in the Forty-seventh year of the reign of King George the Third, Session 2, Chapter 45, intituled 'An 'Act for amending an Act of the twelfth year of 'his present Majesty for repairing and widening 'several Roads through the County of Lanark, 'and for building a Bridge over the River Clyde 'at or near a place called the Howford in the said "County, and for making more effectual and con-'verting the Statute Labour within the said 'County, and for repairing and regulating the 'Roads within the same' (hereinafter called the 'Statute Labour Trustees'), and William Smith Dixon of Govanhill, and any other person or persons to be specified in the said Bill, or some or one of them jointly or severally to construct the said new Road or Street and works connected therewith, and to enter upon, take and use temporarily or permanently and either compulsorily or by agreement, all such lands, houses, and other property, as may be necessary or convenient for the purposes of the said new Road or Street, and works connected therewith, and for the other purposes hereinafter mentioned of the Bill; and to deviate in the construction of the said new Road or Street from the lines and levels delineated on the plans and sections to be deposited as hereinafter mentioned to the extent defined on the said Plans, or provided by the Bill; and to cross, divert, alter, stop up, and appropriate, whether temporarily or permanently, any turnpike or other roads, bridges, railways, tramways, water-courses, sewers, gas and water pipes, and telegraphic apparatus in the Parish before mentioned, which it may be necessary or expedient to cross, divert, alter, stop up, or appropriate for the purposes of the said new Road or Street, and works connected therewith, and for the other purposes hereinafter mentioned of the Bill; and to enter into agreements with each other with respect to the con-struction of the said new Road or Street, and other works, and the expense of such construction, and the maintenance of such new Road or Street and works, and with respect to the dedication of such new Road or Street and works to the use of the public; and to confirm any Agreements which may have been or may be entered into by or between the said several parties or any of them with respect to those matters or any of them.

To vest in the Board of Police such portion of the said new Road or Street as shall be situate within the Parliamentary or Municipal limits and boundaries of the City of Glasgow, and to authorize and require them to maintain the same as one of the Public Streets of Glasgow, out of the proceeds of the Statute Labour Assessment which they are or may for the time being be authorized to impose, or out of such other rates or assessments or other funds as may be prescribed by the Bill.

To vest in the Statute Labour Trustees such portion of the said new Road or Street as shall be situate outside of the said Parliamentary or Municipal limits and boundaries, and to authorize and require them to maintain and repair the same by means of the Statute Labour of the Parish of interfere with any of the objects aforesaid, and to

To incorporate with the Bill the Lands Clauses Consolidation (Scotland) Act, 1845, the Lands Clauses Consolidation Acts Amendment Act, 1860, and the Railways Clauses Consolidation (Scotland) Act, 1845, or some parts of such Acts.

To authorize and require the expense of the construction of the said new Road or Street and the works connected therewith to be defrayed wholly or partly by the said William Smith Dixon or such other person or persons as shall be specified in the Bill; and, if thought fit, to authorize and require the Board of Police and the Statute Labour Trustees, or either of these bodies, to pay or contribute to the payment of such expense out of any funds in their hands or which they may have power under any Act or Acts of Parliament to raise for the construction,

maintenance or repair of any roads or streets. And it is intended to take power in the said Bill as soon as the said new Road or Street shall have been completed and dedicated to and opened for public use, or at such other time as shall be prescribed by the Bill, permanently to discontinue as a public road, street, or thoroughfare the portion of the said Aitkenhead Road and the said Bridge carrying the same over the said Polloc and Govan Railway lying between the point of commencement hereinbefore described of the said new Road or Street and the point on the said Road, called the Cathcart Road where the said Aitkenhead Road now joins the said Cathcart Road ; and to take up and entirely remove any sewers, drains, gas and water pipes and telegraphic apparatus laid in, under, or over, and to extinguish all rights of way and other rights, servitudes, and privileges, of what nature and kind soever, over, under, or along such portion of road and bridge to be discontinued as a public thoroughfare as aforesaid; and to vest such portion of road and bridge absolutely in the said William Smith Dixon and any such person or persons as shall be specified in the Bill, which portion of road and bridge to be discontinued and vested as aforesaid are situate wholly in the said Parish of Govan and County of Lanark, and partly in the City of Glasgow.

To authorize the several parties herein before-mentioned, and the Lord Provost, Magistrates, and Council of the City of Glasgow, the Glasgow Corporation Water Works Commissioners, and the Caledonian Railway Company, or any of them, to enter into agreements with each other with respect to the construction of the said new Road or Street, and the discontinuance as a public thoroughfare, and the vesting of the said portion of Road and Bridge as aforesaid, and the removal and relaying of sewers, drains, gas and water pipes, and laying of new sewers, drains, gas and water pipes, or to confirm any agreements entered into between those several parties, or some of them, with respect to those matters, or

any of them. To authorize the levying of rates and duties and to vary and extinguish all existing powers, rights and privileges which might in any manner

confer all powers, rights and privileges, necessary or expedient for effecting those objects or in relation thereto.

To amend and, so far as necessary for any of the purposes aforesaid, to repeal the provisions of the before-mentioned Act of the Forty-seventh year of the reign of King George the Third, Session 2, Chapter 45, and of the several Acts hereinafter mentioned, that is to say, an Act passed in the Ninth and Tenth years of the reign of Her present Majesty, Chapter 289, initialed 'An Act to extend the Municipal Boundaries of the City 'of Glasgow; to amend the Acts relating to the 'Police and Statute Labour of the said City and 'adjoining districts; and for other purposes in 'relation to the Municipality and Police of the 'said City:' 'The Glasgow Police Act, 1866:' An Act passed in the Sixth year of the reign of King George the Fourth, Chapter 108, intituled 'An 'Act for amending and continuing several Acts 'for repairing Roads in the County of Renfrew :' An Act passed in the First year of the reign of King William the Fourth, Chapter 138, intituled 'An Act for amending and continuing an Act for repairing Roads in the County of Renfrew, and 'for altering the line of Road between Glasgow 'and Kilmarnock in the said County :' 'The Ren-'and Kilmarnock in the said County :' 'The Ken-frewshire Turnpike Roads Act, 1856 :' 'The Glasgow Corporation Gas Act, 1869 :' 'The Glas-gow Corporation Water Works Act, 1855 :' 'The Caledonian Railway Act, 1845 :' 'The Caledonian Railway (Additional Powers) Act, 1872,' and any other Acts recited in any of the before metrioned Acts or working to or effecting beforementioned Acts, or relating to or affecting the Board of Police, the Statute Labour Trustees, the Trustees of the Renfrewshire Turnpike Roads, the Lord Provost, Magistrates, and Council of the City of Glasgow, the Glasgow Corporation Water Works Commissioners, and the Caledonian Railway Company, or any of them.

Transfer of Tay Ferries to Dundee Harbour Trustees, or Magistrates and Council of Dundee, or Commissioners; Powers of Purchase and Sale; Management and Maintenance of Ferries; Power to Levy and Alter Rates, and to Borrow Money; Continuation, Amendment, and Repeal of Acts; Agreements; and other Purposes.

NOTICE is Hereby Given, That it is intended to apply to Parliament in the next session for a Bill to confer the powers and effect the objects hereinafter mentioned, or some of them, that is to say—

To transfer to and vest in the Trustees of the Harbour of Dundee (hereinafter called the Trustees), or in the Magistrates and Town Council of the Royal Burgh of Dundee (hereinafter called the Council), or in a separate body of Commissioners to be constituted and incorporated by the Bill (hereinafter called the Commissioners), on such terms and conditions as have been or may be agreed upon, or as may be fixed by or under the provisions of the Bill, the Ferries and Passages across the River Tay, between Newport and Woodhaven in the county of Fife, and Dundee in the County of Forfar, and along the Coast between Ferry-Port-on-Craig and Balmerino on the south, and from Broughty Castle to Invergowrie Burn on the north, and the rights of Ferry and rights of Ferry Harbours or Landing-places, specified and described in the Local Acts relating to the Tay Ferries, 59 Geo. III., cap. 113; 3 Geo. IV., cap. 76; 4 Geo. IV., cap. 88; and 6 and 7 Vict., cap. 84; or some of them, and the whole undertaking, piers, harbours, docks, jetties, works, lands, houses, property, roads, and accesses, plant, matters, and things connected with the Tay Ferries, and all powers, rights, privileges, and jurisdiction conferred by the said Acts on the Trustees constituted or appointed by, or acting under, the said Acts, or any of them (hereinafter called the Tay Ferry Trustees), or on the Committee of Management of the said Tay Ferry Trustees, or on Mortgagees or Assignees of Mortgagees, or other persons in posses-sion of the said Ferries, or on the Caledonian Railway Company, or on any other parties; and which Ferries and Passages, Rights of Ferry and Ferry Harbours or Landing-places, under-taking, piers, harbours, docks, jetties, works, lands, houses, and property, roads, and accesses, and others above mentioned, are hereinafter called and included under the term Tay Ferries; or to provide for the transference to and vesting in the Trustees, Council, or Commissioners of the Tay Ferries on the terms and conditions above mentioned.

To authorize the Trustees, Council, or Commissioners to purchase, acquire, and take, by agreement with the Tay Ferry Trustees and the Committee of Management of the said Trustees, and with the Caledonian Railway Company, Mortgagees or Creditors, or alleged Mortgagees or Creditors, in possession of the Tay Ferries, or otherwise claiming right thereto or interest therein, and with all creditors of the Tay Ferry Trustees, or subscribers to or creditors on the Tay Ferries, and with all other persons interested in the Tay Ferries, or with any of the said several parties, or to purchase, acquire, and take compulsorily, and to enable and compel all or any of the said parties to sell or convey to the Trustees, Council, or Commissioners, for such price or consideration, or on such terms as may be agreed on, or as may be settled by arbitration, or otherwise fixed or provided in or by the said Bill, the Tay Ferries, or any of them, and the powers, rights, privileges, and jurisdiction which are now vested in or held or possessed by the Tay Ferry Trustees, or the Committee of Management of the said Trustees, or the Caledonian Railway Company, or any mortgagees, subscribers, creditors, or other persons interested respectively, or any of them, and all or any mortgages, assignments, bonds, debts, shares, or securities, of, on, or affecting the Tay Ferries, or the funds, rates, duties, and revenues thereof, which are now owing to or held or possessed by the Caledonian Railway Company, or any mortgagees, creditors, or subscribers to or on the Tay Ferries, or creditors of the Tay Ferry Trustees or other persons.

Which piers, harbours, docks, jetties, works, lands, houses, property, roads, and accesses aforesaid are situate at and adjacent to Newport, in the Parish of Forgan, and County of Fife, and at and adjacent to Craig Pier, in the Royal Burgh and Parish of Dundee, and County of Forfar.

To provide for fixing and ascertaining the amount and value of the said Mortgages, Assignments, Bonds, Debts, Shares, and Securities, and to authorize the Trustees, Council, or Commissioners to pay and discharge the said Mortgages, Assignments, Bonds, Debts, Shares, and Securities, or the value thereof, as fixed and ascertained from and out of the funds, rates, duties, and revenues belonging to or levied or received by them under the authority of the Acts relating to the Tay Ferries or the Harbour of Dundee respectively, or of the said Bill, or from and out of the Common Good of the Burgh of Dundee, or from and out of any moneys to be borrowed under the authority of the said Acts or any of them, or the said Bill.

To authorize the Trustees, Council, or Com-missioners to work, maintain, regulate, improve, and manage the Tay Ferries; to provide, hire, and use Steamboats and other Vessels, and all necessary Plant; to appropriate, or to sell and dispose of any part of the Undertaking, Works, Lands and Property vested or to be vested in them as they may from time to time consider necessary or proper; to make Bye-Laws, Rules, and Regulations with respect to the working and management of the Tay Ferries and other matters relating thereto; and to use and exercise all the powers, rights, privileges, and jurisdiction conferred by the said Acts relating to the Tay Ferries, and all other powers, rights, and privileges to be conferred by the said Bill, which may be necessary or expedient for the working, maintenance, regulation, improvement, disposal, and management of the Tay Ferries, and the Undertaking, Works, Lands, and Property connected therewith, or the objects of the said Bill, or any of them.
