land Mains farm steading joins that turnpike road; and which aqueduct, conduit or pipe, will pass from, in, through or into, the following parishes, or some of them, viz.:—the parishes of Manor, Peebles, Eddleston, and Newlands, in the County of Peebles, and the parishes of Penicuik and Lasswade, in the County of Edinburgh.

Fourth, a branch conduit or pipe commencing by a junction with the aqueduct, conduit or pipe, thirdly before described, at a point in the Ugly Grain Burn 66 yards, or thereabouts, measuring along the course of that Burn in a south-westerly direction, from the point where the said Ugly Grain Burn joins the Manor Water, and terminating at or near a point in the Ugly Grain Burn 66 yards, or thereabouts, measuring in a westerly direction, from the north-west corner of the said Manorhead Farm buildings, which branch conduit or pipe will be wholly situated in the Parish of Manor, and County of Peebles.

Fifth, a branch conduit or pipe commencing by a junction with the aqueduct, conduit, or pipe thirdly before described, at or near a point on the public road from old Posso to Manorhead, where the West Burn crosses that road, and terminating in the West Burn at a point 163 yards, or thereabouts, measuring along the course of the West Burn in a south-westerly direction, from its commencement, which branch conduit or pipe will be wholly situated in the Parish of Manor and County of Peebles.

Sixth, a branch conduit or pipe commencing by a junction with the aqueduct, conduit, or pipe thirdly before described, at a point on the west side of the public road, from Posso to Manorhead, 166 yards, or thereabouts, measuring in a northwesterly direction, from the point where the Lingbope Burn joins the Manor Water, and terminating in the bed of the Linghope Burn, at or near be point where the Mid-Grain Burn joins the lighope Burn, which branch conduit or pipe of be wholly situated in the Parish of Manor and County of Peebles.

Swenth, a branch conduit or pipe commencing by a junction with the aqueduct, conduit, or pipe thirdly before described, at a point 66 yards or thereabouts, measuring in a westerly direction, from the point where the road to Langhaugh Farm leaves the public road from Posso to Manorhead, and terminating at or near a point in the Langhaugh Burn, where the Thorter Cleuch Burn joins the said Langhaugh Burn, which branch conduit or pipe will be wholly situated in the Parish of Manor and County of Peebles.

Eighth, a branch conduit or pipe commencing by a junction with the aqueduct, conduit, or pipe thirdly before described, at a point in the Newholm Hope Burn, 190 yards, or thereabouts, measuring in a westerly direction, from the point where the public road from Posso to Manorhead crosses the said Newholm Hope Burn, and terminating at or near a point in the Newholm Hope Burn, where the Kirkhope Burn joins the said Newholm Hope Burn, which branch conduit or pipe will be wholly situated in the Parish of Manor and County of Peebles.

Ninth, a branch conduit or pipe commencing by a junction with the aqueduct, conduit, or pipe thirdly before described, at a point in the Tower Burn, 210 yards, or thereabouts, measuring in a westerly direction, from the south-west corner of the mill-dam on the west side of Posso Farm buildings, and terminating at or near a point in the themselves a point in the said turn the Pow Burn crosses the burgh to Penicuik, and or pipe, will pass through the themselves and Libert County of Edinburgh. Fifteenth, an aqued

joins the said Glenrath Burn, which branch conduit or pipe will be wholly situated in the Parish of Manor and County of Peebles.

Tenth, a branch conduit or pipe commencing by a junction with the aqueduct, conduit, or pipe thirdly before described, at or near the point where the conduit ninthly before described commences, and terminating at or near a point in the Posso Mill Burn where the Berry Burn joins the said Mill Burn, which branch conduit or pipe will be wholly situated in the Parish of Manor and County of Peebles.

Eleventh, a road commencing at a point on the public road leading from Posso to Manorhead, 220 yards, or thereabouts, measuring in a southerly direction along that road from the entrance gate to Posso Farm buildings aforesaid, and terminating at or near the point where the road to Langhaugh Farm leaves said public road, and which road will be wholly situated in the Parish of Manor and County of Peebles.

Twelfth, an aqueduct, conduit, or pipe commencing in the Parish of Lasswade and County of Edinburgh, at a point on the north side of the Peebles Railway, at or near where the acqueduct, conduit or pipe thirdly before described crosses under the said Railway, and 433 yards, or thereabouts, distant from the point where the road to Firth Mains Farm steading crosses the said Railway (measuring along said Railway, in a north-easterly direction) and terminating at Eskbank, in the Parish of Dalkeith and County of Edinburgh, at a point at or near the intersection of the cross roads opposite Annfield Inn, which aqueduct, conduit, or pipe, will pass from, through, or into the parishes of Lasswade, Cockpen, Dalkeith, or some of them, in the County of Edinburgh:

Thirteenth, a reservoir to be situated at the termination of the aqueduct, conduit, or pipe thirdly before described, in the Parish of Lasswade and County of Edinburgh, within the area included within the limits next hereinafter described, that is to say: commencing at or near a point on the west side of the turnpike road from Edinburgh to Penicuik, where the road to Pentland Mains farm joins that turnpike road, thence extending in a westerly direction, in a line parallel with the road to Pentland Mains farm, for a distance of 150 yards, or thereabouts, thence extending in a southerly direction, in a line at right angles to the first-mentioned line, for a distance of 150 yards, or thereabouts, thence extending in an easterly direction, to a point in the said turnpike road, 150 yards, or thereabouts, measuring in a southerly direction, from the junction of the road to Pentland Mains farm with that turnpike road, thence extending in a northerly direction, parallel with the said turnpike road to the point of commencement, which reservoir will be wholly situated in the Parish of Lasswade and County of Edinburgh.

Fourteenth, an aqueduct, conduit or pipe, commencing in the Parish of Lasswade at the northeast corner of the reservoir thirteenthly above described at or near the point where the road to Pentland Mains farm leaves the turnpike road from Edinburgh to Penicuik and terminating at or near a point in the said turnpike road in the Parish of Liberton, at the south end of Mayfield Street, where the Pow Burn crosses the turnpike road from Edinburgh to Penicuik, and which aqueduct, conduit or pipe, will pass through or into the parishes of Lasswade and Liberton, or one of them, in the County of Edinburgh.

Fifteenth, an aqueduct, conduit or pipe, com-
