#### EUROPEAN SOCIETY ARBITRATION.

3. Each policy on which a claim is allowed against the Wellington Society shall be valued as on 8 April 1873 being the day of the date of the Order to wind up that Society.

4. Each policy on which a claim is allowed against the British Nation Association shall be valued as on 18 January 1872 being deemed to be the day of the dates of the Order to wind up that Association.

5. Each policy on which a claim is allowed against the European Society shall be valued as on 12 January 1872 being the day of the date of the Order to wind up that Society.

6. À claim shall not be received against the Wellington Society unless the claimant first pays every premium which fell due and became payable in respect thereof before 8 April 1873.

 A claim shall not be received against the British Nation Association unless the claimant first pays every premium which fell due and became payable in respect thereof before 18 January 1872.
 A claim shall not be received against the European

8. A claim shall not be received against the European Society unless the claimant first pays every premium which fell due and became payable in respect thereof before 12 January 1872.

9.
