EDINBURGH IMPROVEMENT.

Acquisition of West Princes Street Gardens, and Opening of the same for Public Recreation; Acquisition of Lands adjoining the Royal Botanic Gardens for formation of an Arboretum; Power to regulate; Confirmation of Agreements; Power to borrow Money; to apply or levy Rates; other Purposes.

NOTICE is hereby given, that Application is intended to be made to Parliament in the en-suing Session, by the Lord Provost, Magistrates, and Council of the City of Edinburgh (hereinafter called 'the Corporation'), for leave to bring in a Bill for the following, or some of the following, among other objects, powers, and purposes, that is to say :-

To acquire the Gardens in Edinburgh known as the West Princes Street Gardens, and all rights and privileges belonging thereto, the said Gardens lying to the south of Princes Street, and extending southwards therefrom to the road on the north front of the Free Church College, the property known as Ramsay Gardens, the Esplanade of the Castle of Edinburgh, and base of the Rock of the said Castle, and around the said Rock as far as the bridge known as the King's Bridge, and bounded on the east by the western road of the Earthen Mound, and on the west by the road thereby taken to make such bye-laws in regard to leading from Princes Street to St. Cuthbert's Bury- the regulation of the said Gardens as shall be ex-

ing Ground, the said burying ground and the low road to King's Stables, lying in the Parishes of the City of Edinburgh, St. Cuthbert's, Canongate, St. George's, and Tolbooth, and County, and County of the City and Royal Burgh of Edinburgh; excepting the line and property of the North British Railway Company through the said West Princes Street Gardens.

And power will also be taken to the Corporation to purchase and acquire the lands and property following, lying to the west and partly to the north of, and adjoining to, the Royal Botanic Gardens of Edinburgh, bounded on the north by the new. road leading to Fettes College in continuation of Inverleith Place, on the east by the west gable and garden wall of the westmost house on the south side of Inverleith Place, numbered Sixteen of that place, to the north-west angle of the boundary wall of the Royal Botanic Gardens, thence southward, westward, southward, and eastward by the wall enclosing the said Royal Botanic Gardens to a point in said wall opposite the western gable of the westmost house in Inverleith Terrace, numbered Fifteen of that terrace, thence southward in the line of said last-mentioned gable to the boundary wall enclosing the property of Tanfield, thence westward along that boundary wall to the Water of Leith, thence westward and southward along said Water of Leith to the north-west corner of the street called St. Bernard's Row, thence southward and westward to the south-western angle of the avenue leading to Inverleith House adjoining St. Bernard's Cottage, thence northward by the west wall of said avenue, and of the policy grounds of Inverleith House, to the road in continuation of Inverleith Place aforesaid, all lying in the Parish of St. Cuthbert's, and County, and County of the City and Royal Burgh of Edinburgh.

And power will be taken to the Corporation to purchase and acquire compulsorily or by agreement the Gardens, houses, lands, and property before described, or any of them, and all rights and privileges connected therewith, and to deviate to any extent shown on the plans afterwards referred to; and to stop up all roads or accesses, and to alter and divert roads, drains, sewers, and pipes, where the same will interfere with the objects intended.

And power will be taken to enter into agreements with all parties interested in the said West Princes Street Gardens for the acquisition of their rights therein, and any agreement made with such parties may be ratified or confirmed by the Bill.

And power may be taken by the Bill to constitute a Committee to be appointed by the parties interested in the said Gardens, with powers to negotiate and conclude the arrangements and compensation to be taken for the surrender of their rights, or powers will be taken such as in 'The Lands Clauses Consolidation (Scotland) Act, 1845' (which with 'The Lands Clauses Consolidation Acts Amendment Act, 1860,' will, for all purposes of the Bill, with certain amendments and alterations, be incorporated), are contained in regard to common lands, with amendments on such powers. And power will also be taken to throw open to

the public the said West Princes Street Gardens, and to make all necessary and proper improvements and alterations thereon to adapt it as a place of public recreation, and such regulations will be made by the said Bill, or power will be pedient, and all restrictions which will operate to prevent such improvements, and alterations, and public user and enjoyment of the said Gardens will be removed.

And power will also be taken to the Corporation to make any arrangement or agreement with Her Majesty's Secretary for War, or other public officer having the care and custody of the Banks of the Castle of Edinburgh, belonging to Her Majesty, and at present included within the said West Princes Street Gardens, for such limited or conditional right of possession of such portion of the said Gardens as shall be consistent with the public service, which arrangement or agreement may be ratified in the Bill.

And power will be taken to enter into agreements with the Commissioners of Her Majesty's Works and Public Buildings, or Her Majesty's Woods, Forests and Land Revenues, for the transfer and giving over to such bodies of Commissioners, or one or other of them, of the lands and property adjoining the Royal Botanic Gardens before described, so to be acquired, for the purpose of the same being laid out and maintained as an Arboretum for public recreation and for the scientific education of students in connection with the said Botanic Gardens, and for other objects of public utility.

And power will be taken, for the purposes before mentioned, to apply the General Improvement Rate authorised by the Edinburgh Provisional Order, confirmed by 'The Edinburgh Provisional Order Confirmation Act, 1867,' and also the rate or portion of rate authorised by 'The Edinburgh Police Amendment Act, 1854,' to be applied for the formation and maintenance of parks and bleaching greens, or so much of the said rates as may be necessary for the purpose aforesaid, and to such extent to alter and amend such rates; or power will be taken to increase such rates or either of them, or to impose and levy new and additional rates for the purposes aforesaid, or either of them.

And power will be taken to borrow such sums of money as may be necessary for the said objects and purposes aforesaid, or some of them, on the security of the rates before mentioned.

And power will also be taken to alter and amend the following Acts of Parliament, or some of them, viz. :--The Act (Local) 56 Geo. III., cap. 41, in-tituled 'An Act to enable the Lord Provost, Magistrates, and Council of the City of Edinburgh to carry into effect certain purposes in regard to the Erection of a Chapel at the West End of Princes Street, and for effecting certain Improvements in the neighbourhood thereof, and in other parts of the Extended Royalty of the said City;' and also any unrepealed or unexpired enactments of the Acts of Parliament of the former Improvement Commission of the City of Edinburgh—viz., the Acts (Local) 7 and 8 Geo. IV., cap. 76; 1 and 2 Will. IV., cap. 45; and 3 and 4 Will. IV., cap. 106; the Act (Private) 3 Geo. IV., cap. 27; and the existing ' Edinburgh Improvement Act, 1867; the existing 'Edinburgh Improvement Act, 1867;' and the following Acts, viz.:---'The Edinburgh Police Act, 1848;' 'The Edinburgh Police Amend-ment Act, 1854;' aforesaid; 'The Edinburgh Municipality Extension Act, 1856;' and the afore-said 'Edinburgh Provisional Order Confirmation Act, 1867,' with the Provisional Order thereby confirmed, and all other Acts of Parliament which it may be necessary to alter and amend with regard to the objects of the intended application.

And such further and other provision will be

calculated to effect or carry out the objects of the same, and all rights and privileges will be conferred which will seem necessary for these objects, and any rights or privileges which will obstruct or interfere with such objects will be varied or extinguished; and all grants, charters, conveyances, contracts, leases, agreements, minutes, or writings whatsoever which will interfere with such objects, will be cancelled or abrogated.

And Notice is hereby also given, that duplicate Plans of the said Gardens, lands, houses, and property proposed to be taken for the purposes aforesaid, with a Book of Reference to such Plans, containing the names of the Owners or reputed Owners, Lessees or reputed Lessees, and Occupiers of such Gardens, lands, houses, and property, together with a copy of this Notice, as published in the Edinburgh Gazette, will be deposited for public inspection, on or before the 30th day of November instant, in the Office at Edinburgh of the Principal Sheriff-Clerk of the County of Edinburgh, and also with the Sheriff-Clerk of the County of the City of Edinburgh, and with the Town Clerk of the City and Royal Burgh of Edinburgh, at their respective Offices; and so much of the said Plans and Book of Reference as relates to each of the parishes before mentioned in which the Gardens, lands, houses, and property are situate, with a copy of the Gazette Notice, will be deposited on or before the said date with the Schoolmaster and Session-Clerk of each such parish, at their usual places of abode, and with the Registrars of the said parishes respectively, under the Public Act 17 and 18 Vict., cap. 80, at their respective places of abode, or their Offices.

LEVEN HARBOUR.

(Incorporation of Company; Diversion of River Leven; New Cuts, Wet Dock, Deepening River, and other Works; connecting Railway; Compulsory Purchase of Lands; Compulsory Transfer of existing Harbour, and all rights connected therewith; Dredging, &c.; Levying of Tolls, Rates, and Duties, and Alteration of existing Tolls, Rates, and Duties; Arrangements with and Contributions from Leven and East of Fife Railway Company; Amendment of Acts, and other Powers.)

OTICE is hereby given, that Application is intended to be made to Parliament in the made by the Bill as may be found necessary or ensuing Session for leave to bring in a Bill for the

To incorporate a Company (hereinafter called the Company), to authorise the Company to make and maintain the following works, or some of them, all situate in the county of Fife, and to confer upon the Company the powers, or some of the powers, hereinafter described :-

1. A Cut or Diversion of the River Leven (which river in its present bed or channel is the boundary between the parishes of Scoonie and Markinch), to commence in the said parishes, or one of them, by a junction with the said river 160 yards or thereabouts, measured down the present bed or channel thereof, from the bridge carrying the turnpike road from Dysart to Leven over the same, and to terminate in the said parishes, or one of them, by a junction with the said river 190 yards or thereabouts, measured in a south-easterly direction, from the south-west corner of the house in the town of Leven called the Pavilion, which cut or diversion will be situate in, or pass from, in, through, or into the said parishes, or one of them.

2. The Deepening of the said River Leven (forming the parish boundary as before mentioned), from the termination of the cut or diversion last before described to low water mark in the sea, into which the said river flows.

3. A Wet Dock, to be situate in the parishes of Scoonie and Markinch, and between the present stone wharf of the Harbour of Leven and the intended cut or diversion first above described, and to commence at the south-west corner of the wooden jetty to the west of the said stone wharf, and to terminate 23 yards or thereabouts, measured in a westerly direction, from the western gable of Miss Beale's house on the Shorehead of Leven.

4. A River Wall, to commence in the parish of Markinch at a point 70 yards or thereabouts, measured in a south-westerly direction, from the south-west corner of the house before mentioned called the Pavilion, and thence extending 68 yards or thereabouts, in a south-easterly direction, to the east side of the River Leven, and to terminate in the parish of Scoonie at a point 100 yards or thereabouts, measured in a south-easterly direction, from the south-west corner of the said house called the Pavilion, which river wall will pass from, in, through, or into the said parishes of Markinch and Scoonie.

5. A Protection Wall, to be wholly situate in the parish of Scoonie, and to commence at the termination of the intended river wall last described, and to terminate at a point 9 yards or thereabouts, measured in a southerly direction, from the south end of the lane leading from the seashore to Mrs. Younger's house in the town of Leven.

6. A Cut or Diversion of the River Leven, to commence in the parishes of Scoonie and Markinch, or one of them, by a junction with the said river 80 yards or thereabouts, measured down the present bed or channel thereof, from the bridge called the Saw Mill Bridge, in or near to the town of Leven, and to terminate in the said parishes, or one of them, by a junction with the said river at the bridge carrying the turnpike road from Dysart to Leven over the same, which cut or diversion will be situate in, or pass from, in, through, or into the said parishes of Scoonie and Markinch, or one of them.

7. A Cut or Water Course, to commence in the parish of Scoonie at the point where the old Ochre Mill Lade joins the lade from the Durie Foundry, in possession of the estate of Durie, or such parts

purposes after mentioned, or some of them, that is | and to terminate in the parish of Markinch in the intended cut or diversion last described at a point 142 yards or thereabouts, measured in a northerly direction, from the said bridge carrying the turnpike road from Dysart to Leven over the said river, which cut will pass from, in, through, or into the parishes of Scoonie and Markinch.

> 8. A short line of Railway, to commence in the parish of Scoonie by a junction with the Leven and East of Fife Railway at a point thereon 242 yards or thereabouts, measured in a westerly direction along the line of said Railway, from the enginehouse at the Leven Station of said Railway, and to terminate in the said parish at a point in the Harbour of Leven 17 yards or thereabouts, measured in a southerly direction, from the junction of Branch Street with the Shorchead of the town of Leven, which line of Railway will pass from, through, in, or into the said parishes of Scoonie and Markinch.

> All necessary embankments, piers, jetties, wharfs, quays, walls, gates, cuts, weirs, dams, locks, sluices, roads, bridges, accesses, approaches, houses, build-ings, warehouses, sheds, lights, cranes, machinery, moorings, shipping stages, drains, culverts, sidings, works, and conveniences in connection with the existing works of the Harbour of Leven, and with the intended works, or some of them.

> To divert into the intended cuts or diversions, and wet dock, firstly, thirdly, and sixthly before described respectively, the waters of the River Leven, and to stop up the respective existing channels of the said river between the commencement and termination of the said respective intended cuts or diversions, and to appropriate and use the solum and banks of the said existing channels respectively for the purposes of the harbour and works before described, and the other purposes of the Bill, or some of them; as also to divert into the cut seventhly before described the waters of the old Ochre Mill Lade and Durie Foundry Lade.

> To deviate laterally from the lines of the intended works to the extent shown on the plans hereinafter mentioned, and also to deviate vertically from the levels shown on the sections hereinafter mentioned. to such an extent as may be authorised by the Bill.

> To cross, alter, stop up, and divert, either temporarily or permanently, roads, railways, streams, water courses, sewers, drains, pipes, and other works, so far as may be necessary for the purposes of the Bill.

> To purchase and acquire lands and other property compulsorily; to vary or extinguish all rights and privileges in any manner connected with the lands and other property proposed to be taken, and to purchase and acquire lands, houses, rights, and easements by agreement.

> To transfer to and vest in the Company, or to provide for the transfer to and vesting in the Company, or to enable the Company to purchase and acquire compulsorily, or by agreement, for such consideration and on such terms as may be defined in the Bill, or be fixed under the provisions thereof, the Harbour of Leven, and all piers, works, and conveniences connected therewith, and all rights of harbour in the River Leven and in the precincts thereof, and of levying tolls, rates, dues, and other charges as in right of said harbour and works, rights and others foresaid, or such parts and portions thereof as at present belong to Robert Christie, Esq. of Durie, as heir of entail

and portions as the Bill may define, and to confirm any agreements that may be entered into in reference to such transfer and sale, which harbour, piers, works, and others foresaid are situated within the parishes of Scoonie and Markinch, or one of them, and county of Fife.

To dredge, scour, and deepen, from time to time, the bed of the River Leven, and all channels and waters forming a means of access to the Harbour and existing and intended works, or some of them.

To define and extend the limits of the Harbour.

To levy tolls, rates, and duties in respect of the Harbour and existing works, and works to be authorised by the Bill, or some of them, and for the use of wharfs, quays, landing places, warehouses, sheds, cranes, and other works or conveniences; to alter or repeal existing tolls, rates, and duties; and to confer, vary, or extinguish exemptions from the payment of tolls, rates, and duties; and also to vary or extinguish any rights or privileges which would interfere with the objects of the Bill; and to confer all powers, rights, and privileges which may be necessary for carrying the same into effect.

To lease or grant the use or occupation of any warehouses, buildings, wharves, yards, cranes, and other conveniences, at such rents, and upon such terms and conditions, and for such periods, as the Company may think fit.

To enable the Company and the Leven and East of Fife Railway Company from time to time to enter into and carry into effect contracts, agreements, and arrangements for or with respect to the working, management, and maintenance of the intended Railway^{*} eighthly before described.

To authorise the Leven and East of Fife Railway Company to subscribe to the undertaking of the Company out of their corporate funds, and if necessary, out of any money to be raised by them under the powers of the Bill, by shares or stock, with or without priority of dividend over their existing or authorised capital, and by Ioan, and to take and hold shares in the capital of the Company, and to guarantee interest and dividend upon any shares or stock, and principal and interest of any Ioan, and, in the event of subscription, to appoint Directors of the Company.

To make provision for the management, use, regulation, and protection of the Harbour and existing and intended works and conveniences; the regulation and control of shipping, persons, animals, and goods frequenting, or using, or approaching to or departing from the same.

To amend and enlarge, alter or repeal, so far as may be necessary to carry out the objects of the Bill, the powers and provisions of the following Act (local) relating to the Leven and East of Fife Railway Company, that is to say — 14th and 15th Vict., cap. 158, and Acts therein recited.

The Bill will incorporate with itself the Companies Clauses Consolidation (Scotland) Acts, 1845, 1863, and 1869; the Lands Clauses Consolidation (Scotland) Acts, 1845, 1860, and 1869; the Railways Clauses Consolidation (Scotland) Acts, 1845 and 1863; and the Harbours, Docks, and Piers Clauses Act, 1847, or some of these Acts, or some of the provisions of one or more of them.

Plans and duplicate thereof, describing the lines and situation of the intended works, and the lands, houses, and other property which may be taken under the powers of the Bill, and Sections and duplicate thereof, describing the levels of the said intended works, together with a Book of Reference
