- 1. The Bishopric of St. Albans is hereby founded:
- 2. The diocese of the said bishopric shall consist of the Counties of Hertford and Essex, and of so much of the County of Kent as lies north of the River Thames:

- 3. The Abbey Church of St. Albans, in the County of Hertford, subject to the rights of the incumbent of such church, is assigned as a cathedral church to the said bishopric:
- 4. The Bishopric of St. Albans is constituted a body corporate, and the Bishop of St. Albans is hereby invested with all such rights, privileges, and jurisdictions as are now possessed by any other Bishop in England, and is subjected to the metropolitan jurisdiction of the Archbishop of Canterbury:
- 5. This Order shall come into operation on the publication of the same in the London Gazette.
