 - 12. Plane Trigonometry (analytical) and Spherical Trigonometry.
 - Plane Co-ordinate Geometry (more advanced), and Analytical Geometry of three dimensions.
 - Differential and Integral Calculus (more advanced), and the easier Differential Equations.
 - 15. Higher Mechanics and Hydrostatics.
 - 16. Elementary Chemistry and Physics.
