MEMORANDUM.

OPEN Competitive Examination for Clerkships (Class I.) in the Civil Service to be held on the 29th of April 1879, and following days.

At this Examination the number of Candidates selected will be that which is necessary to fill the situations which may have been reported to the Civil Service Commissioners as vacant up to the date at which the result of the Examination is declared.

The under-mentioned vacancies are those which have been notified to the Commissioners up to the present date, viz. :—

\* No Candidate is eligible for this situation who does not possess a competent knowledge of Latin and French (translation into English).

The Civil Service Commissioners are authorized to publish the following information respecting the above appointments :—

COLONIAL OFFICE.

The salary attached to the position of a Junior Clerk in this Department is £250, rising by annual increments of £20 to £600. Two of the Junior Clerks, selected by the Secretary of State, occupy furnished rooms within the building to attend to telegrams and pressing official business out of office hours. Each of these two Clerks receives furnished rooms, besides coals, light, &c., and attendance, and a money allowance of £25 a year.

The two resident Clerkships are at present filled up, but the new Clerks may be required to accept them on the occurrence of vacancies.

INLAND REVENUE.

The Tax Surveying Branch comprises 254 Surveyors and Assistant Surveyors, the whole body of whom are established upon the scale of salaries applicable to the Upper Division of the Civil Service (under the Playfair Scheme), commencing at £100, and rising by £37, 10s. triennially to £400.

In addition to this service scale there is a sum of £5700 allowed for duty pay in the more important districts, which is allotted in sums not exceeding in any case £200 per annum.

Surveyors are stationed not only in London, Edinburgh, and Dublin, but also at various other places in England, Scotland, and Ireland. They are liable to be removed from one station to another according to the requirements of the service.

There are 14 Inspectors at £550 by £20 to £650, and 4 Superintending Inspectors at £700 by £25 to £800, who are appointed by promotion from the Surveyors. All newly appointed Assistant Surveyors have to pass an examination in Book-keeping by Double Entry within a twelvemonth from the commencement of their employment on probation.

(Supplementary to the GENERAL REGULATIONS issued 8th April 1872, and amended by subsequent Notices in the LONDON GAZETTE)\*

RESPECTING

OPEN COMPETITIVE EXAMINATIONS FOR CLERKSHIPS (CLASS I.) in the CIVIL SERVICE.

N.B.—These Regulations are liable to alteration.

1. The limits of age for these situations are 18 and 24, and candidates must be of the prescribed age on the first day of the competitive examination.

2. At the competitive examinations exercises will be set in the following subjects only, the maximum of marks for each subject being fixed as follows, viz. :—

Candidates will be at liberty to offer themselves for examination in any or all of these subjects.

No subjects are obligatory.

No candidate will be allowed any marks in respect of any subject of examination unless he shall be considered to possess a *competent knowledge* of that subject.

3. No candidate can be admitted to the competition who has not previously satisfied the Civil Service Commissioners that he possesses the requisite amount of proficiency in the following subjects:—

1. Handwriting.
2. Orthography.
3. Arithmetic (to Vulgar and Decimal Fractions).
4. English Composition.

With this view, preliminary examinations in these subjects will be held at such times and places as the Commissioners may appoint.

Application for permission to attend one of these preliminary examinations must be made in the writing of the candidate, at such times and in such manner as may be fixed by the Commissioners.

4. A fee of £1 will be required from every candidate attending a preliminary examination, and a further fee of £5 from every candidate who may be admitted to the competition.

#### GENERAL REGULATIONS

(issued 8th April 1872, and amended by Notices in the LONDON GAZETTE of the 24th January 1873, 21st November 1873, 16th June 1874, 5th February 1875, 9th November 1875, and 20th September 1878)

##### RESPECTING

OPEN COMPETITIVE EXAMINATIONS for SITUATIONS in the CIVIL SERVICE, included in Schedule A. of the Order in Council of 4th June 1870.

*N.B.*—These Regulations are liable to alteration at any time.

1. Competitive examinations of candidates for situations in the different public departments will be held at such times and at such places as may be deemed expedient. Before every such examination Special Regulations will be issued, in which the particular conditions of the competition will be specified.

2. At each examination the number of candidates selected will (unless otherwise stated in Special Regulations) be that which is necessary to fill the situations which may have been reported to the Civil Service Commissioners as vacant up to the date at which the result of the examination is declared.

3. These examinations are open, under such general restrictions as may be laid down, to all natural-

born subjects of Her Majesty, being of the requisite age, health, and character. The under-mentioned restrictions are at present in force:

- (i.) Persons actually serving in the Army and Navy are ineligible.
- (ii.) The following classes of persons are eligible under certain conditions only, that is to say:—
  - (a.) Persons holding situations in the Civil Service.
  - (b.) Members of the Royal Irish Constabulary, of less than 12 years' service.
  - (c.) Apprentices and Engineer students in Her Majesty's Dockyards.
  - (d.) Persons who have been trained in Normal Schools at the public expense.

Persons comprised in the classes (a), (b), (c), must have produced to the Civil Service Commissioners, at least one week before the date of the competition, the written permission of the authorities of their department to attend the examination.

Persons comprised in class (d) will not be qualified to receive appointments until the consent of the Committee of Council on Education, Great Britain, or the Commissioners of National Education, Ireland, as the case may be, given in conformity with rules sanctioned by the Lords of the Treasury, has been notified to the Civil Service Commissioners.

4. In reckoning age for competition the following allowances are made, viz., (1) members of the Military and Naval Services (whether commissioned or non-commissioned) may deduct from their actual age any time during which they have served; (2) persons who have served for two full consecutive years (a) in any Civil situation to which they were admitted with the Certificate of the Civil Service Commissioners, (b) in the Royal Irish Constabulary, or (c) as Registered Copyists in connection with the Civil Service, may deduct from their actual age any time not exceeding five years which they may have spent in such service.

5. If at any examination two or more situations, whether in the same or in different Departments, shall be offered for competition, the successful candidates will be permitted (unless otherwise stated in Special Regulations) to choose in their order as determined by the competitive examination among the situations offered for competition; provided that they be duly qualified according to the special rules prescribed, under Clause IV. of Her Majesty's Order in Council of the 4th June 1870, for the particular situations to which they may severally be assigned. If there be a vacant situation for which no one of the selected candidates is duly qualified, the Civil Service Commissioners may offer it to the highest candidate on the list whom they may deem duly qualified, or to the candidate highest at the time on the list of selected candidates, subject to his passing a qualifying examination within such period as they may determine; or they may reserve it to be filled by means of a subsequent open competition, or otherwise, as they may see fit, in accordance with the Order in Council of 4th June 1870.

MITCHELL'S ESTABLISHMENT.

**A** PETITION, under the 'Endowed Institutions (Scotland) Act,' having been presented by the Trustees of the above-named Institution, to the Right Honourable Richard A. Cross, H.M. Secretary of State for the Home Department, he has, in pursuance of sec. 5 of that Act, directed that the said Petition be published in the Edinburgh Gazette, in two consecutive numbers thereof, and also once in the Edinburgh Courant and Scotsman Newspapers. The Petition craves that power should be given to the Trustees—

*Primo.* To increase their numbers to not exceeding seven members—more particularly to include the Minister of the *Quoad Sacra* Parish of Gilmerton as one of the said members *ex officio*, as that Parish forms a part of the original Parish of Liberton, having been constituted since the beginning of the Trust; as also to include one member from each of the Kirk Sessions of Newton and Liberton, to be elected by the said Kirk Sessions respectively.

*Secundo.* To increase the minimum age of the

boys from eight years to ten years, and to extend the maximum age from thirteen to fifteen years.

*Tertio.* To limit the ordinary allowance of boys on the Fund to £4 each half-year, to be applied under the supervision of the Trustees to the 'Aliment, &c.' as appointed by the donor, it being at the same time within the discretion of the Trustees to increase the allowance to any promising boy, more especially during the last year of his term, which would be beyond the present statutory school age in Scotland.

*Quarto.* To enable the Trustees to lessen the allowance of boys not making satisfactory progress, under regulations to be drawn up by the Trustees, or altogether to cut off from the fund, boys whose progress or conduct, or the conduct of whose parents, is unsatisfactory to the Trustees, it being also within the power of the Trustees to refuse to fill up the full number of four boys should they be of opinion that none of the candidates applying on the occasion of any vacancy or vacancies is suitable.

*Quinto.* To enable the Trustees, if they shall see fit, to give no allowance beyond the specified term at Newton Parish School to boys who then betake themselves to mere unskilled labour.

*Sexto.* To enable the Trustees to grant assistance to boys desirous of continuing their studies, either at a Secondary School or University in Scotland, or otherwise as might be approved of by the Trustees, a preference being given to the four boys enjoying the benefits of the Fund.

*Septimo.* To enable the Trustees to foster Secondary Education within the Parish, by granting allowances to the teacher should he succeed in passing any scholars in any of the special subjects included in the syllabus of the 'Scotch Education Code,' or should he satisfy the Trustees of suitable progress having been made by the scholars in any other subject selected by the Trustees.

*Octavo.* To apply any surplus of the Fund, not required for any of the purposes above specified, to any other educational object within the Parish.
