The QUEEN's Most Excellent Majesty in Council.

Whereas by an Act passed in the thirty-eighth and thirty-ninth years of Our reign intituled 'The Militia (Voluntary Enlistment) Act, 1875,' it is amongst other things enacted that save as therein otherwise provided the Militia shall be trained and exercised for not less than twenty-one days and not more than twenty-eight days in every year, at such times and at such places in any part of the United Kingdom as Her Majesty may appoint; and also that Her Majesty may from time to time, with the advice of Her Privy Council, order that the period of training and exercise in any year, of all or any part of the Militia, be reduced to such time as to Her Majesty, with the advice aforesaid, may seem fit.

And whereas it is expedient that the training of the several Regiments of Militia of the United Kingdom should be reduced to the period of twenty days for the year one thousand eight hundred and seventy-nine.

Now therefore, Her Majesty with the advice of Her Privy Council, is pleased to order and direct that the period of training and exercise of the several regiments of Militia of the United Kingdom shall for the year one thousand eight hundred and seventy-nine be reduced, under the provisions of the said recited Act, from twenty-eight days to twenty days.

Her Majesty's Ambassador at Paris has transmitted to the Marquis of Salisbury an extract from the French Journal Officiel, containing a Law which re-establishes the duties in the French Customs Tariff, which, as stated in the notice published in the London Gazette of the 17th of January, had been modified in consequence of the lapse of the Commercial Treaty of December 11, 1866, between France and Austria at the end of last year. The duty on woollen yarns, single, bleached or unbleached, measuring 20,000 metres or less to the kilogramme, which was fixed by the Franco-Austrian Treaty at 10 frs., 15 frs., or 20 frs. per 100 kilogrammes, according to the fineness, is, however, not re-established, but remains at 25 frs. per 100 kilogrammes. The French Minister of Finance is authorized in certain cases to repay to importers of goods affected by these changes of tariff the difference between the duties levied before and subsequent to the 31st of December 1878, namely, on proof that such goods are the produce of a country having a Commercial Treaty with France, and were imported in execution of con-

tracts entered into before the 1st of January 1879.

The French Law above referred to is followed by a Decree of the President of the Republic, containing regulations relative to the exemption from Customs' duty under the 2d Article of that Law, in favour of materials for building, equipping, or repairing merchant ships.

## EUROPEAN SOCIETY ARBITRATION.

Tuesday the 18th day of March 1879.

In the matter of the European Assurance Society Arbitration Acts, 1872, 1873, and 1875.

**W**HEREAS in the Companies named in the Schedule to this Order (in addition to the European Assurance Society), Dividends, particulars whereof are stated in that Schedule, have been declared in this Arbitration.

And whereas as regards some of those Dividends, persons entitled thereto have not presented for payment cheques issued for those Dividends, or otherwise duly applied for payment of those Dividends.

And whereas as regards some of those Dividends by several former Orders in this Arbitration, payment of cheques not so presented has been barred.

And whereas it is expedient to enforce the closing of the Liquidations of those Companies.

The foregoing direction of this Order is without prejudice to the several former Orders in this Arbitration barring payment of cheques for Dividends, and the right of all Creditors or holders of cheques comprised in those former Orders to receive payment thereof or of the Dividends for which they were issued, shall be and is hereby, as from and after Friday the 18th day of April 1879, absolutely barred.

3. Friday the 18th day of April 1879 shall be the day before or on which payment of Dividends allotted and directed to be paid to the Creditors of the several Companies named in the Schedule to this Order for which cheques have not been issued shall be applied for, and the right of all such last-mentioned Creditors to receive payment of such Dividends after that day shall be and is hereby absolutely barred.

## MITCHELL'S ESTABLISHMENT.

**A**PETITION, under the 'Endowed Institutions (Scotland) Act,' having been presented by the Trustees of the above-named Institution, to the Right Honourable Richard A. Cross, H.M. Secretary of State for the Home Department, he has, in pursuance of sec. 5 of that Act, directed that the said Petition be published in the Edinburgh Gazette, in two consecutive numbers thereof, and also once in the Edinburgh Courant and Scotsman Newspapers. The Petition craves that power should be given to the Trustees—

*Primo.* To increase their numbers to not exceeding seven members—more particularly to include the Minister of the *Quoad Sacra* Parish of Gilmerton as one of the said members *ex officio*, as that Parish forms a part of the original Parish of Liberton, having been constituted since the beginning of the Trust; as also to include one member from each of the Kirk Sessions of Newton and Liberton, to be elected by the said Kirk Sessions respectively.

*Secundo.* To increase the minimum age of the boys from eight years to ten years, and to extend the maximum age from thirteen to fifteen years.

*Tertio.* To limit the ordinary allowance of boys on the Fund to £4 each half-year, to be applied under the supervision of the Trustees to the 'Aliment, &c.,' as appointed by the donor, it being at the same time within the discretion of the Trustees to increase the allowance for any promising boy, more especially during the last year of his term, which would be beyond the present statutory school age in Scotland.

*Quarto.* To enable the Trustees to lessen the allowance of boys not making satisfactory progress, under regulations to be drawn up by the Trustees, or altogether to cut off from the fund, boys whose progress or conduct, or the conduct of whose parents, is unsatisfactory to the Trustees, it being also within the power of the Trustees to refuse to fill up the full number of four boys should they be of opinion that none of the candidates applying on the occasion of any vacancy or vacancies is suitable.

*Quinto.* To enable the Trustees, if they shall see fit, to give no allowance beyond the specified term at Newton Parish School to boys who then betake themselves to mere unskilled labour.

*Sexto.* To enable the Trustees to grant assistance to boys desirous of continuing their studies, either at a Secondary School or University in Scotland, or otherwise as might be approved of by the Trustees, a preference being given to the four boys enjoying the benefits of the Fund.

*Septimo.* To enable the Trustees to foster Secondary Education within the Parish, by granting allowances to the teacher should he succeed in passing any scholars in any of the special subjects included in the syllabus of the 'Scotch Education Code,' or should he satisfy the Trustees of suitable progress having been made by the scholars in any other subject selected by the Trustees.

*Octavo.* To apply any surplus of the Fund, not required for any of the purposes above specified, to any other educational object within the Parish.

PUBLIC NOTICE, IN TERMS OF THE  
ENDOWED INSTITUTIONS ACT, 1878,  
SECTION 5.

IN terms of an Order by the Right Honourable Richard Assheton Cross, one of Her Majesty's Principal Secretaries of State, made under the provisions of the Endowed Institutions (Scotland) Act, 1878, 41 and 42 Victoria, c. 48, it is hereby intimated that a petition, dated 14th February 1879, has been presented to the aforesaid Secretary of State by the Reverend Patrick M'Laughlin, Roman Catholic Clergyman at Ayr, and others, Trustees of the deceased Reverend Peter Forbes, Roman Catholic Clergyman, residing in Abercromby Street, Calton of Glasgow, acting under his trust disposition and deed of settlement and codicils, in the following terms:—

That the said deceased Reverend Peter Forbes, by his trust disposition and deed of settlement, executed of this date (21st May 1872), gave, granted, assigned, disposed, conveyed, and made over from him, his heirs and successors, to and in favour of the said Reverend Patrick M'Laughlin, Reverend Donald Carmichael, Reverend John Shaw, Reverend Edward Noonan, Reverend Daniel Gallagher, and the Reverend Peter Francis Forbes, and the acceptors or acceptor, survivors or survivor of them (the majority for the time resident in Scotland being a quorum), and that as Trustees or Trustee for the ends, uses, and purposes therein afterwritten, and to their or his Assignees, All and Whole the whole means, estate, and effects, heritable and moveable, real and personal, of which he was or should die possessed, including all lands and heritable subjects in which he was then or at his death might be vested, or to which he might have right as an individual, although the same might have been otherwise destined by any deed or deeds theretofore executed in his favour, all which destinations he did thereby recall, and declared the said several lands and others to be comprehended in said conveyance; together with the whole writs, titles, vouchers, and instructions of his said estate, heritable and moveable, dispensing with the generality thereof, and declaring said trust disposition and deed of settlement to be equally valid and effectual as if every part and portion of his said estate and effects had been therein described and specially disposed; but said trust disposition and deed of settlement was granted and to be accepted in trust always for the ends, uses, and purposes therein afterwritten; and, *inter alia*, the testator thereby declared that it was his wish and desire (as it had for a long time been his humble ambition), and he appointed his said Trustees, to found or establish a permanent bursary or bursaries, or annual payment or payments, not exceeding the sum of Thirty Pounds sterling each per annum, to be applied and devoted by his said Trustees for or towards the outfit, maintenance, or education of one or more students for the office of the priesthood of the Roman Catholic Church in the Western District of Scotland, or the district or division in which Glasgow might be for the time situated, during or on account of their first year's studies exclusively, and that in such manner, by such means, and in terms of such schemes or regulations, which his said Trustees were thereby authorized from time to time to frame for regulating the constitution and management of the said bursaries or payments, as his said Trustees should deem expedient, and which bur-

sary or bursaries should be denominated by such name or title as his said Trustees should decide; and, lastly, he appointed his said Trustees to hold the residue and remainder (if any) of his said estate, heritable and moveable, in trust, and to apply the same, with the rents, interest, profits, and proceeds thereof, for behoof of the religious, educational, and charitable purposes, all or any of them, of or in connection with the Roman Catholic Congregation of St. Mary's, and of the other Roman Catholic Congregations in the said district or division, under the control of the Roman Catholic Archbishop, or Administrator, or Vicar Apostolic for the time of said district, or of such of said congregations and in such proportions as his said Trustees should from time to time think proper; declaring always that if his said Trustees should find the free realizable proceeds of his said estate inadequate in their judgment to meet and fulfil all or any of the purposes of said trust disposition and deed of settlement, they should have it in their power to accumulate, for such period as they found it needful, the whole or any part of the free annual produce of his said estate until the same would admit of his intentions being properly carried into effect; but such accumulation should not extend beyond the lawful period.

That the Testator also, by said deed of settlement and codicils, bequeathed certain pecuniary and specific legacies, and he conferred very ample powers on his said Trustees, and, amongst others, power generally to wind up, manage, and transact his whole affairs and estate in the way they considered most advantageous or expedient.

That the Testator died on the 24th August 1872; and the Trustees have since been occupied in extricating the estate, which was involved in much difficulty and confusion.

That the free residue of the estate of the said Reverend Peter Forbes now available for said bursaries, and for the religious, educational, and charitable purposes before referred to, consists chiefly of heritable properties situated in Glasgow or the suburbs thereof, which were acquired by the deceased, and are estimated to be worth about £6000. The clear annual income of the estate is nearly £300. This, it may be stated, is very greatly in excess of the amount contemplated by the Testator, and arises from the increase in value of the various properties of the Trust.

That the Petitioners are fully conversant with the views, intentions, and wishes of the deceased in relation to the scheme of bursaries contemplated and founded by him. He had for many years cherished the idea of providing to some extent for the education of students intended for the Roman Catholic priesthood in the Western District of Scotland, where he had for many years laboured as the senior and leading priest of Saint Mary's Roman Catholic Church, Abercromby Street, Glasgow. He had interested himself in procuring such tuition for many young men, and at the time when his deed of settlement was executed by him he had found it an object to secure funds for the promotion of their studies for the first year, as at that time funds to enable them to prosecute their studies during subsequent years were generally provided from other sources.

That during the period of six years which has since elapsed, however, important changes have occurred in connection with the education of such students. On the one hand, it is now generally the case that the first year's expenditure is found for the students; while, in many instances, the funds

for subsequent years are not and cannot be provided. Great difficulty has, therefore, been experienced by the Trustees in carrying deceased's intentions into effect, and in point of fact only one year's bursary for the first year has hitherto been applied for and granted. There is therefore much likelihood that the intentions of the Testator will be defeated, unless the conditions upon which bursaries are to be granted are relaxed.

That another and very important change in regard to the education of students for said Western District has taken place since the date of said deed of settlement. Within the last few years a seminary or college has been established at Partickhill, near Glasgow, especially for the district under the control of the Archbishop of Glasgow, and where it is intended that the students for said district shall in future be almost exclusively trained. No provision has been made otherwise for the expense of the education of students at said seminary, and it is thought that the Testator would naturally have desired to devote his funds to that institution which has been established expressly to carry into effect the object he had in view. Further, it is obvious, from the direction to the Trustees to accumulate the income, if necessary, that the bursaries were the main object of the Testator, and therefore it is conceived that the funds of the Trust should with propriety be chiefly so applied.

That the expense of boarding and educating students has, since the date of deceased's deed of settlement, most materially increased, and a sum of £30 is not now found by any means adequate for a year's maintenance and education of a student. That, looking to the altered circumstances, and keeping in view the improvement in the annual income of the Trust Estate, it is conceived that the limitation of the application of the Trust funds to first year's students might with propriety be modified, and the powers of the Trustees extended and enlarged in accordance with the tendency of modern legislation. The Petitioners calculate that they would be able to provide for the tuition of about six students at the rate of £50 a year as a maximum.

That the Petitioners have, in these circumstances, been advised by counsel learned in the law to present the present Petition under the Endowed Institutions (Scotland) Act, 1878, for the better application of the endowments of the said Trust, and for a Provisional Order to that effect, in terms of said Statute.

That the curriculum of such students for the Roman Catholic priesthood varies from five to ten years according to circumstances, and the scheme which the Petitioners would respectfully suggest for the better application of the endowments of the Trust would be simply as follows:—That power should be given to the Trustees or Governing Body for the time being to increase the annual Grant or Bursary for each student to a sum not exceeding £50 as a maximum, and that said Trustees or Governing Body should also have power to admit to the benefit of the funds or endowments students intended for the office of the priesthood of the Roman Catholic Church in the foresaid district, including students attending the foresaid seminary or college at Partickhill, during any one or more years of the whole period of their studies, according as the same shall, in the discretion of said Trustees or Governing Body, appear expedient or necessary in order to the effectual and liberal fulfilment of the known wishes

and intentions of the Testator and the appropriation of the funds left by him for the purpose.

That the Petitioners, as the Governing Body of said Trust or Institution, have, at a meeting held on the 30th January last and specially called for the purpose in terms of the Statute, resolved by a majority of those present at the meeting that it is expedient that provision should be made for the better application of the endowments of said Trust, and that this application should be made for a Provisional Order. A certificate of posting of the circular convening the meeting, and also the minute of meeting, accompany this Petition.

May it therefore please the Right Honourable the Secretary of State, on considering this Petition and the papers produced therewith, to direct this Petition to be published in the Edinburgh Gazette, and in one or more Newspapers circulating in the County of Lanark, and to remit to the Commissioners acting under the Statute before recited, to inquire into this Petition, and report thereon to the said Secretary of State, as provided for in said Statute; and thereafter, on receiving the report of said Commissioners, to issue a Provisional Order in relation to the several things herein mentioned, either in accordance herewith, or with such alterations and modifications not being inconsistent with the general principles hereof as may appear to him requisite,—all in terms of and as provided for in said Statute, and to do further and otherwise in the matter as may seem to him meet and proper. And your Petitioners shall ever pray, &c.
