PUBLIC NOTICE IN TERMS OF THE ENDOWED INSTITUTIONS (SCOTLAND) ACT, 1878, SECTION 5.

In terms of an Order by the Right Honourable Richard Assheton Cross, one of Her Majesty's Principal Secretaries of State, made under the provisions of The Endowed Institutions (Scotland) Act, 1878, 41 and 42 Victoria, c. 48, it is hereby intimated that a Petition, dated the 14th day of June 1879, has been presented to the aforesaid Secretary of State by the Trustees or Governors of James Schaw's Hospital, viz., George Syme, present Proprietor of the Estate of Northfield, Prestonpans; the Rev. John Struthers, LL.D., present Minister of the Parish of Prestonpans; the Rev. William Casar, D.D., present Minister of the Parish of Tranent; Thomas Jamieson Boyd, present Lord Provost of the City of Edinburgh, and present Treasurer of the Merchant Maiden Hospital, Edinburgh; Thomas Rowatt, present eldest Bailie of the City of Edinburgh; John Smith, present Lord Dean of Guild of the City of Edinburgh; George Harrison, present Treasurer of the City of Edinburgh; David Dickson, present Preses of the Merchant Maiden Hospital, Edinburgh, and present Preses of George Watson's Hospital; John Maclaren, present Treasurer of George Watson's Hospital, John Scott Moncrieff, present Treasurer of the Orphan Hospital; Sir Alexander Grant, Baronet, present Principal of the University of Edinburgh; the Rev. James MacGregor, D.D., and the Rev. James Barclay, M.A., the present Ministers of the Parish of West Church of Edinburgh, being (with the exception of the present Proprietor of the Estate of Prestongrange, who is a Pupil; Archibald Davidson, present Sheriff-Depute of Midlothian and Haddington, who declined to accept the Trust; and the Right Honourable Lord Moncreiff, Lord Justice-Clerk, present Preses of the Orphan Hospital, who being Chairman of the Commissioners under 'The Endowed Institutions (Scotland) Act, 1878,' declines to take any part in the present Petition) the whole Trustees of the late James Schaw, Esq. of Preston, in the County of East Lothian, acting under (1) Trust-Disposition and Settlement by the said James Schaw, dated 4th December 1781, and recorded in the Books of Session (Office O.M.) 20th December 1784; (2) Deed of Divestment and Reconveyance by the Primary Trustees named in the foresaid original Deed of Settlement, in favour of the Residuary Trustees thereby appointed, dated 28th November 1787, and recorded in the Books of Session (Office O.M.) 30th November 1787;

25th January, and written to the Seal and registered and sealed 5th April, all in the year 1830;—and said Petition is in the following terms:—

THAT the Petitioners, incorporated as aforesaid by Royal Charter, under the Name and Title of 'James Schaw's Hospital,' are desirous of availing themselves of the 'Endowed Institutions (Scotland) Act, 1878,' 41 and 42 Victoria, Chapter 48, in order that provision may be made for the better government and administration of the Hospital under their charge.

That it is by the fourth Section of the said Act enacted, that 'It shall be lawful for the governing body of any endowed Institution in Scotland, at a meeting specially called for the purpose at a month's notice, to resolve, by a majority of those present at the meeting, that it is expedient that provision should be made for the better government and administration of such Institution, or for the better application of the endowments thereof, or for the transference of such Institution and the endowments thereof, and that an application should be made to the Secretary of State for a provisional order.'

That it is by the Fifth Section enacted, that 'On the foresaid resolution being carried, it shall be lawful for the said governing body to present a petition to the Secretary of State, setting out such resolution, and stating the provisions for the better government and administration of such Institution, or the better application of the endowments thereof, which they desire to have sanctioned. Upon receipt of any such petition as aforesaid, the Secretary of State may, if he shall think fit, direct such petition to be published in the Edinburgh Gazette, in two consecutive numbers thereof, and in one or more Newspapers circulating in the county or counties where such Institution is situated, with a view to further inquiry.'

That it is by the Sixth Section enacted, that 'The Secretary of State may, if he shall think fit, by writing under his hand, remit to the Commissioners hereinafter mentioned to inquire into the said petition, and report thereon to the said Secretary of State; and for the purposes of such inquiry, which shall be held in public, the said Commissioners shall have power, after such public notice as they may think sufficient, to examine witnesses on oath and to call for such information from, and to require the production of such documents by, the governing body or any other persons as they may consider necessary, and to do all such matters and things as may seem to them expedient for the purposes of the inquiry. After the holding of such inquiry the Commissioners shall report to the Secretary of State as to whether, in their opinion, the provisional order prayed for should be made, and if so, with what, if any, alterations or modifications therein.'

That it is by the Seventh Section enacted, that 'It shall be lawful for the Secretary of State to issue a provisional order in relation to the several things mentioned in the foresaid petition, either in accordance therewith, or with such alterations or modifications, not being inconsistent with the general principles thereof, as may appear to him to be requisite, or otherwise to refuse to issue such provisional order.

'Provided also, that if the provisional order shall contain any alterations or modifications as aforesaid, the Secretary of State shall, before signing the order, cause a copy of it to be sent to the governing body, who may, if they think fit, state in writing to the Secretary of State any objections or suggestions respecting such order within one month after the copy thereof was sent to the governing body; and the Secretary of State shall, if he think fit, remit to the Commissioners to report on such objections and suggestions, and shall consider the same, together with the report of the Commissioners.'

That it is by the Eighth Section enacted, that 'The provisional order aforesaid shall not have any effect or operation unless and until the same has been laid before both Houses of Parliament; and it shall be lawful for the Secretary of State, and he is hereby required, as soon as conveniently may be, to cause such provisional order to be laid before both Houses of Parliament; and after such provisional order has lain forty days before Parliament, then, unless within such forty days a resolution has been adopted by one or other of the said Houses disapproving of the said order, such provisional order shall come into operation.'

That it is by the Tenth Section enacted, that 'It shall be lawful for the governing body of an endowed Institution to apply for a provisional order, and such order may provide for the transference of the Institution, and the endowments of such Institution, or part thereof, to the governing body of one or more other endowed Institutions, or to one or more School Boards, subject to the provisions contained in such order.'

That it is by the Fourteenth Section enacted, that 'Nothing herein contained shall be held to limit any of the powers presently enjoyed by any governing body under any Act of Parliament, or provisional order, or charter, or by the foundation grant of the endowed Institution under their government.'

The Petitioners are of opinion that the interests of 'James Schaw's Hospital' would be greatly promoted by their availing themselves of the provisions of the Endowed Institutions (Scotland) Act, 1878, and that the efficiency of the Hospital would not only be increased, but its usefulness very considerably extended, by their taking advantage of the said Act.

With the view of ascertaining the opinions of the Trustees as to whether any action should be taken by Schaw's Hospital in regard to said Act, a Committee, consisting of the Rev. Dr. Struthers, the Rev. Dr. Cæsar, Mr. David Dickson, Mr. John Scott Moncrieff, and Mr. John Maclaren, was appointed at the Quarterly General Meeting of Trustees on 18th October 1878, to consider the matter and to report.

The Committee presented their report to the Quarterly General Meeting of Trustees on 31st January 1879, when the following Resolution was unanimously agreed to, viz.:—'The Meeting approved of the Committee's Report, and recommitted the whole matter to the same Committee, with the addition of Mr. Harrison, Treasurer of the City, in order that a Scheme might be prepared embodying the changes in the Institution suggested in the Report, with the view of being submitted to a Special Meeting of the Trustees in terms of the Endowed Institutions (Scotland) Act, 1878, for their approval.'

The following explanations relative to the Foundation, Management, and Benefits of the Hospital are humbly submitted:—

The late Dr. James Schaw of Preston, in the county of East Lothian (the founder of the Hospital), died on 3d November 1784, leaving a Trust-Disposition and Settlement dated 4th December 1781, and recorded in the Books of Council and Session 20th December 1784.

By that settlement Dr. Schaw assigned, conveyed, and disponed 'to and in favour of Alexander Alison, Esq., Deputy-Cashier of Excise, James Balmain, Esq., Solicitor of Excise, George Fairholme of Greenhill, Alexander Thomson, Accomptant in Excise, and Robert Boswell, Writer to the Signet, and to such of them as shall accept hereof, and to the survivors and last survivor of those accepting, as trustees or trustee, and to their assignees, declaring any three of said trustees to be a quorum, so long as three or more shall remain in life, in trust, always to the ends, uses, and purposes after mentioned, and with and under the burdens, provisions, and reservations after specified, All and whatsoever lands, tenements, heritages, debts, and sums of money, heritable and moveable, household furniture, bed and table linen, silver plate, lying money, bank-notes, horses, carriages, cattle and stocking of every kind, goods, gear, and other heritable and moveable means and effects, of whatever nature, denomination, or designation the same be, resting and pertaining, or that shall be resting and pertaining to me, at the time of my death; together with all and sundry charters, dispositions, procuratories, and instruments of resignation, precepts and instruments of sasine, adjudications, heritable and moveable bonds, backbonds, reversions, tacks, contracts, assignations, bills, decreets, promissory-notes, accompts, and other writs, rights, evidents, and securities whatsoever, heritable and moveable, made, granted, and conceived, or which may be anywise interpreted in my favour, with all claims of every kind which I have or may have against any person or persons, and all action, diligence, and execution competent, or that may be competent upon the premises, and all that has followed or may follow thereupon: And particularly, I do hereby convey and dispone to and in favour of my said trustees, and the survivor of them, and to their assignees, as said is, the subjects heritable and moveable after specified, viz., All and Whole my lands and barony of Preston and Prestonpans, with the free burgh of barony of Preston, and free sea-port and harbour for ships of the same, with the whole privileges, liberties, casualties, and commodities whatever, pertaining and belonging to the said free burgh of barony, and free port and harbour aforesaid, with the manor-place of Preston, houses, biggings, yards, orchards, mills, multures, kains, customs, casualties and duties, salt pans, coals, coal-heughs, tenants, tenandries, and services of free tenants, and all privileges, liberties, parts, pendicles, and pertinents of the same whatsoever; as also, all and sundry the teind-sheaves of the said lands and barony of Preston and Prestonpans, with tofts, crofts, outsets, parts, pendicles, and whole pertinents thereof: with the privilege and liberty of a market weekly upon Thursday, and of a free fair yearly, beginning on the first day of October, and continuing for the first, second, and third days of that month, being the fair commonly called St. Jerome's Fair, with the whole tolls and customs of the said weekly market and yearly free fair, all united, erected, annexed, and incorporated

by the ancient rights and infeftments thereof, into one free barony called the barony of Preston, of which the manor-place of I'reston is declared to be the principal messuage; and that one sasine to be taken at the said manor-place, or upon any other part of the ground of the said lands, by delivery of earth and stone of the ground of said lands only, without any other symbol, is and shall be sufficient for the said whole lands and barony, all lying within the constabulary of Haddington, and shire of Edinburgh; together with all right, title or interest, claim of right, property and possession petitory or possessory, which I, my predecessors or authors, heirs or successors, had, have, or anywise may have, claim, or pretend to the aforesaid lands and barony, with the pertinents, or to any part or portion of the same: 'And also certain other subjects particularly described in the said Trust-Disposition and Settlement.

The purposes of the Trust were by said Settlement declared to be the following:

'In the first place, for payment and discharge of my funeral expenses, and of all my just and lawful debts and obligations, which shall be resting-owing and undischarged by me at the time of my death. together with the expense of executing the present trust, and denuding themselves thereof.—In the second place, for payment to Jean Schaw, my daughter, presently residing with me at Preston House, the sum of One Thousand Pounds Sterling, and that three days after my death, with interest from the said term of payment until payment thereof; together with sundry other Bequests and Legacies in her favour.—In the third place, for payment and security to the several persons hereinafter named, of the respective sums of money and annuities, which the Truster thereby appointed to be paid to them. 'And, in like manner, for payment and security of the other yearly annuities following, which I hereby appoint to be paid and secured for the use of the Charitable Institutions after-specified, to wit, To the minister and kirksession of the parish of Prestonpans, for the use of the poor of that parish, an yearly annuity of Forty Shillings Sterling: To the minister and kirk-session of the parish of Tranent, for the use of the poor of that parish, the like yearly annuity of Forty Shillings Sterling: To the ministers and kirk-session of the West Church Parish of Edinburgh, within which parish I was born, an yearly annuity of Five Pounds Sterling, for the use of the poor of that parish: To the Governors and Managers of the Charity Workhouse in Edinburgh, for the use of the poor under their care, an yearly annuity of Ten Pounds Sterling: To the Governors of the Merchant Maiden Hospital, for the use of the objects of that institution, an yearly annuity of Five Pounds Sterling: To the Governors of Watson's Hospital, a like yearly annuity of Five Pounds Sterling: and to the Governors of the Orphan's Hospital, a like yearly annuity of Five Pounds Sterling; payable, the said whole annuities last mentioned, at the term of Whitsunday yearly, beginning the first term's payment at the first term of Whitsunday which shall happen after my death, and so to continue yearly thereafter for ever; but declaring always, that the annuities last mentioned granted to the several charities before specified, are granted by me in the faith and confidence that the Directors of these charities, at least such of them hereafter nominated by me among the number of my trustees, for the purpose after specified, shall accept and attend to the ing the same to be as valid, binding, and effectual execution of said trust, and that the non-accept- in every respect, as if made and established by my-

ance or non-attendance of such Directors to the execution of said trust, shall be a sufficient reason for my other trustees accepting and acting, to withhold and refuse payment of said annuities to the charities or charity, from among the Governors of which the said non-accepting or non-officiating trustees are chosen: And lastly, the foresaid lands and barony of Preston, together with the free residue and remainder of my said whole other heritable and moveable estate before disponed, after fulfilment, or securing the fulfilment of the other purposes of this trust, to be re-disponed and conveyed, as my said trustees, and their quorum, or survivor of them aforesaid, are and shall be, by acceptation of these presents, expressly bound and obliged to denude themselves of, and to re-convey and dispone the same to and in favour of themselves during their lives, and to the other persons following, to wit, the Right Honourable John, Earl of Hyndford, present proprietor of the estate of Prestongrange, or any other the proprietor of the said estate of Prestongrange for the time;

Syme, present proprietor of the estate of North-field, in the neighbourhood of Preston, or any other the proprietor of the said estate of Northfield for the time; the minister of the parish of Prestonpans, and the minister of the parish of Tranent, for the time; the Sheriff-Depute of the shire of Edinburgh, and the Sheriff-Depute of the shire of Haddington, for the time; the Lord Provost, the Eldest Bailie, the Dean of Guild, and Treasurer of the city of Edinburgh, for the time; the Preses and Treasurer of the Merchant Maiden Hospital before mentioned, for the time; the Preses and Treasurer of George Watson's Hospital, and the Preses and Treasurer of the Orphan's Hospital, also both before mentioned, for the time; the Principal of the University of Edinburgh, for the time; and the Ministers of the aforesaid parish of West Church of Edinburgh, for the time; and to any other person or persons whom I shall appoint by any writing or note under my hand at any time during my life; declaring any seven of the said persons to be a quorum, the said Alexander Alison, James Balmain, George Fairholme, Alexander Thomson, and Robert Boswell, or at least three of them, while so many are alive, and the last survivors and survivor of them, while able to officiate, being always members of said quorum, and to such of the aforesaid whole persons as shall accept, and to their assignees; and that also, as trustees, and for the special intent and purpose of founding and endowing an hospital or charitable institution for the aliment, clothing, and education of poor boys, and also for binding said boys apprentices, or otherwise setting them out to business, all in the most frugal and sober manner; to be formed the said institution upon such plan, and to be put under such permanent management and regulations, as my said trustees last appointed, or quorum of them aforesaid, shall, after due deliberation and advice, judge best for accomplishing the above purposes. For the establishment and foundation of which institution, and of all regulations and arrangements necessary and proper for communicating and perpetuating the benefit thereof, I do hereby vest my said trustees last mentioned, and their quorum aforesaid, with the most ample and unlimited powers; ratifying hereby and approving of the whole plan, regulations, and arrangements so to be made and established by them, and declarself, and herein particularly engrossed. Provided | only, as it is hereby, and shall be by my said trustees or their quorum, expressly provided and declared, as among the fundamental and unalterable rules to be established and observed with respect to said proposed institution: First, That the objects of said charity shall, as above mentioned, be poor boys, and such only. Secondly, That, in the choice of the children to be admitted to the benefit of said institution, there shall uniformly and perpetually be given a preference to those of the sirname of Schaw and Macneil; and, next after them, to those of the sirname of Cunninghame and Stewart. Thirdly, That the Thirdly, That the children of these sirnames so to be admitted shall be truly in poor and indigent circumstances, so as to stand in need of this charity, and shall, by certificates of unquestionable truth and authority, be attested as proper objects in these respects, before admission. Fourthy, That said children shall not be admitted under the age of four years, nor above the age of seven years, and shall be free of the king's evil, and of all contagious diseases; nor shall any boy be allowed to remain in the hospital after attaining to the age of fourteen years. And, fifthly, That the foresaid lands and barony of Preston, and residue of my other estates, herein before appointed to be applied for the purpose of founding and endowing the aforesaid hospital or charitable institution, shall be considered, and is hereby declared to be the stock or capital of said foundation, never to be diminished or encroached on; nor shall the said lands and barony of Preston ever be sold or alienated, under any pretext whatever, but shall be let out in lease from time to time, by the directors of the aforesaid institution, appointed or to be appointed in manner before specified: the house of Preston itself shall be fitted up, under direction of my said trustees, to receive as many boys as can be conveniently accommodated in it, until the institution shall be put upon a more mature and perfect establishment, when my said trustees may judge it proper to cause erect a suitable building for the purpose, which I recommend to them in that case to cause be done in a neat, plain, frugal manner, studying therein use more than ornament, and keeping always in their eye the meaning of this institution, and the diffusing the benefits thereof as extensively as the funds will admit, to the poor boys who are the objects thereof; and the yearly rents and produce of the said lands and barony of Preston, with the yearly interest and produce of my said other funds, destined for the purposes of founding, supporting, and perpetuating the said institution, shall be applied solely to these purposes, and to no other use or purpose whatsoever. Under which conditions, provisions, and declarations, these presents are granted, and shall be accepted by my said trustees allenarly, as the said Trust-Deed and Settlement, containing sundry other clauses, in itself more fully bears.

The said Dr. James Schaw, by deed of nomination relative to the said Trust-Deed and Settlement, and of even date therewith, and in order to render said Trust-Deed more complete and effectual, nominated and appointed James Balmain, Esq., one of the Commissioners of His Majesty's Board of Excise in Scotland; Alexander Alison, Esq., Deputy-Cashier of Excise; George Fairholme of Greenhill, Esq.; Alexander Thomson, Accountant of Excise, and Robert Boswell, Writer to the Signet, and such of them as should accept, and the survivors and last survivor of those accepting,

heritages, debts, and sums, goods, gear, and other heritable and moveable means and effects of whatever nature, denomination, or designation the same be, either in Great Britain, the West Indies, or elsewhere, which belonged to the said deceased James Schaw at the time of his death, and to which the said original Trustees acquired or might have acquired right, as his trustees or executors, in virtue of the deeds before recited: Excepting only in so far as the state of the subjects conveyed by the said Trust-Deed had been altered or innovated, in consequence of the intromissions and management of said original Trustees under the sanction of the said Deed. All the persons named as Residuary Trustees in the Deed of Divestment and Reconveyance before mentioned, accepted of the trust thereby committed to them, except the late Earl of Hyndford, Mr. James Syme of Northfield, the then Sheriff-Depute of Edinburgh, and the then Sheriff-Depute of Haddington; and a Charter under the Great Seal, of the Estate of Preston, was passed in their favour, dated 20th December 1787, on which they were infeft the 21st, and the sasine thereon recorded in the General Register of Sasines for the shire of Edinburgh, etc., the 22d January 1788.

The Residuary Trustees were incorporated under the name and title of 'James Schaw's Hospital' in the year 1830, conform to Royal Charter of Incorporation in their favour dated 25th January, and written to the Seal and registered and sealed 5th April 1830.

In pursuance of the Truster's object and directions, the Mansion-House of Preston was fitted up as an Hospital in the year 1789, when 20 boys were admitted as Foundationers. The Mansion-House continued to be occupied as an Hospital till the year 1831, when the present Hospital Building was erected.

In the year 1864 the Trustees, with the view of promating the better education and upbringing of the Foundationers, resolved to admit a limited number of Boys as Day-Scholars, under certain regulations, and in 1868 they further agreed to admit a limited number of Boys as Boarders. Both these changes have been fraught with much benefit, and a very marked improvement has been observed in the Foundationers by the introduction of Day-Scholars and Boarders.

The average number of Boys maintained, clothed, and educated in the Institution during the eighty-nine years of its existence has been twenty-two per annum.

Coal having been found upon the Estate, the same was let on lease in the year 1833, at the fixed rent of £200 per annum, and several subsequent Leases have been entered into, but latterly at reduced rents and royalties, owing to the coal seams dimishing in extent as the mineral came to be gradually worked out. Looking to the limited number of Boys which this sum will be able to maintain and educate, the Trustees have lately been giving their anxious consideration to the subject of altering and improving the present administration of the Hospital, in virtue of 'The Endowed Institutions (Scotland) Act, 1878.' A Committee having been appointed, as before stated, the following propositions were submitted by them to the Trustees:-

- 1. That to economise and utilise more than at present the Funds of the Institution, it would be desirable to substitute the system of Boarding out Pupils (under due supervision) for that of receiving inmates into the Hospital-the average annual cost for the last four years being, per Boy, about £36, of which for maintenance and clothing alone above £20; while, by adopting the system of Boarding out each Boy might be satisfactorily maintained and clothed at a rate of a little over from £10 to £15, if the present ages for entry to and removal from the Hospital were to be continued, or at a slightly higher rate in the event of the ages for entry or removal being increased.
- 2. That the funds gained by this change of system might be applied-
  - (a.) In providing maintenance for a larger number of Boys, if thought expedient.
  - (b.) In opening a large Day-School, at very moderate fees, for Children, both Boys and Girls.
  - (c.) In providing Apprentice Fees, Exhibitions, or Gifts in money for Boys of merit and promise.
- 3.
