ENDOWED INSTITUTIONS (SCOTLAND) ACT, 1878.

Unto the Right Honourable Her Majesty's Principal Secretary of State for the Home Department, the Petition of the President and Governors of Robert Gordon's Hospital in ABERDEEN, incorporated by Royal Charter under the Great Seal of Scotland, dated the 15th day of June 1772; and by another Royal Charter under the Great Seal of Scotland, dated the 16th day of May 1792,

Humbly Sheweth,

HAT Robert Gordon, Founder of the Hospital in Aberdeen which bears his name, was born about the year 1665. for a time engaged as a merchant at Dantzic, and afterwards settled in Aberdeen, where he died in

2. By Deed of Mortification and Disposition, dated 13th December 1729, the said Robert Gordon, on the narrative that he had resolved to make a pious mortification of his whole substance and effects towards the building of an Hospital, and for the maintenance, aliment, entertainment, and education of young Boys whose parents are poor and indigent, and not able to maintain them at Schools, and put them to trades and employments, gave, granted, and for the pious uses therein mentioned perpetually, in all time coming, mortified, destinated, and disponed, 'All and Haill the sum of Ten thousand pounds sterling money, or such sum or sums of money as the Patrons and Governors of this my Mortification and Hospital aftermentioned shall receive and recover of my effects after my decease, ' in virtue of the right, disposition, and assignation ' under-written, and that for the uses, ends, and purposes, and conform to and in the terms of the rules, statutes, and conditions of this my Mortification, hereafter particularly inserted and set down; and for making this my Mortification effectual after my decease, wit ye me the said 'Robert Gordon to have sold, assigned, transferred,

heirs, executors, and successors, and all other my assigneys, sell, assign, transfer, and dispone to and in favours of the Provost, Baillies, and the remanent members of the Town Council of the Burgh of Aberdeen, and the four Ministers of the Gospel in the said Burgh of Aberdeen, commonly called the Town's four Ministers of the old and new Churches, who exercise the pastoral charge there, and to their successors in their respective offices, Provost, Baillies, Town Council, and four Ministers of the said Burgh of Abereend, in trust for the uses, dens, and purposes aftermentioned, conform to and in the terms of the rules and statutes under-written, All and Sundry ' my haill goods, gear, debts, sums of money, and others whatsomever, principal sums, annual rents, penalties, and liquidate expenses presently pertaining, resting, and owing to me, or that shall happen to pertain, and be resting and owing to me at the time of my decease, whether by heritable, real, or personal security, &c.'

He further destinated and appointed 'that the said sum of Ten thousand pounds sterling money, or whatever sum or sums of money the said Provost, Baillies, Town Council, and four Ministers, and their successors in office, shall happen to recover and make effectual of my haill effects, heritable and moveable, in virtue of this present right and conveyance (after payment of all my just and lawful debts and funeral expenses), shall be by them stocked, secured, and employed upon land, bonds, obligations, or other sufficient security from time to time, for erecting and maintaining an Hospital, and for the maintenance, aliment, entertainment, and education of young Boys, conform to and in terms of the rules, statutes and conditions of this my Mortification aftermentioned; and to the end this my Mortification may be the more effectually answered and obeyed after my decease, I hereby appoint and ordain the following statutes and rules to be observed and followed in all succeeding ' generations, for erecting and managing my ' Hospital and Mortification for the uses, ends, and purposes aftermentioned.'

3. By the said statutes and rules it was, inter alia, provided as follows:—
'This Hospital shall be called, in all succeeding

generations, Robert Gordon's Hospital.

The Management and administration of the affairs of the said Hospital shall still be in the saids Provost, Baillies, Town Council, and four Ministers of the said Burgh of Aberdeen for the time being, who are to be perpetual Patrons and Governors of the said Hospital. . . . And the saids Governors shall have power to make farther bye-laws and rules for the better administration of the said Hospital and affairs thereof, the same being no wise derogatory to what is declared to be fundamental, nor to the rules and statutes now adjusted (except the same shall be 'altered in manner after prescribed).

There shall be chosen and admitted into the Hospital so many Boys as the stated and certain revenue shall be able to maintain. ordinary election shall be twice in the year, viz. : The third or next lawful days of April and October yearly, when it is to be considered by the Governors what vacancies there are, and how many the stated and certain revenues of the Hospital (making reserve as above) is able to maintain, that so many boys qualified as before expressed, be immediately chosen. They shall 'and disponed, and be thir presents from me, my 'have lodging, bed, diet, washing, and common



fires allowed them, besides their being educated and taught in manner foresaid. They shall be decently apparelled in clothes made after the fashion of the time, or such fashion as the Governors shall think fit, their clothes being all of one colour and fashion. They may continue in the Hospital until they be fourteen, fifteen, or at most, sixteen years of age compleat, and thereafter they shall be put to merchandizing or lawful trades and employments, according as their genius and inclination leads them, and their shall be given the sum of Ten pounds sterling as apprentice fee to a merchant, and Five pounds sterling as apprentice fee to a tradesman, as an apprentice fee to each of them. All to be bound for five years. And if the Patrons or Governors shall think fit at any time to diminish the said apprentice fees, they may do it at discretion.

If any person shall give and mortify to the said Hospital a sum not below the sum of Two thousand pounds sterling money, he shall be assumed and conjoined in all time thereafter with me, the said Robert Gordon, in the name and title of the said Hospital, and be reckoned a founder of the same with me, the said additional donations being always to be employed for entertaining and educating Boys that are indigent, and qualified to be chosen and admitted into the said Hospital in the terms of the foregoing statutes; the Mortifier of the said sum of Two thousand pounds sterling, or such a sum as is sufficient to maintain a boy or boys, being always at liberty to give a preference to the children of

' any name that he pleases.

'In case, after trial and experience, there may be ground for altering and improving of the 'foregoing statutes, the same shall remain with ' and devolve upon the Patrons and Governors of the said Hospital, providing that such alterations be concluded and agreed upon by three-fourths of the whole members, to meet for that effect after the same has been under their deliberation in two several sederunts, the one at the distance of, at least, a month after the other, and be approven by the said Provost of Aberdeen; and the saids alterations no ways infringing upon the ' fundamental articles of the said Hospital, viz. :-That the same is for the relief, maintenance, and for the instruction in the principles of our Holy Christian Protestant Religion, and education in letters, writing, arithmetic, and book-keeping of 'Boys of the names of Gordon and Menzies pre-ferable to others, and that the Hospital shall 'always be called Robert Gordon's Hospital by himself alone, or in conjunction with others who shall mortify to the said Hospital a sum not below ' Two thousand pounds sterling, and that the right of the said Hospital stock and revenue thereof, and administration of the same, shall be vested in, and perpetually remain with, the Patrons and Governors beforementioned, and that no part of ' the stock or profits thereof shall be applied otherwise than for the use and benefit of the said ' Hospital.'

4. By a supplementary Deed of Mortification and Disposition, dated 19th September 1730, the said Robert Gordon ratified, approved, and confirmed, excepting in so far as altered or explained in manner therein mentioned, the prior Deed of Mortification under the declaration:—'That, whereas in the said Deed of Mortification I have mortified and disponed Ten thousand pounds sterling, or such sum or sums as shall be recovered out of my effects after my decease; for preventing any

'dubiety thereanent, I hereby declare that I thereby intended to dispone and mortify all my effects, heritable and moveable, although they should happen to exceed the said sum of Ten thousand pounds sterling, and do accordingly hereby dispone the same for the pious ends and uses therein set forth.... And whereas, by the first statute of the said Deed of Mortification, 'it is declared, That my said Hospital was to be founded for entertaining and educating indigent male children and grandchildren of decayed Merchants and Brethren of Guild of the said Burgh of Aberdeen, of the name of Gordon in the first place, and of the name of Menzies in the second place (the nearest relations of the Mortifier of the ' names of Gordon and Menzies being always pre-' ferred to any others); for preventing any dubiety that may arise anent the order of preference, I ' hereby will and declare that my indigent relations of the name of Gordon claiming to be admitted ' into the said Hospital shall be preferred in the first place; my indigent relations of the name of 'Menzies in the second place; any other indigent boys of the name of Gordon in the third place; 'and any other indigent boys of the name of 'Menzies in the fourth place—they being all 'Burgesses of Guild's children or grandchildren, and of the age and qualities mentioned in the said Deed of Mortification.'

5. The persons named in Robert Gordon's Deed of Mortification having accepted of the trust, proceeded to erect the Hospital Buildings on a site which had been acquired by him. These were partially finished in 1732, but the cost having exceeded expectation, and in consequence of the civil disorders of the country, the Hospital was not opened until 1750. The number of Boys then admitted was 26 and the Trust funds amounted to about £12,000. From that time the number of Foundationers was gradually increased as the funds permitted, till, in 1878, it reached 200, including 40 boys elected and maintained by the Trustees of the late Alexander Simpson of Collyhill, as

aftermentioned.

6. In 1772 the President and Governors on the narrative that at the death of Robert Gordon. they, as Trustees appointed by him, had entered into possession of his Estates, built an Hospital in terms of special directions given by him, and governed the Charity for more than forty years, in the course of which time the funds had greatly increased, and doubts had arisen whether they, as Trustees of a private Endowment, could acquire and raise, and defend actions, applied to His Majesty, King George III., for a Royal Charter incorporating them and their successors in office, under the name and title of the President and Governors of Robert Gordon's Hospital in Aberdeen, with all the powers usually given to bodies Corporate of the like nature, but subject to and under all the conditions and ordinances of the original Deed of Endowment. The prayer of the Petition was granted, and a Charter was issued incorporating the Provost, Baillies, Town Councillors, and four Ministers of the City of Aberdeen, and their successors in these offices respectively, for the time, to be called one Corporation and Body Corporate and Politic, in Deed and in Name, by the name and title of 'The President and Governors of Robert Gordon's Hospital in Aberdeen.'

7. By Trust Disposition, dated 12th April 1816; the late Alexander Simpson of Collyhill directed his Trustees therein named to apply the whole rents and profits of the lands and others therein disponed for

entertaining and educating in Robert Gordon's | less according to the state of the Trust funds from Hospital in Aberdeen, or in any additional buildings to be added thereto, an additional number of indigent male children and male grandchildren of decayed Merchants and Brethren of Guild of the Burgh of Aberdeen, in the first instance, and failing these, male children born in the said Burgh, sons or grandsons of persons who have been residenters in the said Burgh of Aberdeen who are indigent and cannot maintain themselves, to be received into the Hospital according to their neccessity, which shall be judged of by the said four Ministers of the Burgh of Aberdeen, and the said Principal and Professors in the Marischal College, and their successors in the ' said respective offices, and declaring that the said Principal and Professors in the Marischal College shall have an equal vote in all matters concerning the admittance, mode of education, and maintenance of the children received into the Hospital, in as far as regards the present additional funds, as the four Ministers of the Gospel who are at present Managers of the said Hospital; and that the other Managers in said Hospital shall have no right to interfere or meddle with the present additional funds hereby disponed, or with the management or application thereof;' . . . 'and that if the present Hospital is found insufficient to contain or lodge an additional number of children, as above described, the said Disponees shall have power to build such addition as they may judge necessary to the said Hospital, the price of such building being defrayed by the rents and profits from the lands hereby disponed before any children can be admitted into the Hospital from the rents or profits of said lands; that the said Disponees shall have power to elect or choose one or more schoolmasters, for teaching the branches already ' taught in said Hospital, such schoolmaster or 'schoolmasters being always appointed by the test of trial, the aforesaid Disponees being always judges of said performances, and that they appoint to the schoolmasters such salary as they may judge proper; that the rules and regulations laid down in the Deed of Mortification of Robert Gordon, in so far as not contradictory to anything herein contained, shall be the rules and regulations for the management of the said Disponees, but with power to them to make such alterations in the rules laid down by the said Robert Gordon as ' they shall see proper.'

8. By a Deed of Agreement entered into between the President and Governors of Robert Gordon's Hospital and the Trustees of the said Alexander Simpson, dated 12th November 1822, it was provided, inter alia, (1) That the extent, situation, and mode of executing the necessary addition to the Hospital, required for the accommodation of the increased number of boys, should be determined, and a valuation made of the existing buildings and inclosing walls, and of the ground thus occupied and required for other buildings, and that the Trustees should pay for the whole of the additional buildings and necessary furnishings, enlarged playground, &c., or such proportion of the cost thereof as might be found to correspond with the number of boys for whom they required accommodation. (2) That the whole buildings, both original and additional, with the furnishings thereof, should be kept up at the joint expense of the President and

time to time, provided that the number should not, at any time, be reduced without the consent of the President and Governors, unless it appeared that the state of the funds was insufficient for the maintenance of so large a number: provided also that the boys so elected should be such as, in point of age, health, and parentage, might, by the Deed of Mortification of Robert Gordon, and the then subsisting Rules of the Hospital, be competently admitted to the benefit of that charity. (4) That the boys so elected should be clothed, entertained, and educated, by the President and Governors, in all respects on the same footing and in the same manner as the boys elected by themselves, and should be subject to the same discipline, with this provision that the President and Governors should provision, that the President and Governors should only be at liberty to expel them from the Hospital in gross cases of misconduct, and on a report by the four clerical Governors. (5) That the Trustees should pay yearly to the President and Governors a proportion of the whole salaries to Master, Schoolmasters and other Teachers, Treasurer, Housekeeper, Physician, and Clerk, and of the whole expense of maintaining, clothing, and educating the Boys, supplying the house with fuel and light, servants' wages, keeping the furniture and the Hospital buildings in repair, and all other expenses attending the establishment of the Hospital corresponding to the number of boys they had at the time or might be entitled to have in it. (6) That in case, at any time, it might be found necessary to have one or more Schoolmasters besides the two required on the then existing establishment of the Hospital, the Trustees should, on certain conditions, have the nomination and election of such additional Schoolmaster or Schoolmasters and their successors: provided that the President and Governors should be entitled to elect such additional Schoolmasters as might be afterwards required, in addition to the number then employed, for teaching the boys educated in the Hospital under the original foundation of Robert Gordon. (7) That the boys received into the Hospital under Mr. Simpson's endowment should be entitled to the same outfits as the other boys on their leaving the Hospital to be bound to trades, and should, if desired by the Trustees, be bound out to Masters at the expense of the Hospital: provided that the Trustees should become bound for payment of the same apprentice fees as are paid to Masters with other boys from the Hospital; and that, in like manner, the sum of £10 should be paid by them to such of the boys as should be allowed to go abroad after leaving the Hospital.

9. The additions to the said Hospital Buildings were completed at a cost of about £13,255, and the proportion thereof, and of the furnishings, as well as of the value of the original buildings payable by the Trustees, was fixed at about £4147, and paid by them to the President and Governors. The number of boys elected by the Trustees and maintained in the Hospital now number forty, in respect of whom they paid in the last financial year, by quarterly instalments, a sum of £1332, 6s. 8d. as a proportion of the expense of the estab-lishment of the Hospital.

10. In the Session of Parliament (1878), the Act 41 and 42 Vic. cap. 48 was passed, intituled 'An Governors and the Trustees. (3) That the number of boys to be elected by the Trustees for admission into Robert Gordon's Hospital might be more or 'Schools and Hospitals and other Endowed 'Institutions in Scotland, and for other purposes,' the short title of the Act being 'The Endowed | 'Institutions (Scotland) Act, 1878.'

11. By the 4th section of the said Act it is enacted that 'It shall be lawful for the governing body of any Endowed Institution in Scotland, at a meeting specially called for the purpose at a month's notice, to resolve, by a majority of those present at the meeting, that it is expedient that provision should be made for the better government and administration of such institution, or for the better application of the endowments 'thereof, or for the transference of such institution and the endowments thereof, and that an applica-' tion should be made to the Secretary of State for a Provisional Order.'

12. By the 5th section of the said Act it is enacted that 'On the foresaid resolution being carried, it shall be lawful for the said governing body 'to present a Petition to the Secretary of State, ' setting out such resolution, and stating the pro-' visions for the better government and administra-' tion of such institution, or the better application of the endowments thereof, which they desire to 'have sanctioned. Upon receipt of any such Petition as aforesaid, the Secretary of State may, if he shall think fit, direct such Petition to be published in the Edinburgh Gazette, in two consecutive numbers thereof, and in one or more 'newspapers circulating in the county or counties where such institution is situated, with a view to 'further inquiry.'

13. By the 6th section of the said Act it is enacted that 'The Secretary of State may, if he think fit, ' by writing under his hand, remit to the Commis-'sioners, herein aftermentioned, to inquire into 'the said Petition and report thereon to the said Secretary of State; and for the purposes of such inquiry, which shall be held in public, the said Commissioners shall have power, after such public notice as they may think sufficient, to examine witnesses on oath, and to call for such 'information from, and to require the production of such documents by the governing body, or any other persons, as they may consider neces-' sary, and to do all such matters and things as ' may seem to them expedient for the purposes of the inquiry. After the holding of such inquiry the Commissioners shall report to the Secretary of State as to whether, in their opinion, the Pro-'visional Order prayed for should be made, and if so, with what, if any, alterations or modifications ' therein.'

14. By section 7th of the said Act it is enacted 'It shall be lawful for the Secretary of that 'State to issue a Provisional Order in relation to the several things mentioned in the foresaid 'Petition, either in accordance therewith, or with such alterations or modifications, not being inconsistent with the general principles thereof, as may appear to him to be requisite, or other-wise to refuse to issue such Provisional Order: 'Provided always that in every such Provisional Order provision shall be made for saving or making due compensation for the vested interests to which any teacher, master, officer, scholar, bursar, exhibitioner, pensioner, or other shall be entitled at the date of such Order: Provided also that if the Provisional Order shall contain any alterations or modifications, as aforesaid, the Secretary of State shall, before signing the Order, cause a copy of it to be sent to the governing body, who may, if they think fit, state in writing to the Secretary of State any objections or suggestions respecting such Order, within one

'month after the copy thereof was sent to the governing body; and the Secretary of State shall, if he think fit, remit to the Commissioners to report on such objections and suggestions, and shall consider the same, together with the report of the Commissioners.

15. By section 8th of the said Act it is enacted that 'The Provisional Order aforesaid shall not ' have any effect or operation unless and until the 'same has been laid before both Houses of Parlia-'ment; and it shall be lawful for the Secretary of State, and he is hereby required as soon as conveniently may be, to cause such Provisional Order to be laid before both Houses of Parliament; and after such Provisional Order has lain forty days before Parliament, then, unless within ' such forty days a resolution has been adopted by one or other of the said Houses disapproving of the said Order, such Provisional Order shall ' come into operation.'

16. By section 12th of the said Act it is enacted that 'For the purposes of this Act it shall be 'lawful for Her Majesty from time to time, on the 'recommendation of the Secretary of State, to 'appoint Commissioners to hold office during Her 'Majesty's pleasure, but the number of such Com-'missioners shall not at any one time exceed

seven.

17. As soon after the passing of said Act as might be the President and Governors proceeded to consider the same, and whether under its provisions they could obtain such powers as would enable them to increase the usefulness and efficiency and extend the benefits of the Hospital and the revenues under their charge, and after full consideration the Order or Scheme herewith lodged was prepared and approved of by the President and Governors.

18. Under and in terms of the said Act, a meeting of the Governors was called in due form, and was held in the Hall of the said Hospital, on Monday the 11th day of August 1879, when the Governors present at said meeting resolved as

1. 'That in consideration of the changes which have taken place since Robert Gordon's Hospital was instituted, and in respect to the position which primary education now occupies by legislative enactment, it is expedient that advantage be taken of the Endowed Institutions (Scotland) Act, 1878, and that an application be made for a Provisional Order under the same.

2. 'That, with this view, a remit be made to the Education Committee to take into consideration the whole matter, and to formulate a scheme stating the provisions for the better government and administration of the Hospital which it is desirable to have sanctioned, to be laid before a future meeting of the Governors, with a view to said ap-plication being made to the Secretary of That the said Committee be also authorized to communicate with the Collyhill Trustees on the subject.'

19. In accordance with the resolutions come to at the said meeting, this Petition, with the relative proposed Provisional Order or Scheme, is presented.

20. In the said proposed Provisional Order or Scheme there is set forth at length the various powers and provisions which the President and Governors desire to have sanctioned, and which, if granted, would, they believe, enable them still further to increase the usefulness of the Institution placed under their charge, and the endowments thereof.

21. Whilst referring to the Scheme for details of the various powers desired, it may be here stated generally that it is proposed to increase the usefulness and efficiency of the Hospital and its revenues:—

(1.) By converting the Hospital Buildings, wholly or partly, into Day Schools.

- (2.) By reducing the number of Foundationers from 200, as at present, to 120,—one-fourth at least of whom shall be elected by competitive examination.
- (3.) By boarding out any of the Foundationers in family with persons approved by the President and Governors, and under their supervision.
- (4.) By admitting Day Scholars to be educated at the Hospital Schools with the Foundationers, on payment of fees or otherwise.
- (5.) By subjecting all applicants as Foundationers or as Day Scholars, to an entrance examination suitable to the age of each applicant.
- (6.) By instituting a limited number of Bursaries at the Hospital Schools, to be competed for annually by boys belonging to Aberdeen.
- (7.) By giving pecuniary assistance, in the prosecution of their studies at a University or elsewhere, to boys of merit and attainment who have completed their attendance at the Hospital Schools.
- (8.) By establishing Day or Evening Classes for Boys, Girls, and Adult persons, for instruction in Elementary, Secondary, Mechanical, Physical, or other subjects, and providing all necessary apparatus and appliances for said classes.
- (9.) By combining with Educational Institutions of similar character or design to the Hospital or Day Schools, and amalgamating such Institutions, and the funds and property thereof, with the Hospital.
- (10.)
