BILL.

Alteration of Railway during Progress of Bill.

NOTICE is hereby given, that during the progress through the House of Commons of the Bill originating in that House in the present Session of Parliament, under the above written name or short title, the following Alteration has been made in one of the Works proposed to be authorized by that Bill, and therein called Railway No. 3, that is to say, the said proposed Railway, which in the said Bill as originally introduced in the said House was described as follows, viz. :—

'A Railway wholly in the parish of Falkirk (in this Act called "Railway No. 3"), one furlong two chains and eight yards or thereabouts in length, commencing by a junction with Railway No. 1, at a point about three hundred and seventy yards eastward from the farmstead of Longdales, and terminating by a junction with the Railway leading from the North British Railway Company's Stirlingshire Midland Junction Line to Carron Ironworks, at a point about six hundred and five yards southward from the centre of the bridge by which the said Railway to Carron Ironworks is carried over the River Carron;

And that it is intended to alter the said Railway No. 3 in accordance with the last above written description.
