ACT OF ADJOURNAL

RELATIVE TO

ADDITIONAL CIRCUIT COURTS AT CERTAIN TOWNS IN SCOTLAND.

At Edinburgh, the Twelfth day of July Eighteen hundred and eighty-one. Present — The Lord Justice-General, The Lord Moncreiff, Lord Justice-Clerk, Lord Deas, Lord Mure, and Lord Craighill.

HE Lord Justice-General, Lord Justice-Clerk, and Lords Commissioners of Justiciary, considering that by an Order in Council, of date 18th May 1881, and recorded in the Books of Adjournal 6th July current, Her Majesty, by and with the advice of Her Privy Council, and in pursuance of an Act passed in the ninth year of His Majesty King George the Fourth, chapter twenty-nine, did Order that certain additional Circuit Courts should be held at certain towns in Scotland, as particularly therein expressed and before recorded: The said Lords, in obedience to the said Order in Council, and in virtue of the power conferred upon them by the before-mentioned Act of ninth George the Fourth, chapter twenty-nine, by which, upon an Order made by Her Majesty in Council, being communicated to the High Court of Justiciary, the said Court is required and empowered by Act of Adjournal to give all necessary directions for carrying such Order into effect, do hereby Enact, Declare, and Direct, as follows:—

I. Additional Circuit Courts shall be held at the Burgh of Glasgow, for the shires of Lanark, Renfrew, and Bute, at such times in the months of October, February or March, and June or July, in each year, as the Lords may from time to time appoint by Act of Adjournal.

II. Additional Circuit Courts shall be held (1) at the Burgh of Perth for the counties of Perth and Fife, and the whole burghs and districts within the said counties; (2) at the Burgh of Dundee for the county of Forfar, and the whole burghs and districts within the said county; and (3) at the Burgh of Aberdeen for the shires of Aberdeen, Bauff, and Kincardine; at such times, respectively, in the months of January or February, and in the months of June or July, in each year, for each of the said districts of Perth, Dundee, and Aberdeen, as may from time to time be appointed by Act of Adjournal.

III. So far as may be deemed necessary and suitable, all directions, appointments, and authorizations, usually inserted in Acts of Adjournal, fixing the ordinary Circuits, shall be inserted in the Acts of Adjournal fixing the said additional Circuits.

IV. In order that the Lords Lieutenant, Sheriffs, Justices of the Peace, Commissioners of Supply, and Magistrates of Burghs, of the counties to be affected by the aforesaid additional Circuits, may have notice of the same, this Act of Adjournal shall forthwith be published in the Edinburgh Gazette; it shall also be printed, and circulated among all concerned.
