CIVIL SERVICE COMMISSION, July 21, 1892.

The Civil Service Commissioners hereby give notice, that the following Regulations have been approved by the Lords Commissioners of Her Majesty's Treasury, viz.:—

Special Regulations (Supplementary to the General Regulations issued 8th April 1872, and amended by subsequent notices in the London Gazette) respecting Open Competitive Examinations for the situations of Draughtsman in the Department of the Director of Engineering and Architectural Works in the Admiralty, at the Outports, and of Second Assistant to Second Class Surveyors in the Office of Her Majesty's Works, &c.

I. The limits of age for these situations are 24 and 30, and candidates must be of the prescribed age on the first day of the competitive examination.

II. Candidates will be required to show what preliminary training or technical education they have undergone to qualify themselves for a situation of this nature. They must have served in a public or private office under an Architect or

Evidence on this point must be sent in at such times and in such manner as the Civil Service Commissioners may appoint. If it prove primâ facie satisfactory, the candidate will be admitted to examination, subject to such further inquiry as may be necessary.

- IV. Candidates must pass to the satisfaction of the Commissioners in the subjects numbered 1 to 4. Candidates for the Office of Works must also past in the subject numbered 5.
- V. A fee of £1 will be required from each candidate attending the preliminary examination, and a further fee of £2 from each candidate who may be admitted to the competitive part.
- VI. Application for permission to attend an examination must be made at such times and in such manner as the Commissioners may appoint.
