Scheme under the Educational Endowments (Scotland) Act, 1882, for the administration of the Endowment known as the Gaff Trust, in the Burgh of Falkirk and County of Stirling, hitherto held and administered under Trust Deed by Thomas Gaff, Vintner in Falkirk, dated 26th August 1845, and recorded in the Books of Council and Session 21st December 1853, and of the Endowment formerly applicable to the Falkirk Charity School.

Preamble.

1. Future Administration of Endowment.
2. Transference of Property.
3. Constitution and Election of Governing Body.

—The governing body, hereinafter called the governors, shall consist of seven persons, of whom

Three shall be elected by the Town Council and Magistrates of the Burgh of Falkirk.

One shall be elected by the School Board of the Burgh of Falkirk.

One shall be elected by the School Board of the Landward Parish of Falkirk.

One shall be the Minister of the Parish of Falkirk; and

One shall be the Chairman of the Science and Art School of Falkirk.

The Governors elected by the Magistrates and Town Council of the Burgh of Falkirk shall, in the case of the first election, hold office for a period of five years, and thereafter until the first day of August after the expiry of that period. The governors to be elected by the School Boards of

the Burgh of Falkirk and of the Landward Parish of Falkirk shall, in the case of the first election, hold office for a period of three years, and thereafter until the first day of August after the expiry of that period. The governors shall, in the case of all elections subsequent to the first, hold office for a period of five years, from and after the expiry of the term of office of their predecessors, except as hereinafter provided. Each election shall be made at a meeting convened and conducted according to the ordinary rules and practice of the electing body. The governors may be elected by the several electing bodies, either out of their own number or otherwise. Any governor may be re-elected. The first governors shall be elected as soon as conveniently may be after the date of this Scheme. The clerk or other officer of the governors shall, at least one month before the expiry of the term of office of any governor, give notice to the proper electing body, and the electing body shall, as soon as conveniently may be after such notice, elect a governor to hold office from the expiry of said term. Any election not made as aforesaid within three months from the date of this Scheme, or from the date of the notice of expiry of a term of office, or of a vacancy, as hereinafter prescribed, shall in that case be made by the then existing governors.

4-11. Clauses relating to Vacancies, Meetings, Chairman, Quorum, and Execution of Deeds, Minutes, and Committees.

12-17. Clauses relating to Accounts, Audit, Business Arrangements, Casual Profits, Powers of Sale, and Investment.

#### Application of Income.

22. Application of Income. — The governors, after paying the necessary expenses of management and the taxes and burdens affecting the endowment, shall apply the free annual income as hereinafter provided.

23. Free Scholarships. — The governors shall apply a yearly sum of not more than £80 in paying, in whole or in part as they may think fit, the fees of scholars at public or State-aided schools in the burgh or parish of Falkirk for elementary education, as defined in the Educational Endowments (Scotland) Act, 1882. The free scholars shall be children whose parents or guardians, not being in receipt of parochial relief, are in such circumstances as to require aid for providing elementary education, and are persons who, in the opinion of the governors, ought not to be required to apply to the Parochial Board for such aid.

In the case of children under ten years of age the fees shall not be paid for more than one school year without reappointment; and after they have been in attendance at school during one school year, the governors shall, in making their selection, give special weight to good conduct, attendance, and progress at school during the previous year. The amount to be expended in paying school fees for children under ten years of age shall not exceed one-third of the amount to be applied under this section.

In the case of children of ten years of age and upwards, the free scholars shall be selected by competitive examinations, which shall be open to all of the same age who are eligible in terms hereof, whether they have or have not previously been beneficiaries; and for such children the school fees

may continue to be paid for such period not exceeding three years as the governors may determine. If any scholar gain a school bursary, his school fees shall no longer be paid under this section.

The governors, at the end of every school year, shall obtain from the teacher or teachers a special report as to the conduct, regularity of attendance, and progress of all scholars whose school fees are paid in whole or in part under this section, and the fees of no scholar shall continue to be paid in regard to whom such report is not satisfactory.

24. Bursaries for Technical Education. — The governors shall apply an annual sum of not less than £50 in establishing bursaries for technical education, each of the yearly value of not more than £5. These bursaries shall be awarded by competition among the pupils attending the public or State-aided schools in the burgh or parish of Falkirk, under such conditions and regulations as the governors may from time to time determine, and shall be tenable for a period not exceeding two years at the Science and Art School of Falkirk.

25. Annual payment to School Board for purposes of Higher Instruction. — The governors shall pay to the School Board of the burgh of Falkirk an annual sum of £100, on condition—

- (1.) That the said School Board shall either
  - (a) establish and maintain a higher class school in the meaning of the Education (Scotland) Acts, or
  - (b) shall apply the said annual payment for the purposes of higher instruction in one of the existing public schools in Falkirk, by providing a sufficient salary to the head teacher of the said school, who shall, in the case of any appointment after the date of this scheme, be a university graduate, and by supplying such assistance as may enable him to devote his attention chiefly to the upper standards, and to the teaching of specific subjects.
- (2.) That, in the event of the said annual payment being applied to one of the existing public schools in Falkirk, the sum applied out of the school fund for payment of salaries in the said school shall not be less than as at the date of this scheme.
- (3.) That the said School Board give free education in the said school to not more than 12 scholars who have passed the fifth standard, and who shall be selected by the governors under the conditions and regulations of the 24th section hereof from scholars attending the public or State-aided schools in the burgh or parish of Falkirk. The free education thus given shall be continued for a period not exceeding three years, and shall include all specific subjects taught in the school.

The governors shall satisfy themselves from time to time that the said annual payment is applied under the conditions contained herein for the promotion of higher instruction; and, if it appears to them that the said annual payment is not so applied, they shall withdraw the same, provided always that, if the said School Board object thereto, the consent of the Scotch Education Department shall be obtained before the withdrawal of the said annual payment.

26. Application of Annual Payment to School Board in event of Withdrawal. — In the event of the said School Board declining to accept the said annual payment under the conditions of the immediately preceding section, or in the event of its being at

any time withdrawn under the provisions thereof, the governors shall apply the said yearly sum of £100 in establishing bursaries, each of the yearly value of not less than £10, nor more than £15. These bursaries shall be awarded by competitive examination among pupils attending the public or State-aided schools in the burgh or parish of Falkirk, whose age at the date of the competition shall not exceed fourteen years; they shall be tenable for a period not exceeding three years, at such schools for higher education or technical instruction as the governors may approve.

27. School Bursaries.—After providing for the purposes set forth in the preceding sections, the governors shall apply the remainder of the free income of the Endowment in establishing school bursaries, to be called the Gaff School Bursaries, each of the yearly value of not less than £5 nor more than £10. These bursaries shall be awarded by competition among children attending the public or State-aided schools in the burgh and parish of Falkirk who have passed the Fifth Standard of the present Scotch Code, or such standard as may from time to time be fixed by the Scotch Education Department, pursuant to the Education (Scotland) Acts, as that entitling children to total exemption from the obligation to attend school, and whose parents are in such circumstances as to require aid for giving their children a higher education; they shall be tenable for such period, not exceeding three years, as the governors may determine, at public or State-aided schools in which efficient instruction is given in the higher branches.

28. Forfeiture of Bursaries.—If, in the judgment of the governors, the holder of any bursary shall be guilty of serious misconduct, or fail to make reasonable progress at the school, they may withdraw such bursary, and their determination in such case shall be final.

29. Annual Distribution of Scholarships and Bursaries.—The governors shall establish the free scholarships and bursaries herein provided for, in such manner as to secure that they shall be awarded in as nearly as possible equal numbers in each year.

30. Residue of Income.—The residue of the free annual income, in so far as it has not been applied under the provisions of this Scheme, shall be invested by the governors as soon as the same shall amount to £50, and form part of the capital fund of the endowment.

Scheme under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Endowments known as the **Hyndford Mortification**, hitherto held and administered under Deed of Mortification by James, Lord, Carmichael, dated 22nd November, and 30th December 1660; **Thomson's Mortification**, hitherto held and administered under Deed of Mortification by John Thomson, servitor to Sir James Carmichael of Bonnington, dated 30th September 1720; **Battismain's Mortification**, hitherto held and administered under Contract by John Carmichael, Commissary of Lanark, dated 7th December 1648; **Wilson's Mortification**, so far as applicable to Educational purposes, hitherto held and administered under Deed of Mortification by Mrs. Agnes Scoular or Wilson, relict of James Wilson, Merchant in Whitburn, dated 26th July 1817, and recorded in the Sheriff Court Books of Lanarkshire 1819, and Disposition by James Waddel, and other Trustees of the said Mrs. Wilson, dated 30th January and 6th September 1827; and **Tod's Bequest**, so far as applicable to Educational purposes, hitherto held and administered under Trust Disposition and Settlement by William Tod of Logan, dated 22nd November 1866, and recorded in the Books of Council and Session, 11th March 1867.

Each election shall be made at a meeting convened and conducted according to the ordinary rules and practice of the electing body. 23. Discontinuance of Wilson's School.—The governors shall, within twelve months after the date of this Scheme, discontinue the school presently maintained by the Trustees of the said Mrs. Agnes Scoular or Wilson, and shall either sell or let the school buildings at a fair rent, as to them may seem best; but notwithstanding the provisions hereof, they may, on obtaining the authority of the Scotch Education Department, continue the school until such time as may be fixed.

24. Free Scholarships.—On Wilson's School being closed, as provided in the immediately preceding section, the governors shall apply a sum not exceeding £70 yearly in paying, in whole or in part as they may think fit, the fees of scholars at public or State-aided schools in the burgh of Lanark and in the parishes of Lanark, Carmichael, and Pettinain, for elementary education as defined in the Educational Endowments (Scotland) Act, 1882. The free scholars shall be children whose parents or guardians, not being in receipt of parochial relief,

are in such circumstances as to require aid for providing elementary education, and are persons who, in the opinion of the governors, ought not to be required to apply to the Parochial Board for such aid.

In the case of children under ten years of age the fees shall not be paid for more than one school year without reappointment; and after they have been in attendance at school during one school year, the governors shall, in making their selection, give special weight to good conduct, attendance, and progress at school during the previous year. The amount to be expended in paying school fees for children under ten years of age shall not exceed one-third of the amount to be applied under this section.

The governors shall establish the bursaries herein provided for in such manner as to secure that they shall be awarded in as nearly as possible equal numbers in each year.

26. Annual payment to the School Board of the Burgh of Lanark.—The governors shall pay the surplus income of the Endowment to the School Board of the Burgh of Lanark, on condition—

- (1) That the said School Board shall apply the same for the purposes of higher instruction, by providing a sufficient salary to the head teacher of the Grammar School of Lanark, who shall in the case of any appointment after the date of this Scheme be a university graduate, and by supplying such assistance as may enable him to devote his attention chiefly to the upper standards, and to the teaching of specific subjects.
- (2) That the sum applied out of the school fund for payment of salaries in the said

Grammar School shall not be less than as at the date of this Scheme.

- (3) That the said School Board give free education in the said Grammar School to not more than fifteen scholars who have passed the fifth standard, and who shall be selected by the governors by competitive examination under the conditions and regulations of the twenty-fifth section hereof from scholars attending the public or State-aided schools in the parishes of Lanark, Carmichael, and Pettinain. The free education thus given shall be continued for a period not exceeding three years, and shall include all specific subjects taught in the school.

The governors shall satisfy themselves from time to time that the said annual payment is applied under the conditions contained herein for the promotion of higher instruction; and, if it appears to them that the said annual payment is not so applied, they shall withdraw the same, provided always that, if the said School Board object thereto, the consent of the Scotch Education Department shall be obtained before the withdrawal of the said annual payment.

27. Application of Annual Payment to School Board in event of Withdrawal.—In the event of the said School Board declining to accept the said annual payment under the conditions of the immediately preceding section, or in the event of its being at any time withdrawn under the provisions thereof, the governors shall apply the said surplus income in establishing bursaries, each of the yearly value of not less than £10 or of more than £15. These bursaries shall be tenable for a period not exceeding three years at such schools for higher education or technical instruction as the governors may approve, and shall be awarded by competitive examination among the pupils attending the public or State-aided schools in the parishes of Lanark, Carmichael, and Pettinain, whose age at the date of the competition shall not exceed fourteen years.

28. Forfeiture of Bursaries.—If in the judgment of the governors the holder of any bursary shall be guilty of serious misconduct, or shall fail to make reasonable progress at the school, they may withdraw such bursary, and their determination in such case shall be final.

Scheme under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Trust known as Forrest's Trust, in the Burgh of Airdrie and Parishes of New Monkland and Shotts in the County of Lanark, and Slamannan in the County of Stirling, hitherto held and administered under Disposition and Deed of Mortification by William Forrest of Meadowside, dated 6th March 1858, and recorded in the General Register of Sasines at Edinburgh, 29th April 1861.

#### Preamble.

—The governing body, hereinafter called the governors, shall consist of seven persons, of whom

One shall be the Provost of the Burgh of Airdrie.

One shall be the Minister of the *quoad sacra* Parish of Airdrie.

One shall be the Minister of the *quoad sacra* Parish of Clarkston.

One shall be elected by the School Board of the Burgh of Airdrie.

One shall be elected by the School Board of the *quoad sacra* Parish of Clarkston.

One shall be elected alternately by the School Boards of the Parishes of Slamannan and Shotts. The School Board of the Parish of Slamannan shall make the first election.

One shall be appointed by the Sheriff of Lanarkshire, hereinafter called the Sheriff.

The governors elected by the School Boards of Airdrie and Clarkston shall, in the case of the first election, hold office for a period of five years, and thereafter until the first day of August after the expiry of that period. The governor elected by the School Board of Slamannan or the School Board of Shotts, and the governor appointed by the Sheriff, shall in the case of the first election, hold office for a period of three years, and thereafter until the first day of August after the expiry of that period. The governors shall, in the case of all elections or appointments subsequent to the first, hold office for a period of five years from and after the expiry of the term of office of their predecessors, except as hereinafter provided. Each election shall be made at a meeting convened and conducted according to the ordinary rules and practice of the electing body. The governors may be elected by the several electing bodies either out of their own number or otherwise. Any governor may be re-elected or reappointed. The first governors shall be elected or appointed as soon as conveniently may be after the date of this Scheme. The clerk or other officers of the governors shall at least one month before the expiry of the term of office of any governor, give notice to the proper electing body or to the Sheriff

as the case may be, and the electing body or the Sheriff shall, as soon as conveniently may be after such notice, appoint or elect a governor to hold office from the expiry of said term. Any election or appointment not made as aforesaid within three months from the date of this Scheme, or from the date of the notice of expiry of a term of office or from the date of the notice of a vacancy, as hereinafter prescribed, shall in that case be made by the then existing governors.

4-11. Clauses relating to Vacancies, Meetings, Chairman, Quorum and Execution of Deeds, Minutes, and Committees.

12-17. Clauses relating to Accounts, Audit, Business Arrangements, Casual Profits, Powers of Sale and Investment.

#### Application of Income.

22. Application of Income.—The governors, after paying the necessary expenses of management, shall apply the free income of the Endowment to the following objects:—

- a. They shall set aside £150 for the educational purposes hereinafter set forth, and out of this sum they shall pay an annuity of £36 per annum to Mrs. Margaret Wylie or Black, and an annuity of £36 to Mrs. Mary Wylie or Chapman, and an annuity of £18 per annum to Mrs. Connor, as provided in the trust deed of the said William Forrest.
- b. They shall, as provided in the trust deed of the said William Forrest, pay to the minister for the time being of the *quoad sacra* parish of Clarkston the sum of £20 sterling per annum, to assist in maintaining the ordinances of religion and public worship in the said parish.
- c. They shall, as provided in the trust deed of the said William Forrest, apply the sum of £110 per annum for the maintenance of University Bursaries, as hereinafter provided.
- d. They shall, as provided in the trust deed of the said William Forrest, apply the sum of £30 per annum in the purchase of coals for the most necessitous poor persons in the burgh of Airdrie and the *quoad sacra* parish of Clarkston, two-thirds of which shall be distributed in the said burgh, and one-third in the said parish.
- e. They shall apply the surplus of the said revenue, along with the said sum of £150, or so much thereof as may be available, to the educational purposes hereinafter set forth.

23. Free Scholarships.—The governors shall apply the sum of £100 yearly in paying, in whole or in part as they may think fit, the fees of scholars at public or State-aided schools in the burgh of Airdrie and in the parish of Clarkston, for elementary education as defined in the Educational Endowments (Scotland) Act, 1882. The free scholars shall be children whose parents or guardians, not being in receipt of parochial relief, are in such circumstances as to require aid for providing elementary education, and are persons who, in the opinion of the governors, ought not to be required to apply to the Parochial Board for such aid.

In the case of children under ten years of age

the fees shall not be paid for more than one school year without reappointment; and after they have been in attendance at school during one school year, the governors shall, in making their selection, give special weight to good conduct, attendance, and progress, at school during the previous year. The amount to be expended in paying school fees for children under ten years of age shall not exceed one-third of the amount to be applied under this section.

In the case of children of ten years of age and upwards, the free scholars shall be selected by competitive examinations, which shall be open to all of the same age who are eligible in terms hereof, whether they have or have not previously been beneficiaries; and for such children the school fees may continue to be paid for such period not exceeding three years as the governors may determine. If any scholar gain a school bursary his school fees shall no longer be paid under this section.

The governors, at the end of every school year, shall obtain from the teacher or teachers a special report as to the conduct, regularity of attendance, and progress of all scholars whose school fees are paid in whole or in part under this section, and the fees of no scholar shall continue to be paid in regard to whom such report is not satisfactory.

24. School Bursaries.—The governors, after satisfying the provisions of the immediately preceding section, shall apply two-thirds of the remaining funds specified under sub-sections (a) and (e) of the twenty-second section hereof, in establishing school bursaries, to be called the Forrest School Bursaries, each of the yearly value of not less than £5 nor more than £10. These bursaries shall be awarded by competitive examination among children attending the public or State-aided schools in the burgh of Airdrie and parish of Clarkston, who have passed the fifth standard of the Scotch Code, or such standard as may from time to time be fixed by the Scotch Education Department, pursuant to the Education (Scotland) Acts, as that entitling children to total exemption from the obligation to attend school, and whose parents are in such circumstances as to require aid for giving their children a higher education; they shall be tenable for two years at public or State-aided schools in which efficient instruction is given in the higher branches.

25. Bursaries for Higher or Technical Education.—The governors shall apply the remaining third of the said funds in founding bursaries, to be called the Forrest Bursaries, each of the yearly value of not less than £10 nor more than £15. These bursaries shall be awarded by competitive examination among pupils attending the public or State-aided schools in the burgh of Airdrie and parish of Clarkston, whose age at the date of the competition shall not exceed fourteen years; they shall be tenable for such period not exceeding three years as the governors may determine, at such schools for higher education or technical instruction as they may approve. This provision shall not come into operation until the surplus available for the purposes of this and the immediately preceding section amount to £30 annually.

26. University Bursaries.—The governors shall apply the sum of £110 annually in maintaining five university bursaries, to be called the Forrest University Bursaries, each of the annual value of £22, and tenable at the University of Glasgow for such number of years, not exceeding five, as



the governors may determine. The said bursaries shall be awarded by competitive examination among young men who require aid in obtaining a university education, and who have been pupils in the public or State-aided schools within the parishes of New Monkland, Slamannan, and Shotts, or who are natives of said parishes. If in any year properly qualified candidates cannot be found for any of the said university bursaries, the governors may withhold the said bursary, and shall in that case apply the amount thereof to the purposes of the previous section.

27. Forfeiture of Bursaries.—If, in the judgment of the governors, the holder of any bursary shall be guilty of serious misconduct, or fail to make reasonable progress, they may withdraw such bursary, and their determination in such case shall be final.

28. Annual Distribution of Bursaries.—The governors shall establish the bursaries herein provided for in such manner as to secure that they shall be awarded in as nearly as possible equal numbers in each year.

29. Residue of Income.—The residue of the free annual income, in so far as it has not been applied under the provisions of this Scheme, shall be invested by the governors as soon as it shall amount to £50, and form part of the capital fund of the Endowment.
