> CIVIL SERVICE COMMISSION, September 14, 1883.

THE Civil Service Commissioners hereby give notice that the following Regulations have been approved by the Lords Commissioners of Her Majesty's Treasury, viz.:—

Special Regulations (Supplementary to the General Regulations issued 8th April 1872, and amended by subsequent notices in the London Gazette) respecting Open Competitive Examinations for the Situation of Assistant to the Furniture Clerk in the Architect's Branch of the Public Works Office, Ireland.

N.B.—These Regulations are liable to alteration for future examinations.

1. The limits of age for this situation are 20

and 24. Candidates must be of the prescribed age on the first day of the examination.

2. Candidates will be required to show what preliminary training or technical education they have undergone to qualify themselves for a situation of this nature. They must have served in the office of a Manufacturing Cabinetmaker and Upholsterer for at least two years, and must show that they have profited by their training. Evidence on this point must be sent in at such times and in such manner as the Civil Service Commissioners may appoint. If such evidence should prove prima facie satisfactory, the candidate will be admitted to examination, subject, in the case of his being successful in the competition, to such further inquiry and the production of such further evidence as may be necessary.

3. The examination will be in the following subjects, viz.:—

Obligatory:

1. Handwriting.

2. Orthography.

- 2. Arithmetic (to Vulgar and Decimal Fractions).
- 4. English Composition.

Optional:

- A knowledge of Cabinet Making and Upholstery sufficient to enable the candidate to prepare and check Inventories and Furniture Accounts.
- 4. Application for permission to attend an examination must be made at such times and in such manner as the Commissioners may appoint.
- 5. A fee will be required from each candidate attending the examination, according to the scale

laid down under the Order in Council of 22d | March 1879, by notice in the London Gazette of 29th April 1881.

The Civil Service Commissioners further give notice, that an Open Competitive Examination for the situation of Assistant to the Furniture Clerk in the Architect's Branch of the Public Works Office, Ireland, will be held in Dublin, under the above Regulations, on Tuesday the 16th October 1883, and following days.

The number of situations to be filled will be the number vacant at the time of the examination. The number now vacant is one.

No person will be admitted to compete from whom the Secretary of the Civil Service Commission has not received, on or before the 6th October, an application in the handwriting of the candidate, on a prescribed form, which may be obtained from the Secretary at once.


