CULLEN HARBOUR.

(PROVISIONAL ORDER.)

(Vesting of Harbour of Cullen in Harbour Commissioners; Provisions for Constitution and Election of Commissioners; Powers to the Earl of Seafield and the Town Council of Cullen; Confirmation of Agreements between the said Earl and Town Council; Construction and Maintenance of New Works; Extension and Definition of Limits of Harbour; Acquisition of Lands; Power to Alter and to Levy Tolls, Rates, Duties, and Charges; Borrowing Powers; Regulation of Harbour and Pilotage Authority; and for other Purposes.)

NOTICE is hereby given that application is intended to be made, by the promoters of the undertaking hereinafter mentioned, to the Board of Trade, on or before the twenty-third day of December next, for a Provisional Order pursuant to the provisions of the General Pier and Harbour Act, 1861, and the General Pier and Harbour Act (1861) Amendment Act, for all or some of the following powers and purposes (that is to say):—

To provide for the transfer to and vesting of the existing Harbour of Cullen, and all lands, works, and rights and privileges connected therewith, in a Public Board of Harbour Commissioners, and to provide for the constitution of such Commissioners, and to incorporate them and to enable them to carry into execution the purposes of the said Provisional Order.

To confirm any agreement made or to be made between the Earl of Seafield and the Magistrates and Town Council of Cullen, and any other parties, with reference to the transfer and vesting of the

said Harbour, and with reference to the objects and purposes of the said Provisional Order, and to confer on the said Earl and on the said Town Council and other parties all powers necessary for carrying into effect the purposes of the said Order, and to enable the said Earl and the said Council and parties paying harbour rates and charges, or such other parties as shall be fixed by the Order, to nominate Commissioners, and to enable the said Council to apply any of their funds or rates towards the said Harbour and transfer thereof, and to the purposes of the said Order, and to make provision as to debts or obligations affecting the existing Harbour.

To make, maintain, and regulate, in connection with the existing Harbour of Cullen, the following works, or some of them, viz.:—

- 1st. An extension of the existing East Pier or Breakwater, commencing at a point thereon, one hundred lineal yards or thereby from the extreme south-east corner or parapet of said pier, and proceeding from thence in a north-westerly direction for a length of forty lineal yards or thereby, and terminating in the Bay of Cullen, forty-five lineal yards or thereby north from the eastmost corner of the sea entrance of the Outer Harbour of Cullen;
- 2d. A northern extension of the existing West Pier, commencing at the north-east end of the said pier, and proceeding in a northerly direction for a length of twenty-six lineal yards or thereby, and terminating on the existing bight of present East Pier, twelve lineal yards or thereby east of the north-east side of the sea entrance of the Outer Harbour.
- 3d. A southerly extension of the aforesaid West Pier, commencing at a point thereon, forty lineal yards or thereby from the south-west face of the aforesaid sea entrance to the Outer Harbour, and proceeding from thence in a south-westerly direction for a length of one hundred and thirty-five lineal yards or thereby, and terminating on the foreshore or beach of the Bay of Cullen, seventy-eight lineal yards or thereby from the east end of Lord Seafield's coal store, near the Harbour;
- 4th. A jetty or pier, commencing on the south-east side of the Outer Harbour, at a point thereon, twenty-five lineal yards or thereby north-westwards from the north-west corner of the building called Clyne's Curing Station, and as occupied by George Clyne, and proceeding in a westerly direction for a length of sixty-six lineal yards or thereby, and terminating in the said Outer Harbour, at a point thereon, fourteen lineal yards or thereby eastward of the inner or south face of the sea entrance to the said Outer Harbour;
- 5th. A quay, starting from the commencement of the jetty fourthly above-described, and proceeding in a southerly direction for a length of thirty-seven lineal yards or thereby, and from thence in a south-west direction for a length of thirty-six lineal yards or thereby, and from this point for a farther length in a westerly direction for forty-two lineal yards or thereby, and terminating on the beach forming the shore end of the Inner Harbour, fourteen lineal yards or thereby westward of the south-west corner of the

dwelling-house occupied by John Findlay, 'Jackie.'

- 6th. A sea wall or bulwark, commencing from the southern extension of existing West Pier, thirdly above-described, from a point thereon, one hundred and sixteen lineal yards or thereby from the north-east-end of said West Pier, and proceeding from thence in a westerly direction for a length of two hundred and thirty lineal yards or thereby, and terminating on the sea beach or foreshore, at a point thereon, thirty-three lineal yards or thereby from the north corner of the Zion Chapel in Seatown;
- 7th. An excavation to form a new sea entrance to the Outer Harbour of Cullen, commencing from the termination of the northern extension of the West Pier, secondly above-described, and proceeding from thence in a north-easterly direction for a length of thirteen lineal yards or thereby, and terminating at a point on the high in line with the inner face of the East Quay, twenty-six lineal yards or thereby from the north-east face of the sea entrance to the Outer Harbour.
- 8th. To excavate, deepen, or dredge the whole of the Outer and Inner Harbours of Cullen to the level of low water of spring tides, to form slipways, and otherwise improve the West Pier and the entrance to Inner Harbour;

All of which intended works will be situate in the Parish and Burgh of Cullen and County of Banff, and the foreshore and bed of the sea in and *ex adverso* of the said Parish, Burgh, and County:

To make all suitable lateral and vertical deviations in the construction of the said intended works:—

To authorize the construction of all such railways, sidings, tramways, turntables, warehouses, and other buildings, cranes and conveniences, in connection with the harbour and new works, as may be deemed requisite:

To alter, extend, and define the limits of the said Harbour of Cullen:

To purchase, take on lease, or otherwise acquire lands necessary for the construction of the proposed works, and for other purposes in connection with the harbour and of the said Provisional Order, and to sell or dispose of such lands:

To levy tolls, rates, and duties on vessels and boats, and on passengers, animals, fish, goods, minerals, and other articles entering or leaving the existing and extended Harbour, or in respect of the use thereof, or of any part thereof, or of the quays, works, lights, warehouses, railways, tramways, and conveniences connected therewith, and for supplying water to vessels, and for services rendered in connection with the Harbour, and to alter, vary, and increase the tolls, rates, duties, and charges now authorized to be levied at the said Harbour; to make provision for the collection and regulation of the tolls, rates, duties, or charges; to compound for the same; to confer, vary, and extinguish exemptions from tolls, rates, duties, and charges; to confer, vary, and extinguish other rights and privileges, and to provide for the application of the funds and revenues of the said Harbour:

To borrow money for the purposes of the said intended works and of the said Provisional Order, on the security of the existing and extended Harbour, or either of them, and of the lands and

property connected therewith respectively, and the works constructed thereat, or of the tolls, rates, and duties authorized to be levied at and for the use of the existing Harbour, and which may be authorized to be levied by the said Provisional Order, and for establishing a sinking fund:

To provide for the maintenance, management, and regulation of the said existing and extended Harbour and works, and all matters relating thereto:

To provide for letting on lease the said Harbour and works, and the said tolls, rates, and duties, or any of them:

To supply water to vessels frequenting the Harbour.

To authorize the Commissioners to be constituted by the said Provisional Order to carry the same into effect, and to confer on them all powers, rights, privileges, and authorities which may be necessary for that purpose, and to vary and extinguish all rights and privileges which would interfere with the objects of the proposed Order:

To constitute the said Commissioners the Harbour and Pilotage Authorities for the said Harbour, and to grant to them all the powers and privileges authorized by the Merchants' Shipping Acts, 1854 to 1880, or otherwise howsoever:

To incorporate with the said Provisional Order all or some of the provisions of the Lands Clauses Consolidation (Scotland) Act, 1845; the Lands Clauses Consolidation Act Amendment Act, 1860; the Railways Clauses Consolidation (Scotland) Act, 1845; the Railways Clauses Act, 1863; the Harbours, Docks, and Piers Clauses Act, 1847; the Harbours and Passing Tolls, &c. Act, 1861; and the Commissioners Clauses Act, 1847; and such other Acts as may be requisite, and to alter or amend any Act, Charter, or other Deed which may be necessary.
