

OTICE is hereby given, that application is intended to be made to Parliament in the next session by the Liverpool Grain, Storage, and Transit Company Limited (hereinafter called 'the Company'), for an Act for the following purposes, or some of them, that is to say :-

To empower the Company to issue and deliver to persons warehousing or depositing goods in any warehouse, store, or premises of the Company, or to persons entitled to any goods so warehoused, stored, or deposited, certificates of such goods having been so warehoused, stored, or deposited, or warrants for the delivery of such goods, or of

any part thereof. To provide that every such certificate or warrant shall be deemed to be a document of title to the goods specified therein and transferable by endorsement, and further to provide that any holder of such certificate or warrant, whether the person named therein or the endorsee thereof, shall have the same right to the possession and property of such goods as if they were deposited in his own warehouse, and to make other provision for the issue of negociable certificates and warrants for defining the property in the goods and the rights of the holders of such certificates or warrants, and to exempt goods included therein from the operation of the law affecting goods in the possession, order, or disposition of a bankrupt as the reputed owner, and to amend or render inapplicable such of the provisions of the Bank-ruptcy Act, 1883, and the Bills of Sale Acts. 1878 and 1882, as may interfere with the objects of the intended Act.

Also to make provision for the payment of freight and all dock, warehouse, and other dues, rents, and charges in respect of goods warehoused or deposited with the Company. And it is proposed by the intended Act to enlarge or amend the Memorandum and Articles of Association of the Company, so far as may be necessary or expedient for the purposes above mentioned, or some of them.

To incorporate, with or without amendment, all, or some of the provisions of the following Acts (that is to say), the Companies Clauses Consolidation Act, 1845, the Companies Clauses Act, 1863, and the Companies Acts, 1862 to 1880.

GLASGOW CORPORATION WATER.

(Extension of Waterworks; Increased Supply of Water from Loch Katrine; Raising of Level of Water in Loch Katrine and Loch Arklet; New Aqueducts, Conduits, and other Works; Diversion of Water from Loch Katrine, Loch Arklet, and the Arklet Water; Compulsory Purchase of Lands, etc.; Provisions with Reference to Landowners, Compensation Water, etc.; Supply of Water to High-level Districts within the City, and Provisions relating thereto; Provisions for Protection of Water and Waterworks, for Preventing Fouling or Pollution of Water, and Powers to the Commissioners and others with Reference thereto; Alteration of Abatements to Owners Paying Water Rate; Reduction of Assessment on Underground Works of Commissioners; Additional Borrowing Powers; Application to Purposes of Bill of Present Funds and Moneys of Commissioners; Incorporation of Acts; Amendment of Acts; and other Purposes.

NOTICE is hereby given, that application is intended to be made to Parliament in the ensuing Session by the Lord Provost, Magistrates, and Council of the City and Royal Burgh of Glasgow, and by the Magistrates and Council of the City of Glasgow, the Commissioners for executing and carrying into effect 'The Glasgow Corporation Waterworks Acts, 1855, 1859, 1860, 1865, 1866, 1873, 1877, 1879, and 1882,' and 'The General Police and Improvement (Scotland) Act, 1862, Order Confirmation (Glasgow) Act 1877' (those Commissioners are in this Notice called 'the Commissioners,' and those Acts are in this Notice called 'The Glasgow Corporation Waterworks Acts'), for leave to bring in a Bill for the following or some of the following objects, powers, and purposes, that is to say:—

To authorise the Commissioners to make, maintain, and use the following waterworks, roads, and other works or some or one of them, or some part or parts thereof, respectively, together with all proper works and conveniences in connection therewith, including embankments, bridges, roads, approaches, fences, ways, wells, pumping works, tanks, basins, gauges, filter beds, stand pipes, dams, weirs, sluices, waste weirs, outlets, outfalls, discharge pipes, adits, engines, tunnels, byechannels, cuts, shafts, aqueducts, culverts, channels, cisterns, filtering apparatus, conduits, drains, mains and distributing pipes, junctions, valves, telegraphs, telephones, and other means of communication, apparatus, and conveniences connected with the said works, or any of them, or necessary for conducting, inspecting, maintaining, repairing, cleansing, managing, and using the same; and also to acquire the lands hereinafter described, that is to say :-

(1.) A dam or embankment for the purpose of enlarging Loch Katrine and raising the level of the water in that loch, to be situate at or near the outlet at the southeastern end of Loch Katrine, commencing in the parish of Aberfoil, in the county of Perth, at a point on the western side

of the outlet 8 yards or thereby, measuring in a south-westwardly direction from the western end of the existing dam across that outlet, continuing thence across the said outlet in an eastwardly and north-eastwardly direction, and terminating in the parish of Callander, in the county of Perth, at a point 90 yards or thereby (measuring on a straight line), in a north-eastwardly direction from the point hereinbefore described as the point of the commencement of the said dam or embankment, which said intended dam or embankment will be situate in, or pass from in through and into the said parishes of Aberfoil and Callander.

(2.) Lands to be compulsorily taken and acquired for the purpose of enlarging Loch Katrine and raising the level of the water thorain via

therein, viz.:-

(a) A strip of land round the margin of the said loch, and round the islands in the loch, which will be submerged by the enlarging of the loch and raising of the level of the water therein, which strip will vary in width, measuring in all cases landward from the water margin of the loch from r yard to 80 yards or thereby, and is situate in the parishes of Callander and Aberfoil, in the county of Perth, and the parish of Buchanan, in the county of Stirling.

(b) A tract of land, containing 23 acres or thereby, situate at and near the western end of Loch Katrine, and on either side of the Glengyle Water, partly in the parish of Callander, in the county of Perth, and partly in the parish of Buchanan, in the

county of Stirling.

(c) A tract of land, containing 5 acres or thereby, situate on and near the north shore of Loch Katrine, and on either side of the Letter Burn at or near the entrance of that burn into the said loch, in the parish of Callander, in the county of Perth.

(3.) The following diversions and alterations of the public road leading from Callander along the northern shore of Loch Katrine.

(A B) A diversion commencing in the said road at a point 360 yards or thereby (measuring along the road) westward from the Strone Burn at its entrance into the loch, and terminating by a junction with the road at a point 1070 yards or thereby (measuring along the road) eastward from the said Strone Burn.

(C D) A diversion commencing in the road at a point 490 yards or thereby (measuring along the road) eastward from the point hereinbefore described as the point of the termination of the said diversion (A B), and terminating by a junction with the road at a point 95 yards or thereby (measuring along the road) eastward from the point hereinbefore described as the point of the commencement of this diversion (C D).

(E F) An alteration of levels and raising of the road commencing in the road at a point 140 yards or thereby eastward from the point hereinbefore described as the point of the termination of the



last-mentioned diversion (C D), and terminating in the road at a point 33 yards or thereby eastward of the said point of the commencement of this

alteration (E F).

(G H) A diversion commencing in the road at a point 440 yards or thereby (measuring on a straight line) westwards from Brenachoil Shooting Lodge, and terminating by a junction with the road at a point 385 yards or thereby (measuring on a straight line) eastwards from

the said Lodge.

(I J) An alteration of levels and raising of the road, commencing in the road at a point 470 yards or thereby (measuring along the road) eastwards, from the point hereinbefore described as the point of the termination of the lastmentioned diversion (G H), and terminating in the road at a point 333 yards or thereby (measuring along the road) eastward from the said point of the commencement of this alteration (I J).

(J K) A diversion commencing in the road at or near the termination of the said last-mentioned alteration of levels (I J), and terminating by a junction with the road at a point 133 yards or thereby (measuring along the road) eastward from the commencement of

this diversion (J K).

(K L) An alteration of levels and raising of the road commencing in the road at or near the point hereinbefore described as the point of the termination of the last-mentioned diversion (J K), and terminating in the road at a point too yards or thereby (measuring along the road) eastward from the commencement of this alteration of levels (K L).

(M N) An alteration of levels and raising of the road, commencing in the road at a point 165 yards or thereby (measuring along the road) eastward from the point hereinbefore described as the point of the termination of the last mentioned alteration of levels (K L), and terminating in the road at a point 100 yards or thereby (measuring along the road) eastward from the commencement of this alteration of levels (M N).

(O P) An alteration of levels and raising of the road, commencing in the road at a point 900 yards or thereby (measuring along the road) eastward from the point hereinbefore described as the point of the termination of the last-mentioned alteration of levels (M N), and terminating in the road at a point 790 yards or thereby (measuring along the road) eastward from the commencement of this alteration of levels (O P).

of the road, commencing in the road at a point 240 yards or thereby (measuring along the road) eastward from the point hereinbefore described as the point of the termination of the last-mentioned alteration of levels (O P), and terminating in the road at a point 370 yards or thereby (measuring along the road).

eastward from the commencement of this alteration of levels (Q R).

(S T) An alteration of levels and raising of the road, commencing in the road at a point 196 yards or thereby (measuring along the road) castward from the point hereinbefore described as the point of the termination of the last-mentioned alteration of levels (Q R), and terminating in the road at a point 23 yards or thereby eastward from the Boat House, near the Steamboat Pier, at the northeast end of the Loch:

All which said road works A B, C D, E F, G H, I J, J K, K L, M N, O P, Q R, and S T, will be wholly situate in the Parish of Callander, in the county of

Perth.

- (4.) A dam or embankment for the purpose of enlarging Loch Arklet and raising the level of the water in that loch, to be situated across the river or stream known as the Arklet Water, at the distance of 750 yards or thereby westward of the present outlet of Loch Arklet, such dam or embankment commencing at a point on the road leading from Stroniachlachar to Inversnaid, 407 yards or thereby (measuring along that road in a westwardly direction) from the point in that road where that road crosses Corriearklet Burn, continuing thence (crossing the Arklet Water) in a southwardly direction for a distance of 615 yards or thereby, and terminating there at a point 787 yards or thereby (measuring in a westwardly direction) from the farm-house of Corriehichon.
- (5.) A discharge culvert commencing in the Arklet Water at a point 150 yards or thereby (measuring on a straight line in a north-eastwardly direction) from the point hereinbefore described as the point of the termination of the last-mentioned dam or embankment (4), passing round the south end of that dam or embankment, and terminating in the Arklet Water at a point 160 yards or thereby (measuring on a straight line in a north-westwardly direction) from the point hereinbefore described as the point of the termination of the said last-mentioned dam or embankment (4).

The said dam or embankment (4) and the said discharge culvert (5) will be wholly situate in the parish of Buchanan,

(b) A tract of land containing 100 acres or thereby, situate at and near the western end of Loch Arklet, and extending on both sides of the Arklet Water, all in the parish of Buchanan, in the county of

Stirling

(7.) A conduit or line of pipes commencing in the parish of Buchanan, in the county of Stirling, from and out of the eastern end of Loch Arklet, at a point 310 yards or thereby (measuring on a straight line in a south-eastwardly direction) from the house called Bruach, on the road from Stronachlachar to Inversnaid, and terminating in the parish of Aberfoil, in the county of Perth, in the south-eastern end of Loch Katrine, 420 yards or thereby (measuring on a straight line in a north-westwardly direction) from the western end of the existing dam across the outlet of Loch Katrine, which said intended conduit or line of pipes will be situate in, or pass from, in, through, or into the said parishes of Buchanan and Aberfoil.

(8.) An aqueduct from and out of Loch Katrine, commencing in the parish of Aberfoil, in the county of Perth, at a point in Loch Katrine 22 yards or thereby westward of the inlet to the existing aqueduct of the Commissioners, from Loch Katrine to Glasgow, and terminating in the parish of Strathblane in the county of Stirling, by a junction with the aqueduct authorised by and fourthly described in 'The Glasgow Corporation Waterworks Amendment Act, 1882,' at a point 22 yards or thereby eastward of the termination of the existing aqueduct of the Commissioners at the north end of the Mugdock Reservoir, which said intended aqueduct will be situate in, or pass from, in, through, or into the parishes of Aberfoil in the county of Perth, and Drymen, Balfron, Killearn, and Strathblane in the county of Stirling, or some or one of them.

(9.) A branch aqueduct to be wholly situate in the parish of Strathblane, in the county of Stirling, commencing by a junction with the intended aqueduct (8) last hereinbefore described at the point hereinbefore described as the point of the termination of that aqueduct, and terminating in the north end of the said Mugdock Reservoir.

(10.) An aqueduct or line of pipes commencing in the parish of New Kilpatrick, in the county of Stirling, from and out of the reservoir authorised by and thirdly described in 'The Glasgow Corporation Waterworks Amendment Act, 1882,' at a point 210 yards or thereby (measuring on a straight line in an eastwardly direction) from the Commissioners' Cottage, at or near the south-eastern end of the said Mugdock Reservoir, and terminating in the parish of Springburn or City Parish of Glasgow, in the county of Lanark, by a junction with the existing mains of the Commissioners at or near the junction of the New Keppoch Hill Road with the Springburn Road, which said aqueduct will be situate in or pass from, in, through, or into the parishes and other places of New Kilpatrick and Baldernock, in the county of Stirling, and Cadder, Maryhill,

Royal Burgh of Glasgow, in the county of Lanark, or some or one of them.

- (11.) An aqueduct or line of pipes commencing in the parish of New Kilpatrick, in the county of Stirling, from and out of the reservoir authorised by, and thirdly described in 'The Glasgow Corporation Waterworks Amendment Act, 1882,' at a point 210 yards or thereby measuring in a straight line in an eastwardly from the Commissioners' direction) Cottage at or near the south-eastern end of the said Mugdock Reservoir, and terminating in the parish of Maryhill or City Parish of Glasgow and Royal Burgh of Glasgow in the county of Lanark, by a junction with the existing mains of the Commissioners at or near the junction of Saracen Street with New Keppoch Hill Road, which said branch aqueduct or line of pipes will be situate in or pass from, in, through, or into the parishes and other places of New Kilpatrick and Baldernock, in the county of Stirling, and Cadder, Maryhill or Barony Parish of Glasgow, and Maryhill or City Parish of Glasgow, and Royal Burgh of Glasgow, in the county of Lanark, or some or one of
- (12.) A road wholly situate in the parish of Drymen, in the county of Stirling, commencing at a point in the public road leading from Glasgow to Aberfoil 450 yards or thereby (measuring on a straight line in a southwardly direction) from the farm-house called Garrauld, and terminating at a point on the existing aqueduct of the Commissioners 1010 yards or thereby (measuring on a straight line in an eastwardly direction) from the farm-house called Hoish.
- (13.) A road wholly situate in the parish of New Kilpatrick, in the county of Stirling, passing along the eastern side of the said Mugdock Reservoir, and commencing from and out of the road which crosses the northern end of that reservoir, at a point in that road at or near the eastern side of that reservoir, and terminating by a junction with the road passing along the south-eastern side of that reservoir at or near the eastern corner of that reservoir.

be diverted from Loch Katrine now flows through Loch Achray and Loch Vennacher, and along the River Teith and the River Forth into the Firth of Forth.

To empower the Commissioners to deviate laterally from the lines of the several works hereinbefore described to the extent shown on the plans to be deposited as hereinafter mentioned, or as may be provided by the Bill, and to deviate vertically from the levels shown on the sections to be deposited as hereinafter mentioned, to any extent which may be provided by the Bill, and also temporarily or permanently to use, cross, open, or break up, alter, divert, and stop up highways and other roads, railways, tramways, bridges, streets, paths, passages, rivers, canals, streams, brooks, drains, sewers, aqueducts, watercourses, reservoirs, telegraph apparatus, and gas, water, and other pipes, and to carry conduits, pipes, and other works through, over, under, across, along, upon, or into the same within the parishes and places aforesaid so far as may be necessary or expedient for the purposes of making, maintaining, and using the several works before mentioned or any of them, or any of the works and conveniences connected therewith.
