No. 4. Arradoul Female School Endowment in the County of Banff and Parish of Rathven;

No. 5. Bell Fund in the County of Fife and Parish of Cameron;

No. 6. Henderson Mortification in the County of Fife and Parish of Leuchars.

No. 1.—Scheme, under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Endowment, in the Parish of Alvah and County of Banff, known as Wright's Bequest, hitherto held and administered under the last Will and Testament of Alexander Wright, dated 26th January 1867, and recorded in the Register of Probation Writs for the County of Banff, 26th April 1867.



Operative Clause.

6. The governing body, after paying the necessary expenses of management and the burdens and taxes affecting the Endowment, shall apply the income to one or other of the following objects as from time to time they see fit :- (a) They may establish a bursary to be awarded by competitive examination among children attending the public or State-aided schools in the parish of Alvah, who have passed the fifth standard of the present Scotch Code, or such standard as may be from time to time fixed by the Scotch Education Department, pursuant to the Education (Scotland) Acts, as that entitling children to total exemption from the obligation to attend school, and whose parents or guardians are in such circumstances as to require aid in giving them a higher education. The bursary shall be tenable for two years at public or State-aided schools to be approved by the governing body; or, (b) They may apply the income in paying the fees of poor and deserving children, with books and stationery, at public or State-aided schools in the parish of Alvah, who have passed in the fifth standard of the present Scotch Code, and whose parents or guardians are in such circumstances as to require aid in giving them higher education. These free scholarships shall be awarded on the result of a competitive examination or as a reward for regularity of attendance, industry, general merit, and good conduct, all to be ascertained by the report of the teachers, and otherwise as the governing body may determine. Any payment under this sub-section shall be withdrawn in the case of children who fail to give regular attendance or make satisfactory progress at school.

No. 2.—Scheme, under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Endowments in the Parish of Grange and County of Banff, known as the Paithnick Mortification, presently paid by the Earl of Fife to the School Board of Grange, and the Bruce Mortification, presently held and administered by the Kirk-Session of Grange.

Operative Clause.

7. The governing body, after paying the necessary expenses of management and the burdens and taxes affecting the Endowment, shall apply the free annual income to either of the following objects as from time to time they may see fit: -(u) They may establish a school bursary to be called the Bruce School Bursary, which shall be awarded by competitive examination among pupils attending public or State-aided schools in the parish of Grange, who have passed the fifth standard of the present Scotch Code, or such standard as may from time to time be fixed by the Scotch Education Department pursuant to the Education (Scotland) Acts, as that entitling children to total exemption from the obligation to attend school, and whose parents or guardians are in such circumstances as to require aid for giving them higher education; the bursary shall be tenable for two years at public or State-aided schools in which efficient instruction is given in the higher branches; or, (b) They may expend the annual income in awarding prizes in the public schools of the parish of Grange, provided always that no prize shall be awarded to any child who nor more than £15.

No. 3.—Scheme, under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Endowment in the Parish of Botriphnie and County of Banff, known as Admiral Duff's Bequest, hitherto held and administered by the Kirk-Session of Botriphnie under Trust Disposition and Deed of Settlement by Admiral Archibald Duff, dated 25th July 1853, and registered in the Books of Council and Session, 27th March 1858.

Operative Clause.

6. The governing body, after paying the necessary expenses of management and the burdens and taxes affecting the Endowment, shall apply the free annual income in establishing a bursary to be called the Duff Bursary, which shall be awarded by competitive examination among pupils attending public or State-aided schools in the parish of Botriphnie who have passed the fifth standard of the present Scotch Code, or such standard as may from time to time be fixed by the Scotch Education Department pursuant to the Education (Scotland) Act, as that entitling children to total exemption from the obligation to attend school, and whose parents or guardians are in such circumstances as to require aid in giving them higher education. In the event of equality in examination a preference shall be given to girls. The bursary shall be tenable for two years at a public or State-aided school, in which efficient instruction is given in the higher branches.

No. 4.—Scheme, under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Endowments in the Parish of Rathven and County of Banff, known as the Arradoul Female School Endowment, presently held and administered by the School Board of the Parish of Rathven.

Operative Clause.

5. The governing body, after paying the necessary expenses of management and the burdens and taxes affecting the Endowment, shall apply the income to one or other of the following objects as from time to time they see fit:—(a) They may establish one or more bursaries of the annual value of not less than £2, to be awarded by competitive examination among children attending the public or State-aided schools in the parish of Rathven, who have passed the fifth standard of the present Scotch Code, or such standard as may be from time to time fixed by the Scotch Education Department, pursuant to the Education (Scotland) Acts, as that entitling children to total exemption from the obligation to attend school, and whose parents or guardians are in such circumstances as to require aid in giving them a higher education. These bursaries shall be tenable for such period not exceeding two years as the governing body may think fit at public or State-aided schools to be approved by the governing body; or, (b) They may accumulate the annual revenue, or a part thereof, and apply the same in giving at intervals a bursary of not less than £10 nor more than £15. The bursary shall be

awarded by competition among children attending | annual income in either of the following modes as public or State-aided in the parish of Rathven, whose parents or guardians are in such circumstances as to require aid in giving them a higher education, under such conditions and regulations as to age or otherwise as the governing body may from time to time determine. It shall be tenable for a period not exceeding two years at such school for higher education or technical instruction as the governing body may approve, or at a Scotch University.

No. 5.—Scheme, under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Endowment in the Parish of Cameron and County of Fife, known as the Bell Fund, presently held by the School Board of the Parish of Cameron.

Operative Clause.

5. The governing body, after paying the necessary expenses of management, and the burdens and taxes affecting the Endowment, shall apply the income to one or other of the following objects as from time to time they see fit: -(a) They may establish a bursary to be awarded by competitive examination among children attending the school at Denhead in the parish of Cameron, who have passed the fifth standard of the present Scotch Code, or such standard as may be from time to time fixed by the Scotch Education Department, pursuant to the Education (Scotland) Acts, as that entitling children to total exemption from the obligation to attend school, and whose parents or guardians are in such circumstances as to require aid in giving them a higher education. bursary shall be tenable for two years at public or State-aided schools to be approved by the governing body; or, (b) They may apply the income in paying the fees of poor and deserving children, with books and stationery, at the school of Denhead in the parish of Cameron who have passed in the fifth standard of the present Scotch Code, and whose parents or guardians are in such circumstances as to require aid in giving them higher education. These free scholarships shall awarded on the result of a competitive examination, or as a reward for regularity of attendance, industry, general merit, and good conduct, all to be ascertained by the report of the teachers, and otherwise as the governing body may determine. Any payment under this sub-section shall be withdrawn in the case of children who fail to give regular attendance or make satisfactory progress at school.

No. 6 .- Scheme, under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Endowment in the Parish of Leuchars and County of Fife, known as the Henderson Mortification, hitherto held and administered under the Last Will and Testament of Alexander Henderson, dated 17th August 1646, and recorded in the Commissary Court Books at Edinburgh, 9th November 1646.

Operative Clause.

7. The governing body, after paying the necessary expenses of management and the burdens and taxes affecting the Endowment, shall apply the free |

they may from time to time see fit :-

(1) They may establish two school bursaries to be called the Henderson School Bursaries, to be awarded by competitive examination among pupils attending public or State-aided schools in the parish of Leuchars, who have passed the fifth standard of the present Scotch Code, or such standard as may from time to time be fixed by the Scotch Education Department, pursuant to the Education (Scotland) Acts, as that entitling children to total exemption from the obligation to attend school, and whose parents or guardians are in such circumstances as to require aid for giving them higher education; these bursaries shall be tenable for two years at public or State-aided schools in which efficient instruction is given in the higher branches, or

(2) They may establish a bursary for higher education to be called the Henderson Bursary, to be awarded by competitive examination among pupils attending public or State-aided schools in the parish of Leuchars, whose parents or guardians require aid in giving them higher education, and whose age at the date of the competition shall not exceed fourteen years; it shall be tenable for such period, not exceeding three years, as the governors may determine, at such schools for higher education or technical instruction as they may approve.

Note.—In the above Schemes, the Endowments are transferred to the respective School Boards, and the usual clauses are inserted as to Investment, &c.

To sell or lease the undertaking, or some portion thereof, or to lease or compound, or to omit levying the said Tolls, Rates, and Duties, Shore Dues, Anchorages, Harbour Customs and Charges, or any part of them in such manner, and for such period as may be specified in the said Provisional Order, and to provide for the application of the revenue

of the Harbour.

To borrow at interest such money as may be required for the purposes of the Harbour, and of the said Provisional Order, by way of bond, mortgage, cash credit, or otherwise, on the security of the Harbour, and of the lands and property connected therewith respectively; and the works constructed thereon, and of the Tolls, Rates, and Duties, Shore Dues, Anchorages, Customs and other Charges and Payments authorised to be levied, or which may be authorised to be levied by the said Provisional Order; and to enable the promoters to make further provision for, or to establish a sinking fund for, the repayment of monies borrowed.

To authorise the promoters for the time being to carry the proposed Provisional Order into effect; to confer on them all powers, rights, and privileges and authorities which may be necessary for that purpose; and to provide for the maintenance, management, and administration of the Harbour of Dunbar, and of the works connected therewith, and of all matters relating thereto respectively.

CLYDE NAVIGATION.

(Extension of Time for Compulsory Purchase of Lands and Completion of Works; Provisions for Collecting and Enforcing Payment of Rates, Tolls, and Duties; Appointment of Master-Porters, Meters, Weighers, and other Officers; Power to Clyde Pilot Board to enter into Agreements with Proprietors and Lessees of Harbours, Piers, &c., in River and Firth of Clyde, for, or to require the Erection, Maintenance, and working by such Proprietors or Lessees of Signals for Regulating the Pilotage and Approach of Steam Vessels; Confirmation of Agreements; Bye-Laws, Officers, and Rates for Working Signals; Incorporation, Amendment or Repeal of Acts; and other Purposes.)

TICE is hereby given, that application is intended to be made to Parliament in the ensuing Session for leave to bring in a Bill (hereinafter called 'the Bill') for effecting the objects and purposes aftermentioned, or some of them, that is to say :-

To extend the time limited by the Clyde Navigation Act, 1883, for the compulsory purchase of lands, houses, and other property for the purposes of the said Act, and also for the completion of the works thereby authorised.

To provide for the collection of the rates, tolls, and duties leviable under the Clyde Navigation Consolidation Act, 1858, and the Acts amending the same, or relating to or affecting the Trustees of the Clyde Navigation (hereinafter called 'the Trustees,') and for the imposition and enforcement of fines or penalties on the owners, masters, agents. or other persons in charge of vessels leaving the Harbour of Glasgow before payment is made of the rates, tolls, and duties leviable in respect of such vessels, or in respect of all or any part of the cargoes of such vessels.

To authorise the Trustees to appoint and license, from time to time, as they may think fit, Master-Porters, Meters, Weighers, Measurers, and Stevedores, within the limits of the said Harbour; to make regulations for the control and conduct of such Master-Porters, Meters, Weighers, Measurers, and Stevedores; and to fix the rates to be paid or remuneration to be made for Storing, Weighing, Measuring, Stowing, and Discharging

of Cargoes within the said limits.
