A PROCLAMATION.

VICTORIA, R.

WHEREAS Our Parliament stands prorogued to the eleventh day of November instant, We, by and with the advice of Our Privy Council, hereby issue Our Royal Proclamation, and publish and declare that the said Parliament be further prorogued to Thursday the ninth day of December one thousand eight hundred and eighty-six.

Given at Our Court at Windsor, this tenth day of November, in the year of Our Lord One thousand eight hundred and eighty-six, and in the fiftieth year of Our Reign.

GOD SAVE THE QUEEN.

At the Court at Windsor, the 10th day of November 1886.

#### PRESENT,

The QUEEN's Most Excellent Majesty in Council.

It is this day ordered by Her Majesty in Council that the Convocations of the Provinces of Canterbury and York be prorogued from the

day to which the same now stand prorogued, to Friday the tenth day of December one thousand eight hundred and eighty-six; and the Right Honourable the Lord High Chancellor of that part of the United Kingdom called Great Britain is to cause Writs to be prepared and issued in the usual manner for proroguing the Convocations accordingly.

ORDER IN COUNCIL No. 13.

EXPLOSIVES ACT, 1875 (38 Viet. c. 17).

Order in Council relating to the exemption of Small Arm Nitro-compounds from the Restrictions imposed in Orders in Council, Nos. 6A, 7A, and 12.

At the Court at Balmoral, the 24th day of September 1886.

#### PRESENT,

The QUEEN's Most Excellent Majesty in Council.

Whereas in pursuance of 'The Explosives Act, 1875,' three Orders of Her Majesty in Council were made, bearing date twentieth April one thousand eight hundred and eighty-three, by which Orders it is provided that certain explosives shall not be kept in stores or registered premises or for private use except in pursuance of a certificate granted as set forth in the said Orders that the person authorised by such certificate is a fit

person to keep such explosives during the continuance of the said certificate.

Now Her Majesty is pleased, in pursuance of part two (section forty-three) of the said Act, by and with the advice of Her Privy Council, to order and prescribe,—

(a) That, notwithstanding anything contained in the aforesaid Orders in Council, a certificate as set forth therein shall not be required to authorise the keeping in any store, registered premises, or for private use, of Schultze gunpowder, E. C. sporting powder, E. C. rifle powder, or other nitro-compound adapted and intended exclusively for use in cartridges for small arms only, and otherwise designated small arm nitro-compound, or of cartridges exclusively for small arms made with such small arm nitro-compound.

(b) That this Order shall be construed in like manner to the aforesaid Orders as if it were part of the Act; and that it shall come into operation immediately on its publication in the London Gazette, provided always that it shall not affect rights, obligations, or liabilities acquired or incurred previously to such publication.

THE STATUTES OF THE DISTINGUISHED SERVICE ORDER.

#### VICTORIA, R. & I.

United Kingdom of Great Britain and Ireland, Queen, Defender of the Faith, Empress of India, to all to whom these presents shall come, greeting:—

Whereas We have taken into Our Royal consideration that the means of adequately rewarding the distinguished services of Officers in Our Naval and Military Services who have been honourably mentioned in Despatches are limited; now for the purpose of attaining an end so desirable as that of rewarding individual instances of meritorious or distinguished service in war, We have instituted and created, and by these presents, for Us, Our Heirs and Successors, do institute and create a new Naval and Military Order of Distinctionto be designated as hereinafter described-We are desirous should be highly prized by the Officers of Our Naval and Military Services, and We are graciously pleased to make, ordain, and establish the following rules and ordinances for the government of the same, which shall henceforth be inviolably observed and kept;

Firstly. It is ordained, that this Order shall henceforth be styled and designated the 'Distinguished Service Order.'

Secondly. It is ordained that the Order shall consist of the Sovereign, and of such Members or Companions as We, Our Heirs or Successors, shall appoint.

Thirdly. It is ordained that We, Our Heirs and Successors, Kings and Queens Regnant of the United Kingdom of Great Britain and Ireland,

Emperors and Empresses of India, are and for ever shall be Sovereigns of this Order.

Fourthly. It is ordained that no person shall be eligible for this distinction who doth not actually hold, at the time of his nomination, a Commission in Our Navy, in Our Land Forces, or Marines, or Our Indian or Colonial Naval or Military Forces, or a Commission in one of the Departments of Our Navy or Army, the holder of which is entitled to Honorary or relative Navy or Army rank, nor shall any person be nominated unless his services shall have been marked by the especial mention of his name, by the Admiral or Senior Naval Officer Commanding a Squadron or detached Naval Force, or by the Commander-in-Chief of the Forces in the Field, in Despatches for meritorious or distinguished service in the Field, or before the enemy.

Fifthly. It is ordained that Foreign Officers who have been associated in Naval and Military operations with Our Forces, shall be eligible to be Honorary Members of this Order.

Sixthly. It is ordained that when We, Our Heirs and Successors, shall be pleased to appoint any person to be a Member of this Order, such appointment shall be made by Warrant under Our Sign Manual, and countersigned by one of Our Principal Secretaries of State.

Seventhly. It is ordained that the decoration of the Order shall be and shall be worn as is hereinafter set forth.

Eighthly. It is ordained that an Officer shall be appointed to this Order, that is to say, a Secretary and Registrar.

Ninthly. It is ordained that the Secretary and Registrar of this Order shall be appointed by Us, Our Heirs and Successors, and shall have the custody of the archives of the Order. He shall attend to the Service of the Order, and shall execute such directions as he may receive from Our Principal Secretary of State for War.

Tenthly. It is ordained that this Order shall rank next to and immediately after Our Order of the Indian Empire, and that the Companions thereof shall, in all places and assemblies whatsoever, have place and precedency next to and immediately after the Companions of Our said Order of the Indian Empire, and shall rank among themselves according to the dates of their respective nominations.

Eleventhly. It is ordained that the Badge of the Order, which shall consist of a gold cross, enamelled white, edged gold, having on one side thereof in the centre, within a wreath of laurel enamelled green, the Imperial Crown in gold, upon a red enamelled ground, and on the reverse, within a similar wreath and on a similar red ground, Our Imperial and Royal cypher V.R.I., shall be suspended from the left breast by a red riband edged blue, of one inch in width.

Twelfthly. It is ordained that the names of those upon whom We may be pleased to confer the decoration, shall be published in the London Gazette, and a registry thereof kept in the office of Our Secretary of State for War.

Lastly. We reserve to Ourself, Our Heirs and Successors, full power of annulling, altering, abrogating, augmenting, interpreting, or dispensing with these Regulations, or any part thereof, by a notification under the Sign Manual of the Sovereign of the Order.

Scheme, under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Endowments known as the Gordon Schools, with the Endowments attached thereto, hitherto held and administered under Feu Charter by Charles, Duke of Richmond and Lennox, dated 4th September 1841; Notarial Instrument in favour of the Duke of Richmond and Lennox and others, Trustees of the said Gordon Schools, recorded in the General Register of Sasines applicable to the County of Aberdeen, 7th October 1875; Will and Testament of Elizabeth, Duchessof Gordon, dated 25th September 1862, with Codicil thereto, dated 31st October 1862; and Hall's Legacy, hitherto held and administered under the Will of Elizabeth Hall, dated 24th May 1852.

#### Preamble.

1, 2. Future Administration; Transference of Property.

3. Constitution and Election of Governing Body.—The governing body, hereinafter called the governors, shall consist of five persons, of whom

Two shall be appointed by the Duke of Richmond and Gordon, or by his tutors or curators if he be a minor or incapable of acting;

Two shall be elected by the School Board of Huntly; and

One shall be elected by the Kirk-Session of Huntly.

The governors may be elected by the several electing bodies either out of their own number or otherwise. The governors appointed by the Duke of Richmond and Gordon or his foresaids shall, in the case of the first election, hold office for a period of five years, and thereafter until the first day of August after the expiry of that period. The governors elected by the School Board and Kirk-Session of Huntly shall, in the case of the first election, hold office for a period of three years, and thereafter until the first day of August after the expiry of that period. The governors shall, in the case of all elections or appointments subsequent to the first, hold office for a period of five years from and after the expiry of the term of office of their predecessors, except as hereinafter provided. Each election shall be made at a meeting convened and conducted according to the ordinary rules and practice of the electing body. Any governor may be re-elected or re-appointed. The first governors shall be elected or appointed as soon as conveniently may be after the date of this Scheme. The clerk or other officer of the governors shall, at least one month before the expiry of the term of office of any governor, give notice to the proper electing body or to the Duke of Richmond and Gordon, as the case may be, and the electing body or the said Duke of Richmond and Gordon shall, as soon as conveniently may be after such notice, appoint or elect a governor to hold office from the expiry of said term. Any election or appointment not made as aforesaid within three months from the date of this Scheme, or from the date of the notice of expiry of a term of office, or from the date of the notice of a vacancy, as hereinafter prescribed, shall in that case be made by the then existing governors.

Vacancies; Meetings; Chairman; Quorum, and Execution of Deeds and Minutes.

11-16. Accounts; Business Arrangements; Casual Profits; Powers of Sale and Investment; Audit.

17-20. Clauses relating to Transference of Administration.

21. Transference of School Buildings to School Board. — The buildings known as the Gordon Schools, with their sites, pertinents, and furnishings, shall, from and after the date of this Scheme, be transferred to and vest in the School Board of Huntly, under burden of the feu-duty or other burdens attaching thereto, without the necessity of any further conveyance or instrument, under the condition always that the said buildings shall be used by the said School Board for educational purposes, but without any further restriction, that they shall continue in all time coming to bear the name of the Gordon Schools, and that the School Board shall employ the present female teacher, Miss Aldiss, until her death or resignation, on such terms as may be agreed on between the governors and said Board, provided always that if the governors and said Board disagree as to said terms of employment they shall be fixed by the Scotch Education Department. The governors shall, within twelve months after the date of this

Scheme, cease to maintain the schools maintained in said building by the present trustees of said Endowment.

22. Vested Interests.

#### Application of Income.

23. Application of Income. — The governors, after paying the necessary expenses of management and the burdens and taxes affecting the Endowment, shall, after their ceasing to maintain the schools under the administration of the present trustees of the said Gordon Schools, apply the free income of the Endowment in the manner hereinafter provided.

24. School Bursaries.—The governors shall apply the annual sum of £50 in establishing school bursaries, to be called the Gordon School Bursaries, each of the yearly value of not less than £5 nor more than £10. These bursaries shall be awarded by competitive examination among pupils attending public or State-aided schools in the parish of Huntly, who have passed the fifth standard of the present Scotch Code, or such standard as may from time to time be fixed by the Scotch Education Department, pursuant to the Education (Scotland) Acts, as that entitling children to total exemption from the obligation to attend school, and whose parents or guardians are in such circumstances as to require aid for giving them higher education; these bursaries shall be tenable for such period not exceeding three years as the governors may determine, at public or State-aided schools in which efficient instruction is given in the higher branches.

 Free Scholarships at Public Schools.—The governors may expend a sum not exceeding £10 yearly in paying the fees of poor and deserving children, who shall be called Hall's Free Scholars, with books and stationery, at public or State-aided schools in the parish of Huntly, who have passed in the third or higher standards of the present Scotch Code, and whose parents or guardians, not being in receipt of parochial relief, are in such circumstances as to require aid in providing elementary education, and are persons who, in the opinion of the governors, should not be required to apply to the Parochial Board for aid in paying school fees. These free scholarships shall be awarded on the result of a competitive examination, or as a reward for regularity of attendance, industry, general merit, and good conduct, all to be ascertained by the report of the teachers and otherwise as the governors may determine. Any payment under this clause shall be withdrawn in the case of children who fail to give regular attendance or make satisfactory progress at school.

26. Remainder of Income to be employed in promoting Higher Instruction.—The governors shall pay the remaining free annual income of the Endowment to the School Board of Huntly, to be applied by them for the promotion of higher instruction, either, according as the governors may determine, by increasing the number and efficiency of the staff for higher instruction in their principal school, or by retaining the services of an efficient female teacher or teachers to give separate instruction to girls in the higher classes. The governors shall satisfy themselves from time to time that the funds are being efficiently applied for higher instruction in the manner prescribed, and not in relief of any expenditure which the School Board might reasonably be expected to incur out of the school fund; and if appear to the

governors that the funds are not being applied in manner foresaid they shall cease to make such yearly payments to the School Board, and shall apply the remaining free yearly income of the Endowment to the purposes of the following section; provided always that the School Board shall have the right to appeal to the Scotch Education Department against any such decision of the governors; and provided further that the Scotch Education Department, either on the application of any governor or member of the School Board, or on such information and after such inquiry as they themselves may deem necessary, shall have the power to intimate to the governors that the said payment is not being efficiently applied in manner foresaid, and the governors shall thereupon cease to make such payment, and shall apply the same to the purposes of the immediately succeeding section, until the School Board have satisfied the Department that they are prepared to comply with the conditions of said payment.

27. Bursaries for Higher or Technical Education .- In the event of the governors ceasing for any period to make the payment to the School Board under the provisions of the immediately preceding section, they shall during such period apply the remaining free income of the Endowment in establishing bursaries for higher education, to be called the Gordon Bursaries, each of the yearly value of not less than £15 nor more than £20. These bursaries shall be awarded by competitive examination among pupils attending public or State-aided schools in the parish of Huntly, under such conditions and regulations as to age or otherwise as the governors may determine; they shall be tenable for such period, not exceeding three years, as the governors may determine, at such schools for higher education or technical instruction as they may approve. In the event of the annual payment to the School Board being renewed under the provisions of the immediately preceding section, the governors shall, in the first place, make payment of any bursaries awarded under this section.

28. Forfeiture of Bursaries.—If, in the judgment of the governors, the holder of any bursary shall be guilty of serious misconduct, or fail to make reasonable progress, they may withdraw such bursary, and their determination in such case shall be final.

29. Annual Distribution of Bursaries.— The governors shall establish the bursaries herein provided for in such manner as to secure that they shall be awarded in as nearly as possible equal numbers in each year.

30-34. Future Administration; Power to Apply to Court of Session for Alteration; Power to make Bye-Laws, and receive Additional Donations. Scheme to be Printed.

Note.—As the Gordon School Trustees and the School Board have submitted to the Commissioners an agreement which they ask to be incorporated in a Scheme, the Commissioners desire to explain why they do not see their way to give effect to it. It appears to the Commissioners that the result of the agreement would be in future to relieve the School Board of expenditure which ought properly to be defrayed out of the rates. The policy of the Commissioners has always been to make it certain, if possible, that an endowment should secure some special educational advantages to the district to which it is applicable, and it appears to them that this object will be best attained by the

Scheme now published. The Commissioners have not thought it desirable that any permanent conditions should be imposed as to the maintenance of a separate female school. They have no doubt they can trust this matter to the discretion of the governors and the School Board; and that it is better to do so than to lay down conditions which could not be easily altered under any subsequent change of circumstances.


