# GREAT NORTH OF SCOTLAND RAILWAY.

(FURTHER POWERS.)

(Amendment of Great North of Scotland Railway (Consolidation and Conversion of Stocks) Act, 1882; Additional Capital; Alteration of Certain Stocks; Loop Line at Grange; Polmuir Road Bridge; Compulsory Purchase of Lands.)

North of Scotland Railway Company (hereinafter called "The Company") intend to apply to Parliament in the ensuing Session for leave to bring in a Bill for the following or some of the following among other purposes:—

- 1. To alter the provisions of the Great North of Scotland Railway (Consolidation and Conversion of Stocks) Act 1882 (hereinafter called the Consolidation Act of 1882) which relate to the creation and issue of the "New C Preference Shares" therein mentioned and to provide for cancelling the resolution of the Company of the 21st day of September 1882 relative to the creation of the said New C Preference Shares and to make further provisions as to the terms and conditions upon which the said shares or stock in substitution therefor may be created and issued.
- 2. To enable the company to raise additional Capital by Shares Stock or borrowing and to apply the same wholly or in part for the purposes of their Railway authorised by the Great North of Scotland (Buckie Extension) Railway Act 1882 and to provide either for increasing the separate Capital created and issued under that Act or for raising money by debentures or debenture stock on security of the separate undertaking thereby authorised or of the general undertaking of the company or partly by one and partly by the other of such methods.
- 3. To merge the separate Capital created under the last mentioned Act (together with any additions thereto authorised by the intended Act) in the Lien Stock authorised and created under the Consolidation Act of 1882 or to provide for the said separate Capital being so merged with the assent of such proportion of the holders of the said Stocks respectively as may be prescribed in the intended Act and to provide for making the Buckie Railway part of the general undertaking of the Company.

4. To repeal or alter those provisions of the Great North of Scotland Railway Act 1873 and of the Consolidation Act of 1882 which relate to the redemption of the "Redeemable Four per cent. Preference Stock "now remaining unredeemed and to constitute the same Stock a permanent stock or to make other provisions with

reference thereto.

. 5. To authorise and confirm the construction of a short Loop Line commencing in the Parish of Cairnie and County of Aberdeen by a Junction with the Main Line of the Company about two furlongs northward of the Gatekeeper's house at the level crossing near Haughs of Cairnie and terminating in the Parish of Grange in the County of Banff by a junction with the Banff Portsoy and Strathisla section of the Company's Railway about three chains westward of the bridge carrying the said Railway over the River Isla near Nether Mills of Grange and to declare the same for the purpose of tolls rates and charges and all other purposes part of the undertaking of the Company and also to enable the Company to purchase and take by compulsion or agreement Lands and other property required for the purposes of said Loop Line.

6. To authorise and confirm certain alterations recently made by the Company with the assent of the Town Council of Aberdeen in the Bridge carrying the Company's Decside Railway over the Polmuir Road in the Parish of Oldmachar and County of

Aberdeen.

7. To enable the Company to purchase and acquire by agreement or compulsion for purposes of their undertaking certain Lands in the united parishes of Glenmuick Tullich and Glen Gairn in the County of Aberdeen which are situate on both sides of their Railway at their Ballater Station and extend on both sides of the said Station.

8. To empower the Company to divert alter or stop up any roads or rights of way sewers pipes or other works on over or through any parts of the lands to be acquired under the Bill or shewn on the deposited Plans.

9. To authorize the Company to apply any moneys which they at present possess or which they have still the power to raise to the purposes of the Bill.

10. To vary and extinguish all rights and privileges which would in any manner impede or interfere with the objects and purposes of the Bill and to confer vary and extinguish other rights and privileges.

11. The Bill may incorporate with itself any necessary provisions of "The Companies Clauses Consolidation (Scotland) Act Clauses Consolidation (Scotland) Act 1845" "The Companies Clauses Act 1863" "The Companies Clauses Act 1869"
"The Lands Clauses Consolidation (Scotland) Act 1845" "The Lands Clauses Consolidation Acts Amendment Act 1860" "The Lands Clauses Consolidation Act 1869" "The Railways Clauses Consolidation (Scotland) Act 1845" and "The Railways Clauses Act 1863" and the Bill will so far as may be deemed necessary or expedient amend or enlarge the Great Act 1859 and any other Acts relating to the Company.

To empower the Society or their Office-Bearers or the Judicial Factor, at such time and in such manner as shall be resolved on, to contract with any Insurance Company, or other body, for the Purchase of Annuities and Provisions for the Widows and Children of deceased Members of the Society, or other persons, of such amounts as shall be provided in the intended Act, in lieu of the Annuities which such Widows and Children or other persons may be receiving from the Fund.

To provide for the winding-up and distribution

of the Fund among the Members of the Society, at such time and in such manner as shall be resolved on by the Members of the Society, or the Office-Bearers, or Judicial Factor, for the time, or as shall be provided by the intended Act.

To provide for the Dissolution of the Society. To vary or extinguish the rights and privileges, or some of them, of the Members of the Society, and of the Widows and Children of deceased Members, or other persons, and to vary or extinguish all other rights and privileges which might in any manner interfere with any of the objects of the intended Act, and to confer all powers, rights, and privileges necessary or expedient for effecting those objects, or in relation
