PRESENTATIONS.

Any Lady who proposes to be presented must leave at the Lord Chamberlain's Office, St. James's Palace, before twelve o'clock, two clear days before the Drawing Room, a card with her name written thereon, and with the name of the Lady by whom she is to be presented. In order to carry out the existing regulations, that no presentation can be made at a Drawing Room excepting by a Lady actually attending that Court, it is also necessary that an intimation from the Lady who is to make the presentation, of her intention to be present, should accompany the presentation card above referred to, which will be submitted to The Queen for Her Majesty's approbation. It is Her Majesty's command, that no

presentations shall be made at the Drawing Rooms, except in accordance with the above regulations.

It is particularly requested that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them.

It is not expected that Gentlemen will present themselves at the Drawing Rooms, except in attendance on the Ladies of their families.

Any Gentleman who under these circumstances should desire to be presented, will observe the same regulations as are in force for Her Majesty's Levees.

Any Nobleman or Gentleman who proposes to be presented must leave at the Lord Chamberlain's Office, St. James's Palace, before twelve o'clock, two clear days before the Levce, a card with his name written thereon, and with the name of the Nobleman or Gentleman by whom he is to be presented. In order to carry out the existing regulations that no presentation can be made at a Levee, excepting by a person actually attending that Levee, it is also necessary that an intimation from the Nobleman or Gentleman who is to make the presentation, of his intention to be present, should accompany the presentation card above referred to, which will be submitted to The Queen for Her Majesty's approbation. PUBLIC HEALTH.

THE DAIRIES, COW-SHEDS, AND MILK-SHOPS AMENDING ORDER, 1887.

To all the Local Authorities in Scotland, in terms of 'The Public Health (Scotland) Act, 1867.'

WHEREAS by Section 34 of the Contagious Diseases (Animals) Act, 1878 (hereinafter referred to as 'the principal Act'), it was enacted that Her Majesty's Most Honourable Privy Council (hereinafter referred to as 'The Privy Council'), might from time to time make such general or special Orders as they should think fit, subject and according to the provisions of the Act, for the purposes specified in that section.

And whereas on the 15th day of June 1885, the Privy Council, in pursuance of the powers vested in them by the principal Act, made a General Order known as 'The Dairies, Cow-Sheds, and Milk-Shops Order of 1885' (hereinafter referred to as 'the Order of 1885'); and such Order extends

to the whole of Scotland.

And whereas by Article 14 of the Order of 1885, it is provided that a copy of every Regulation therein referred to shall be sent to the Privy Council, and that if at any time the Privy Council are satisfied on inquiry with respect to any Regulation that the same is of too restrictive a character, or otherwise objectionable, and direct the revocation thereof, the same shall not come into operation, or shall thereupon cease to operate, as the case may be.

And whereas by Section 9 of the Contagious Diseases (Animals) Act, 1886 (hereinafter referred to as 'the Act of 1886'), it is enacted as

follows :--

9. (1.) The powers vested in the Privy Council of making general or special orders under section thirty-four of the principal Act, for the purposes in that section mentioned, are hereby transferred to and shall henceforth be exercisable by the Local Government Board; every such order shall have effect as if enacted in this section, and shall be published in such manner as the Local Government Board may direct, and the said Board may from time to time alter or revoke any such order.

(5.) The like penalties for offences against orders or regulations made for the purposes of section thirty-four of the principal Act as amended by this section may be imposed by the Local Government Board or Local Authority making the same, and such offences may be prosecuted and penalties recovered in a summary manner, and subject to the like provisions, as if such orders or regulations were bye-laws of a Local Authority under the Public Health Act, 1875, and as if the Local Authority mentioned in that Act included a Local Authority in the metropolis as defined in this section.

(6.) (a.) The Dairies, Cow-Sheds, and Milk-Shops Order of 1885, and any regulations thereunder, or having effect in pursuance

thereof, made by any Local Authority under the principal Act, other than the Local Authority of a county, shall be deemed to have been made respectively by the Local Government Board and by a Local Authority under this section.

(7.) In the application of this section to Scotland, the expression 'Local Government Board' shall mean the Board of Supervision for relief of. the Poor and for Public Health; the expression 'Local Authority' shall mean the Local Authority under the Public Health (Scotland) Act, 1867; the expressions 'Public Health Act, 1875,' and 'section one hundred and two of the said Act' shall mean respectively the Public Health (Scotland) Act, 1867, and section seventeen of the said Act; the expression 'Bye-laws of a Local Authority' shall mean rules and regulations made by a Local Authority under the Public Health (Scotland) Act, 1867; and generally the Board of Supervision and the Local Authority under the Public Health (Scotland) Act, 1867, shall have all the powers of the Privy Council, and the Local Authority under section thirty-four of the Contagious Diseases (Animals) Act, 1878, with regard to the regulation of Dairies, Cow-Sheds, and Milk-Shops: Provided always, that no general or special order made by the Board of Supervision under this section shall be binding until it has been confirmed by the Secretary for Scotland, subject to such conditions, if any, as the Secretary for Scotland shall think fit.

And whereas it is expedient that the Order of 1885 should be altered as hereinafter mentioned, and that penalties should be imposed for offences

against such Order.

Now therefore, We, the Board of Supervision for the relief of the Poor, and for Public Health in Scotland, in pursuance of the powers vested in Us by the Act of 1886, hereby Order as follows:—

ARTICLE 1.—This Order may be cited as 'The Dairies, Cow-Sheds, and Milk-Shops Amending Order of 1887'

Order of 1887.'

ARTICLE 2.—Article 14 of the Order of 1885 shall be altered by the substitution therein of the words 'Board of Supervision' for the words 'Privy Council' occurring therein.

'Privy Council' occurring therein.

Article 3.—If any person is guilty of an offence against the Order of 1885, he shall for every such offence be liable to a penalty of Five Pounds.

Provided, nevertheless, that the Sheriff or other Magistrate before whom any complaint may be made, or any proceedings may be taken in respect of any such offence, may, if he think fit, adjudge the payment as a penalty of any sum less than the full amount of the penalty imposed by this Order.

ARTICLE 4.—In this Order the expression 'Local Authority' means the Local Authority under the Public Health (Scotland) Act, 1867.

Whereas an Act was passed in the thirtieth and thirty-first years of the reign of Her present Majesty Queen Victoria, intituled 'An Act 4 to consolidate and amend the law relating to the 'Public Health in Scotland;' and by the thirtyfirst section of the said Act it is enacted that Whenever any part of the United Kingdom 'appears to be threatened with, or is affected by, ' any formidable epidemic, endemic, or contagious ' disease, the Lords and others of Her Majesty's 'Most Honourable Privy Council, or any three or more of them (the Lord President of the Council, or one of Her Majesty's Principal Secretaries of State being one), may by Order or Orders by ' them from time to time made direct that the pro-'visions for the prevention of diseases contained in Part III. hereof be put in force in Scotland, or in such parts thereof, or in such places therein, as in such Order or Orders may be expressed, and may from time to time, as to all or any of the 'parts or places to which any such Order or Orders extend, and in like manner, revoke or renew such Order: and subject to revocation and renewal as aforesaid, every such Order shall be in force for six calendar months, or for such shorter period as in such Order shall be expressed; and every such Order of Her Majesty's 'Privy Council, or any Members thereof as afore-' said, shall be certified under the hand of the Clerk 'in Ordinary of Her Majesty's Privy Council, and 'shall be published in the Edinburgh Gazette, and 'such publication shall be conclusive evidence of such Order.'

And whereas by Order dated the 25th day of June 1885, in respect that the United Kingdom appeared to be threatened with a certain epidemic disease, that is to say, the Asiatic Cholera, the Lords of the Council did order that the provisions for the prevention of diseases, contained in Part III. of the Act thirty and thirty-first Victoria, chapter one hundred and one, should be put in force in Scotland for the space of six calendar months after the publication of the said Order in the Edinburgh Gazette.

And whereas the said Order was on the 21st December 1885 renewed for a period of three calendar months:

And whereas the said Order was on the 26th February 1886 renewed for a period of six calendar months:

And whereas the said Order was on the 16th August 1886 renewed for a further period of six calendar months, and will expire on the 16th day of February 1887:

And whereas it is expedient to renew the said Order for the space of seven weeks:

And whereas by 'The Secretary for Scotland Act, 1885,' it is provided that all powers and duties vested in or imposed on the Privy Council by Part III. of the said Public Health (Scotland) Act, 1867, shall be transferred to, vested in, and imposed on the Secretary for Scotland.

Now, therefore, in exercise of the powers conferred upon him by the said Secretary for Scotland

Act, the Secretary for Scotland does order, and it is hereby ordered, that the said Order in Council, dated the 25th day of June 1885, shall be renewed and shall continue in force for the space of seven weeks after the publication of this Order in the Edinburgh Gazette.

To all the Local Authorities in Scotland within whose District there is a Port or Harbour, in terms of 'The Public Health (Scotland) Act, 1867.'

Whereas by an Order of Her Majesty's Most Honourable Privy Council, dated the twenty-fifth day of June 1885, the provisions for the Prevention of Diseases, contained in Part III. of the Act 30 and 31 Vict. c. 101, are put in force in Scotland for the space of six calendar months after the publication of the Order in the Edinburgh Gazette.

And whereas by an Order of the Secretary for Scotland, dated the twenty-first day of December 1885, the said Order in Council is renewed and continued in force for the space of three calendar months after publication in the Edinburgh Gazette.

And whereas by an Order of the Secretary for Scotland, dated the twenty-third day of February 1886, the said Order in Council is renewed and continued in force for the space of six calendar months after publication in the Edinburgh Gazette.

And whereas by an Order of the Secretary for Scotland, dated the sixteenth day of August 1886, the said Order in Council is renewed and continued in force for the space of six calendar months after publication in the Edinburgh Gazette.

And whereas by an Order of the Secretary for Scotland, dated the ninth day of February 1887, the said Order in Council is renewed and continued in force for the space of seven weeks after publication in the Edinburgh Gazette.

Therefore, exercising the powers conferred upon them by the 33rd section of the foresaid Statute, the Board of Supervision renew the Direction and Regulation issued by them on the seventh day of July, the twenty-fifth day of August, and the twenty-sixth day of October 1886, prohibiting the Importation of Rags from Italy; and the Directions and Regulations issued by them on the twenty-sixth day of October 1886, prohibiting the Importation of Rags from Austria-Hungary; and continue the same in force, unless revoked or altered, until the first day of April 1887.
