Scheme, under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Endowment in the Parish of Crieff and County of Perth, known as Taylor's Institution, hitherto held and administered under Trust Disposition and Deed of Settlement by William Taylor, dated 16th February 1841, with Codicil thereto, dated 22nd June 1841.

Preamble.

1, 2. Future Administration; Transference of Property.

3. Constitution and Election of Governing Body.—The governing body, hereinafter called the governors, shall be constituted as follows:—

Three shall be elected by the existing Trustees of the said William Taylor, to hold office for their lives;

Two shall be elected by the Magistrates and Town Council of Crieff;

Two shall be elected by the School Board of Crieff;

On the death or resignation of office of the last of the life governors, another governor shall be elected by the School Board of Crieff;

The governors may be elected by the several electing bodies either out of their own number or otherwise. The governors elected by the Magistrates and Town Council of Crieff shall, in the case of the first election, hold office for a period of five years, and thereafter until the first day of August after

the expiry of that period. The governors elected by the School Board of Crieff shall, in the case of the first election, hold office for a period of three years, and thereafter until the first day of August after the expiry of that period. The governor to be elected by the School Board on the death or resignation of the last life governor, shall hold office for a period of five years, and thereafter until the first day of August after the expiry of that period. The governors shall, in the case of all elections subsequent to the first, hold office for a period of five years from and after the expiry of the term of office of their predecessors, except as hereinafter provided. Each election shall be made at a meeting convened and conducted according to the ordinary rules and practice of the electing body. Any governor may be re-elected. The first governors shall be elected as soon as conveniently may be after the date of this Scheme. The clerk or other officer of the governors shall, at least one month before the expiry of the term of office of any governor, give notice to the proper electing body, who shall, as soon as conveniently may be after such notice, elect a governor to hold office for the expiry of said term. Any election not made as aforesaid within three months from the date of this Scheme, or from the date of the notice of expiry of a term of office, or from the date of the notice of a vacancy, as hereinafter prescribed, shall in that case be made by the then existing governors.

4-10. Vacancies; Meetings; Chairman; Quorum; and Execution of Deeds and Minutes.

11-16. Accounts; Business Arrangements; Casual Profits; Powers of Sale and Investment; Audit.

17-20. Clauses relating to Transference of Administration.

21. Discontinuance of School, and Conditions of Transference.—The governors shall, within twelve months after the date of this Scheme, discontinue the school presently maintained by the Trustees of the said William Taylor, and shall transfer the buildings to the School Board of Crieff under the condition that the said School Board shall give free education to fifty children in a school maintained in said buildings or such other school as they may determine, under the following conditions:—The free scholars shall be children who have passed in the third or higher standards of the Scotch Code, and whose parents or guardians, not being in receipt of parochial relief, are in such circumstances as to require aid in providing elementary education, and are persons who, in the opinion of the governing body, should not be required to apply to the Parochial Board for aid in paying school fees. These free scholarships shall be awarded on the result of a competitive examination, or as a reward for regularity of attendance, industry, general merit, and good conduct, all to be ascertained by the report of the teachers and otherwise as the governing body may determine. Any payment under this clause shall be withdrawn in the case of children who fail to give regular attendance or make satisfactory progress at school.

22. Vested Interests.

Application of Income.

23. Application of Income.—The governors, after paying the necessary expenses of management, and the burdens and taxes affecting the Endowment, shall apply the free income of the

Endowment after the closing of Taylor's Institution in the manner hereinafter provided.

24. School Bursaries.—The governors shall apply the annual sum of £60 in establishing school bursaries to be called the Taylor School Bursaries, each of the yearly value of not less than £5 nor more than £10. These bursaries shall be awarded by competitive examination among pupils attending public or State-aided schools in the parish of Crieff who have passed the fifth standard of the present Scotch Code, or such standard as may from time to time be fixed by the Scotch Education Department, pursuant to the Education (Scotland) Acts, as that entitling children to total exemption from the obligation to attend school, and whose parents or guardians are in such circumstances as to require aid for giving them a higher education. These bursaries shall be tenable at Morrison's Academy for such period not exceeding three years as the governors may determine; but it shall be in the power of the governors, in the event of any bursars showing special promise, to extend the bursary for such longer period as they may determine.

25. Grant for Library.—The governors shall apply such portion of the free annual income as they may determine for the maintenance of a free library in Crieff. In the event of the Innerpeffray Library being transferred to Crieff, the free library shall be managed by a Committee of five members, of whom four shall be appointed by the governors, and one or more as may be agreed on by the governors of the Innerpeffray Mortification. The Committee shall have full power to frame such rules and regulations as they may think fit for the management of the library, and shall have the control of the expenditure of the annual sum set aside for library purposes by the governors, subject only to the obligation to report each year their proceedings to the governors.

26. Expenditure of Balance of Free Income.—The governors shall expend the remainder of the free annual income, either (1) in maintaining or assisting to maintain evening classes in Crieff, in such subjects as they may determine, and that either by payments to teachers, providing apparatus, or paying the fees for such of the pupils as require assistance; or (2) in establishing a bursary or bursaries for university or technical education, each of the annual value of not less than £20, to be awarded by competitive examination among children attending Morrison's Academy, whose parents or guardians reside in Crieff and require aid in giving them higher education. The bursary shall be tenable for three years, at a University or school for professional or technical instruction, to be approved by the governors.

27. Forfeiture of Bursaries.—If, in the judgment of the governors, the holder of any bursary shall be guilty of serious misconduct, or fail to make reasonable progress, they may withdraw such bursary, and their determination in such case shall be final.

28. Annual Distribution of Bursaries.—The governors shall establish the bursaries herein provided for in such manner as to secure that they shall be awarded in as nearly as possible equal numbers in each year.

29-34. Future Administration; Power to apply to Court of Session for Alteration; Power to make Bye-Laws and receive Additional Donations; Scheme to be Printed.

Scheme, under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Endowments in the Parish of Longside, and County of Aberdeen, known as the Mitchell's Trust, so far as applicable to educational purposes within the parish of Longside, hitherto held and administered under Trust Settlement of James Mitchell, dated 21st September 1836, and Deed of Corroboration by Miss Isobel Mitchell, dated 16th October 1838; and the Mearns Fund, hitherto held and administered under Trust Settlement by Ernest Mearns, dated 24th March 1838.

Preamble.

1, 2. Transference of Property; Discharge of Governing Body.

3-8. Conduct of Business; Powers of Sale and Investment; Casual Profits; Accounts, Audit, and Preservation of Vested Interests.

9. Disposal of Schools and Subjects at Mintlaw and Ross.—The governing body shall close the schools presently maintained by the Mitchell trustees at Rora and Mintlaw within twelve months from the date of this Scheme; provided always that on obtaining the consent of the Scotch Education Department they may continue to maintain them for such longer period not exceeding two years as may be determined. On the closing of the said schools the whole rights in and over the buildings, sites and pertinents of the said schools and other subjects at Rora now vested in the trustees of the said James Mitchell and transferred hereby to the governing body, shall be disposed of by the governing body in such manner as may seem to them best calculated to increase the income or capital of the Endowment, and all profits arising therefrom shall be held by them as part of the income or capital of the Endowment as the case may be.

10. Application of Income.—The governing body, after paying the necessary expenses of

management, and the burdens and taxes affecting the Endowment, and after making the payment hitherto made by the trustees of the said James Mitchell for the schools at Mintlaw and Rora until the closing of the said schools, shall apply the free annual income in the manner hereinafter provided.

11. Free Scholarships at Public Schools.—The governing body shall expend a sum not exceeding £10 yearly in paying the fees of poor and deserving children, with books and stationery, at public or state aided schools in the parish of Longside who have passed in the third or higher standards of the Scotch Code, and whose parents or guardians, not being in receipt of parochial relief, are in such circumstances as to require aid in providing elementary education, and are persons who, in the opinion of the governing body, should not be required to apply to the Parochial Board for aid in paying school fees. These free scholarships, which shall be called the Mearns Scholarships shall be awarded on the result of a competitive examination, or as a reward for regularity of attendance, industry, general merit, and good conduct, all to be ascertained by the report of the teachers and otherwise as the governing body may determine. Any payment under this clause shall be withdrawn in the case of children who fail to give regular attendance or make satisfactory progress at school.

12. School Bursaries.—The governing body shall apply the remainder of the free annual income in establishing school bursaries to be called the Mitchell School Bursaries, each of the yearly value of not less than £5 nor more than £10. These bursaries shall be awarded by competitive examination among pupils attending public or state-aided schools in the parish of Longside, who have passed the fifth standard of the present Scotch Code, or such standard as may from time to time be fixed by the Scotch Education Department, pursuant to the Education (Scotland) Acts, as that entitling children to total exemption from the obligation to attend school, and whose parents or guardians are in such circumstances as to require aid for giving them higher education; these bursaries shall be tenable for two years at public or state-aided schools in which efficient instruction is given in the higher branches. It shall be in the power of the governing body to accumulate such part of the free annual income as they may think fit, and to apply the same from time to time in continuing the education of any bursar of special provision for a period not exceeding two years at any school for higher or professional or technical education, but not more than £15 shall be expended by them for this purpose in any one year.
