Scheme, under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Endowments in the Parish of Inveresk and County of Edinburgh, known as Davidson's Bequest, hitherto held and administered under Deed by William Davidson, dated 7th April 1764; Clark's Donation, hitherto held by the Provost and Magistrates of Musselburgh; Wightman's Mortification; and Hastie's, Cowan's, and Kemp's Mortifications, hitherto held and administered by the Minister and Kirk-Session of Inveresk.

Preamble.

1, 2. Transference to School Board, and Discharge of Governing Body.

3-7. Conduct of Business; Power of Sale and Investment; Accounts; Audit; Vested Interests.

8. Application of Income. — The governing body, after paying the necessary expenses of management and the burdens and taxes affecting the Endowment, shall apply the income to one or other of the following objects as from time to time they see fit:—(a) They may establish one or more bursaries of the annual value of not less than £5, to be awarded by competitive examination among children attending the public or State-aided schools in the parish of Inveresk, who have passed the fifth standard of the present Scotch Code, or such standard as may from time to time be fixed by the Scotch Education Department, pursuant to the Education (Scotland) Acts, as that entitling children to total exemption from the obligation to attend school, and whose parents or guardians are in such circumstances as to require aid in giving them a higher education. These bursaries shall be tenable for two years at public or State-aided schools to be approved by the governing body; or (b) They may apply the income in paying the fees of poor and deserving children, with books and stationery, at public or State-aided schools in the parish of Inveresk, who have passed in the fifth standard of the present Scotch Code, and whose parents or guardians are in such circumstances as to require aid in giving them higher education. These free scholarships shall be awarded on the result of a competitive examination, or as a reward for regularity of attendance, industry, general merit, and good conduct, all to be ascertained by the reportof the teachers, and otherwise as the governing body may determine. Any payment under this subsection shall be withdrawn in the case of children who fail to give regular attendance or make satisfactory progress at school.

9. Forfeiture of Bursaries.—If, in the judgment of the governing body, the holder of any bursary shall be guilty of serious misconduct, or fail to make reasonable progress, they may withdraw such bursary, and their determination in such case shall be final.

Scheme, under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Endowment, in the Parish of Rothiemurchus and County of Inverness, known as Caw's Bequest, so far as applicable to Educational purposes, hitherto held and administered under Settlement by John Caw, dated 14th June 1867, and recorded in the Books of Council and Session 12th August 1870, and under Scheme by the Court of Session, dated 1878.

Preamble.

- 1. Future Administration of Endowment.—The funds of the Endowment shall remain vested as hitherto in the clerk of the Presbytery of Abernethy and the minister of Rothiemurchus, who shall pay to the governing body hereinafter constituted one-fourth of the annual income arising from the said bequest, being the properties devoted under said settlement to educational purposes, together with the interest arising from any accumulations on the said one-fourth part of the said bequest, to be administered by the said governing body, under the conditions and provisions of this Scheme.
- 2. Constitution and Election of Governing Body.—The governing body, hereinafter called the governors, shall consist of three persons, of whom:—

One shall be appointed by the Presbytery of Abernethy;

One by the Minister and Kirk-Session of Rothiemurchus; and

One by the School Board of Rothiemurchus for the time being.

The governors may be elected by the several electing bodies either out of their own number or other-The governors shall, in the case of the wise. first election, hold office for a period of three years, and thereafter until the first day of August after the expiration of that period, and they shall in the case of all elections subsequent to the first, hold office for a period of five years from and after the expiration of the term of office of their predecessors, except as hereinafter provided. Each election shall be made at a meeting convened and conducted according to the ordinary rules and practice of the electing body. governor may be re-elected or re-appointed. The first governor shall be elected or appointed as soon as conveniently may be after the date of this Scheme. The clerk of the Presbytery of Abernethy shall, at least one month before the expiry of the term of office of any governor, give notice to the proper electing body, and the electing body shall, as soon as conveniently may be after such notice, elect a governor to hold office from the expiration of said term. election not made as aforesaid within three months from the date of this Scheme, or from the date of the notice of expiry of a term of office, or from the date of a notice of a vacancy, as hereinafter prescribed, shall in that case be made by the then

existing governors, or, in the event of their disagreement, by the chairman of the School Board of the parishes of Duthil and Rothiemurchus.

3-9. Vacancies; Meetings; Chairman; Quorum;

Minutes; Accounts; and Audit.

10. Application of Income.—The governors, after paying the necessary expenses affecting the Endowment, shall apply the free income of the Endowment in the manner hereinafter provided.

11. Bursary for Higher or Technical Education.

—The governors shall establish a bursary for higher education, to be called the Caw Bursary, which shall be awarded by competitive examination among pupils attending public or State-aided schools in the parish of Rothiemurchus, whose parents or guardians require aid in giving them higher education, under such conditions and regulations as to age or otherwise as the governors may determine; it shall be tenable for such period, not exceeding three years, as the governors may determine, at such schools for higher education or technical instruction as they may approve, or at a

Scottish university.

12. School Bursaries.—If any year no qualified candidate appears for the bursary established under the immediately preceding section, or if it appears to the governors, whose determination on this point shall be final, that none of the candidates are suited by their educational attainments to attend a higher school with advantage, it shall be in their power to apply the free income for that year in awarding smaller bursaries, tenable for a year, at any public or State-aided school approved by the governors. These bursaries may be awarded either on the result of the examination for the higher bursary or by competitive examination among pupils attending public or State-aided schools in the parish of Rothiemurchus, who have passed the fifth standard of the present Scotch Code, or such standard as may from time to time be fixed by the Scotch Education Department, pursuant to the Education (Scotland) Acts, as that entitling children to total exemption from the obligation to attend school, and whose parents or guardians are in such circumstances as to require aid for giving them higher education. The governors shall have power to expend the annual income set free in any year for the purposes of this section, in the course of

the same or of any subsequent year.

13. Forfeiture of Bursaries. — If, in the judgment of the governors, the holder of any bursary shall be guilty of serious misconduct, or fail to make reasonable progress, they may withdraw such bursary, and their determination in such

case shall be final.

Scheme, under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Endowments in the Parish of Inverkeillor and County of Forfar, known as Stewart's Mortification, hitherto held and administered under Deed of Settlement by William Stewart, dated 21st December 1790; Duncan's Mortification, hitherto held and administered under Deed of Settlement by James Duncan, dated 6th September 1839, with Codicils thereto dated 11th September 1848, 20th August 1841, and 6th July 1842; and Skair's Mortification, hitherto held and administered under Trust Settlement by John Skair, dated 22nd June 1844.

Preamble.

1. Transference of Property and Administration to New Governing Body.—From and after the date of this Scheme the said Endowments shall be amalgamated, and the whole rights, funds, and estates, heritable and moveable, belonging thereto or vested in the present governing bodies thereof, shall be transferred to and vested in the School Board of the parish of Inverkeillor, and in a representative to be elected by the Kirk-Session of Inverkeillor, in such manner and for such period as they may determine, without the necessity of any new conveyance or instrument, to be held and administered by them under the conditions and provisions of this Scheme, and the said School Board, together with the said representative, shall be the governing body of the Endowment.

2-8. Discharge of Governing Body; Conduct

9. Application of Income. — The governing body, after paying the necessary expenses of management and the burdens and taxes affecting the Endowment, shall apply the free annual income in the manner hereinafter provided.

10. Payments to Teachers at Inverkeillor and Chapelton.—The governing body shall pay to the present head teacher of Inverkeillor School the annual sum of £10, so long as he shall continue to hold office, on condition that he shall give free education to twelve children who shall be selected by the governing body under the conditions of the twelfth section hereof. The governing body shall pay to the teacher of Chapelton School the annual income derived from the capital of the Duncan

and Skair Mortifications so long as he continues to hold office, on condition that he gives free education to nine children who shall be selected by the governing body under the conditions of the twelfth section hereof.

- 11. Non-Educational Purposes.—The governing body shall pay to the Kirk-Session of Inverkeillor the annual sum of £6, to be applied by them to the charitable purposes contained in the Deed of Settlement of the said James Stewart. The governing body shall, as directed in said Deed, pay the annual sum of £1 to the person officiating as beadle, bellman, and gravedigger in Inverkeillor.
- 12. Free Scholarships .- On the demission of office of the present teacher of Inverkeillor School, the governing body shall expend a sum not exceeding £10 yearly in paying the fees of poor and deserving children, with books and stationery, at the public school at Inverkeillor, and on the demission of office of the present teacher of Chapelton School, they shall expend a yearly sum not exceeding £10 in paying the fees, with books and stationery, of poor and deserving children at the public school at Chapelton. These free scholars shall be children who have passed in the third or higher standards of the Scotch Code, and whose parents or guardians, not being in receipt of parochial relief, are in such circumstances as to require aid in providing elementary education, and are persons who, in the opinion of the governing body, should not be required to apply to the Parochial Board for aid in paying school These free scholarships shall be awarded on the result of a competitive examination, or as a reward for regularity of attendance, industry, general merit, and good conduct, all to be ascertained by the report of the teachers and otherwise as the governing body may determine. Any payment under this clause shall be withdrawn in the case of children who fail to give regular attendance or make satisfactory progress at school.
- 13. Bursaries. 
