Whereas We did, by Warrant under Our Royal Sign Manual, bearing date the twentieth day of September one thousand eight hundred and eighty-six, authorise and appoint Our right trusty and well-beloved Councillor Arthur James Balfour, Our then Secretary for Scotland, together with the several gentlemen therein mentioned, or any five or more of them, to be Our Commissioners to inquire into the recent changes in the Relative Values of the Precious Metals, shown by the decrease in the gold price of silver:

Now know ye that We have revoked and determined, and do by these Presents revoke and determine, the said Warrant, and every matter and

thing therein contained.

And whereas We have deemed it expedient that a New Commission should issue for the purposes specified in such Warrant of the twentieth day of September one thousand eight hundred and

eighty-six;

Further know ye, that We, reposing great trust and confidence in your ability and discretion, have appointed, and do by these Presents nominate, constitute, and appoint you, the said Farrer, Baron Herschell; Joseph Chamberlain; Sir Louis Mallet; Henry Chaplin; Charles William Fremantle (commonly called the Honourable Charles William Fremantle); Sir John Lubbock; Sir Thomas Henry Farrer; David Miller Barbour; John William Birch; Lionel Louis Cohen; Leonard Henry Courtney; and William Henry Houldsworth; to be Our Commissioners for the purposes of the said inquiry.

And We do hereby enjoin you, or any five or more of you, to investigate the causes of the said recent changes in the Relative Values of the Precious Metals, and especially to inquire whether

the said changes are due-

To the depreciation of silver; or
 To the appreciation of gold; or
 To both these causes.

If you should find the said changes to be due to the depreciation of silver, you will then inquire whether such depreciation arises from increase of supply or diminution of demand, or from both, and you will endeavour to ascertain the proportions in which these different causes have operated.

If you should find the changes to be due to the appreciation of gold, you will inquire whether the time by adjournment.

appreciation arises from the diminution of supply or from increase of demand, or from both, and you will endeavour to ascertain the proportions in which these different causes have operated.

Having regard to these different causes and their respective effects, you will next inquire what has been the bearing of the changes in the value of the Precious Metals on the following matters of practical business-

I. India:

- (a.) Upon the remittances of the Government of India:
 - (1.) For payments on old or fixed con-
 - (2.) For payments on new or current contracts.
- (b.) Upon the persons in India who have to make remittances home in gold.
- (c.) Upon the producers, merchants, and taxpayers of India.
- (d.) Upon merchants and manufacturers at home who trade with India.

II. The United Kingdom:

- (a.) Upon the trade of the United Kingdom with other silver-using countries.
- (b.) Upon the foreign trade of the United Kingdom generally.
- (c.) Upon the internal trade and industry of the United Kingdom.

If you should come to the conclusion that the aforesaid changes in the values of the Precious Metals are causing permanent or important evils or inconveniences to any of the interests above referred to, it will be your duty then to inquire whether it is possible to suggest any remedies within the power of the Legislature or the Government, by itself or in concert with other Powers, which would be effectual in removing or palliating the evils or inconveniences thus caused without injustice to other interests, and without causing other evils or inconveniences equally

Lastly, if you are of opinion that this is possible, you will state the precise form which such remedies should take, and the manner in which they should be applied.

And for the better effecting the purposes of this Our Commission, We do, by these Presents, give and grant unto you, or any five or more of you, full power to call before you such persons as you shall judge likely to afford you any information upon the subject of this Our Commission; and also to call for, have access to, and examine all such books, documents, registers, and records as may afford you the fullest information on the subject; and to inquire of and concerning the premises by all other lawful ways and means whatsoever.

And We do further by these Presents authorise and empower you, or any five or more of you, to visit and personally inspect such places in Our United Kingdom as you may deem expedient for the more effectual carrying out of the purposes aforesaid.

And We do by these Presents will and ordain that this Our Commission shall continue in full force and virtue, and that you, Our said Commissioners, or any five or more of you, may from time to time proceed in the execution thereof, and of every matter and thing therein contained, although the same be not continued from time to

And We do further ordain, that you, or any five or more of you, have liberty to report your proceedings under this Our Commission from time to time, if you shall judge it expedient so to do.

And Our further will and pleasure is, that you do, with as little delay as possible, report to Us, under your hands and seals, or under the hands and seals of any five or more of you, your opinion upon the several matters herein submitted for your consideration.

And for the purpose of aiding you in such matters, We hereby appoint Our trusty and wellbeloved George Herbert Murray, Esquire, to be Secretary to this Our Commission.

PETITION FOR ADDITIONAL PROVISION.

(Purchase of Existing Pier at Sandbank and Ground Adjoining; Construction of New Pier at Sandbank; Compulsory Purchase of Lands; Tolls, Rates, Duties, and Charges, and Alteration thereof, and Exemptions therefrom; other Purposes.)

OTICE is hereby given, that application is about to be made for Additional Provision in a Bill now in dependence in the House of Commons, intituled "A Bill for the Construction of certain Railways between the Holy Loch near Dunoon, and Lochgilphead, Ardrishaig, and Crinan Loch, with Piers in connection therewith, all in the County of Argyll, and for other purposes," by a Petition for Additional Provision to be presented to that House by the Promoters of the said Bill, by which Additional Provision it is intended to take and confer the powers and effect the objects and purposes following (that is to say):

To authorise or to provide for the Purchase by the Company proposed to be incorporated by the said Bill (hereinafter called "the Company") from, and the Sale by the Trustees of the deceased William Frederick Hunter of Hafton (hereinafter called "the Trustees") to, and the maintenance by the Company of the existing Pier belonging to the Trustees (hereinafter called "the existing Pier"), situate in the United Parishes of Dunoon and Kilmun, and on the foreshore and bed of the Holy Loch between White Farlane Point and the Village of Sandbank, in or ex adverso of the said United Parishes, together with the Offices and whole pertinents thereof, and the Plant and fittings belonging to the Trustees in use thereat; and also to provide for the Sale by the Trustees to the Company of such Ground adjoining or near to the existing Pier as may be required by the Company for the purposes of a Station and terminal Works in connection with their intended Railway, and to make all necessary provisions incidental to and for carrying the said intended sales into effect, and with reference to such Station and Works, and the position thereof, and, failing agreement between the Company and the Trustees, for the ascertainment of the price to be paid by the Company for the existing Pier, Offices and pertinents, and Plant and fittings, and of the price or fenduty to be paid in respect of the said Ground, and of the amount of any other claims competent to the Trustees or others by reason of the acquisition of such Ground, and for fixing the extent thereof to be occupied for the said purposes.

To authorise the Company to make and maintain the following work (that is to say): a Pier on the west side of the existing Pier, commencing at a point on the Railway No. 1, as laid down on the Plans deposited with reference to the said Bill, four furlongs five chains and two decimal parts of a chain, or thereabouts, from the commencement of that Railway as shewn on the said Plans, and extending in a north-easterly direction to, and terminating at a point in the Holy Loch 400 yards or thereabouts from the said point of commencement above described, which intended work will be wholly situate in the United Parishes of Dunoon and Kilmun, and County of Argyll, and in the foreshore and bed of the Holy Loch in or ex adverso of the said United Parishes, together with all proper approaches, rails, sidings, junctions, roads, wharves, depots, warehouses, offices, cranes, and other works and conveniences in connection therewith.

To deviate laterally and vertically from the lines and levels of the said intended work as shewn on the Plans and Sections hereinafter mentioned to the extent defined thereon, or as may be prescribed by the said Bill or in the said Additional Provision.

To purchase by compulsion or agreement, and to lease, feu, or otherwise acquire for the purposes of the said intended work, Lands and Property in, and portions of the foreshore and bed of the Holy Loch in or ex adverso of the said United Parishes, and to vary or extinguish all rights and privileges over or affecting or connected with the same.

To provide and declare (if thought expedient so to do) that the Provisions of "The Harbours, Docks, and Piers Clauses Act, 1847," with respect to Lifeboats, and with respect to keeping a Tide and Weather Gauge shall not apply to the existing Pier, or to the intended Pier above described.

To empower the Company to levy tolls, rates, duties, and charges on and in respect of the use of the said existing and intended Piers, and for the accommodation of passengers and traffic thereon, and the shipment and unshipment of the same; to alter existing tolls, rates, duties, and charges, and to confer, vary, or extinguish exemptions from payment of tolls, rates, duties, and charges.

To extend and make applicable to the existing Pier on the acquisition thereof by the Company, and to the said intended Pier, all or some of the powers and provisions of the said Bill as if the said existing and intended Piers had been authorised to be acquired and constructed by the said Bill as introduced into the House of Commons.

To enable the Company, notwithstanding anything contained in "The Companies Clauses Consolidation (Scotland) Act, 1845," to pay out of the Capital or any funds of the Company from time to time Interest and Dividends on any Shares or Stock of the Company during the construction of the Railways, Piers, and other works proposed to be authorised by the said Bill and the said intended work above described, until the completion thereof respectively, or until such other time as may be prescribed by the said intended Additional Provision.

To confer upon the Company all such other powers, rights, and privileges as may be necessary

or convenient for carrying into effect the objects of the said Additional Provision, and to vary and extinguish all existing powers, rights, and privileges which would in any manner impede or interfere with any of such objects, and to confer, vary, or extinguish other rights and privileges.
