rogued to Friday the thirteenth day of January one thousand eight hundred and eighty-eight, We, by and with the advice of Our Privy Council, hereby issue Our Royal Proclamation, and publish and declare that the said Parliament be further prorogued to Thursday the ninth day of February one thousand eight hundred and eighty-eight; and We do hereby further, with the advice aforesaid, declare Our Royal will and pleasure that the said Parliament shall, on the said Thursday the ninth day of February one thousand eight hundred and eighty-eight, assemble and be holden for the despatch of divers urgent and important affairs: and the Lords, Spiritual and Temporal, and the Knights, Citizens, and Burgesses, and the Commissioners for Shires and Burghs of the House of Commons, are hereby required and commanded to give their attendance accordingly at Westminster, on the said Thursday the ninth day of February one thousand eight hundred and eighty-eight.

Given at Our Court at Osborne House, Isle of Wight, this twenty-ninth day of December, in the year of our Lord one thousand eight hundred and eighty-seven, and in the fifty-first year of Our Reign.
