EDUCATIONAL ENDOWMENTS (SCOTLAND) ACT, 1882.

OTICE is hereby given that the Commissioners under the Educational Endowments (Scotland) Act, 1882, have prepared the Draft of a Scheme for the future administration of the Endowments known as Dr. Bell's Trust, Dr. Gray's Bequest, the Bogie BEQUEST, the KIRKGATE SCHOOL, BAXTER EDUCATIONAL TRUST, in the County of Fife and Parish of Cupar, whereof an abstract is appended. The Commissioners will, in terms of the Twenty-fourth Section of said Act, receive and consider any objection made to them in writing by any public body or persons interested respecting such Scheme, and any amendments proposed thereon, provided that the same be delivered at their Office, at No. 46 George Street, Edinburgh, within two calendar months from the date hereof. Scheme, under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Endowments known as Dr. Bell's Trust, presently held and administered under the Trust Disposition and Settlement of the late Dr. Andrew Bell, of Egmore, dated 27th July 1831, and recorded in the Books of Council and Session 10th April 1832; Dr. Gray's Bequest, presently held and administered under the Trust Disposition and

Settlement of Dr. John Gray, dated 30th | June 1808; the Bogie Bequest (in so far as the same is vested in the Magistrates and Ministers of Cupar for behoof of Cupar Parish), presently held and administered by the said Magistrates and Ministers under the Trust Disposition and Settlement of Alexander Bogie, of Newmill and Balass, dated 9th October 1869; the Kirkgate School or South Branch of the Madras Academy, presently occupied and administered by the Trustees acting under the said Trust Disposition and Settlement of the late Dr. Andrew Bell, of Egmore; and the Baxter Educational Trust, presently held and administered under a Trust Deed, dated 19th and 23rd September, and 2nd October 1873, granted by the Trustees and Executors of Sir David Baxter, Baronet of Kilmaron.

Preamble.

1, 2. Future Administration: Transference of Property.

3. Constitution and Election of Governing Body.—The governing body, hereinafter called the governors, shall consist of eleven persons, of whom

Two shall be elected by the Magistrates and Council of the Burgh of Cupar;

Two shall be elected by the Burgh School Board of Cupar;

One shall be elected by the Landward School Board of the Parish of Cupar;

One shall be elected by the School Board of Springfield;

One shall be elected by the Presbytery of Cupar;

One shall be elected by the United Presbyterian Presbytery of Cupar and by the Free Church Presbytery of Cupar alternately, the United Presbyterian Presbytery to have the first election;

One shall be elected by the Lord Lieutenant of Fife;

One shall be elected by the Sheriff-Substitute of Fife at Cupar;

One: shall be elected by the Senatus of the University of St. Andrews.

The governors may be elected by the several electing bodies, either out of their own number or otherwise. The governors elected by the said School Boards, Sheriff-Substitute, and Senatus shall, in the case of the first election, hold office for a period of five years, and thereafter until the first day of August after the expiration of that period. The governors elected by the said Magistrates and Council, and by the said Presbyteries and Lord Lieutevant shall, in the case of the first election, hold office for a period of three years, and thereafter until the first day of August after the expiration of that period. The governors shall, in the case of all elections or appointments subsequent to the first, hold office for a period of five years from and after the expiration of the term of office of their predecessors, except as hereinafter provided. Each election shall be made at a meeting convened and conducted

be elected or appointed as soon as conveniently. may be after the date of this Scheme. or other officer of the governors shall, at least one month before the expiration of the term of office of any governor, give notice to the proper electing body or to the said Lord Lieutenant or Sheriff-Substitute, as the case may be, and the electing body or the said Lord Lieutenant or Sheriff-Substitute shall, as soon as conveniently may be after such notice, appoint or elect a governor to hold office from the expiration of said term. Any election or appointment not made as aforesaid within three months from the date of this Scheme, or from the date of the notice of expiration of a term of office, or from the date of the notice of a vacancy, as hereinafter prescribed, shall in that case be made by the then existing governors.

4-11. Vacancies; Meetings; Chairman ; Quorum and Execution of Deeds; Minutes;

Power to appoint Committees. 12-17. Accounts; Business Arrangements; Casual Profits; Powers of Sale and Investment;

Audit.

18. First Meeting. - Within two months from the date of this Scheme, a meeting of the governors shall be held, upon the summons of the Lord Lieutenant of Fife. At this meeting they shall make arrangements for the conduct of business, and shall elect a chairman, but they shall not, at this, or any subsequent meeting, transact any business that is not necessary for the immediate administration of the Endowment until the whole of the first governors are elected or appointed.

19-21. Clauses relating to Transference of Administration.

22. Discontinuance of School.—The governors shall, within twelve months after the date of this Scheme, discontinue the school presently maintained in the buildings known as the Kirkgate School or South Branch of the Madras Academy, . and shall sell the school buildings with the playground, fittings, furnishings, parts and pertinents, by public roup, after due advertisement; but the governors shall be bound to offer the said buildings, playground, fittings, furnishings, parts and pertinents to the School Board of the Burgh of Cupar, and to sell the same to the said Board at any time within the said twelve months at the price of £360.

23. The School Board of the Burgh of Cupar shall, under the condition and provision hereinafter made and provided at the same date as that fixed by the governors under the 19th section hereof for the Transference of the Endowment, obtain possession of the buildings and other subjects in Cupar other than the said Kirkgate School presently occupied by and in possession of the Trustees of Dr. Bell and known as the Madras Academy, and the said Trustees shall cede possession at the said date of the said buildings and subjects to the said School Board. The said buildings and subjects are, subject to the condition and provision hereinafter made and provided, hereby excepted from the general conveyance to the governors of the rights, funds, and estates belonging to the Endowments, or vested in the present governing bodies, and all the right, title, and interest in the said buildings and subjects belonging to, or vested in, the said governing bodies, shall be and hereby are, from and after the according to the ordinary rules and practice of the electing body. Any governor may be re-elected or re-appointed. The first governors shall of Dr. Bell shall at the said date transfer to the

said Board any titles to the said buildings and others to which they themselves may have right. But it is provided and declared that the said School Board shall not be entitled to obtain possession of the said subjects or to claim a transference of the right, title, and interest of Dr. Bell's Trustees in and to the saine, unless and until they shall make payment to the governors of a sum of £1794 to be applied by them under the provisions of this Scheme.

24. Vested Interests.

Application of Income.

25. Application of Income.—The governors, after paying the necessary expenses of management and the burdens and taxes affecting the Endowment, shall apply the free income of the Endowment, in the manner hereinafter provided.

Endowment, in the manner hereinafter provided.

26. Free Scholarships.—The governors may, so long as they continue to receive any payment or revenue or benefit from the estate of the said Alexander Bogie, but no longer, apply a sum not exceeding £30 yearly in paying, in whole or in part as they may think fit, the fees of scholars, with books and stationery, at public or State-aided schools in the parish of Cupar, both landward and burgh, for elementary education as defined in the Educational Endowments (Scotland) Act, 1882. The free scholars shall be children whose parents or guardians, not being in receipt of parochial relief, are in such circumstances as to require aid for providing elementary education, and are persons who, in the opinion of the governors, ought not to be required to apply to the Parochial Board for such aid.

In the case of children under ten years of age, the selection of free scholars shall be made with due regard to merit, as ascertained by such examination, suited to the age of the candidates, as the governors may from time to time prescribe; or in the case of children for whom such examination is unsuitable, by evidence that the children possess such qualifications as to justify their selection; and in the case of children who have been in attendance at school during one or more school years, the governors shall, in making their selection, give special weight to good conduct, attendance, and progress at school during the previous year. The fees in respect of children under ten years of age shall not be paid for more than one school year without re-appointment, and the amount to be expended in paying fees for such children shall not exceed one-third of the amount to be applied under this section.

In the case of children over ten years of age and upwards, the free scholars shall be selected by competitive examinations, which shall be open to all of the same age who are eligible in terms hereof, whether they have or have not previously been beneficiaries; and for such children the school fees may continue to be paid for such period, not exceeding three years, as the governors may determine. If any scholar gain a school bursary his school fees shall no longer be paid

under this section.

The governors, at the end of every school year, shall obtain from the teacher or teachers a special report as to the conduct, regularity of attendance, and progress of all scholars whose school fees are paid in whole or in part under this section, and the fees of no scholar shall continue to be paid in regard to whom such report is not satisfactory.

27. School Bursaries.—The governors shall apply an annual sum not exceeding £50 in estab-

lishing school bursaries, one half of which shall be called the Gray Bursaries, each of the yearly value of not less than £5 nor more than £10. These bursaries shall be awarded by competitive examination among pupils attending public or Stateaided schools in the parish of Cupar, both burgh and landward, who have passed the fifth standard of the present Scotch Code, or such standard as may from time to time be fixed by the Scotch Education Department, pursuant to the Education (Scotland) Acts, as that entitling children to total exemption from the obligation to attend school, and whose parents or guardians are in such circumstances as to require aid for giving them higher education, and the Gray Bursaries shall be tenable exclusively by girls so qualified; these bursaries shall be tenable for two years at the Bell-Baxter School.

28. Bell-Baxter School.—The governors shall maintain and keep in good repair the buildings of the Baxter Institution, and shall expend upon extension and alteration of the said buildings the said sum of £1794, to be paid by the said School Board. The governors shall maintain a school in the said buildings so altered and extended, to be

called the Bell-Baxter School.

29. Subjects of Instruction.—The subjects to be taught in the school shall include reading, writing, arithmetic, book-keeping, and mensuration, geography and history, English grammar, composition and literature, Greek and Latin, at least two modern languages, music, mathematics and drawing, at least one subject of natural science, and such other subjects as the governors may from time to time determine, but the governors shall pay special attention to making due provision for the instruction of girls in the higher subjects of instruction appropriate to them.

30. Division into Higher and Lower Departments.—The school shall be divided into a higher department and a lower or preparatory department. The lowest class in the higher department shall correspond as nearly as may be to the sixth

standard of the present Scotch Code.

31. Boys and Girls to be Taught Separately.— The boys and girls shall as far as possible be taught in separate class rooms, and shall have

separate accommodation and entrances.

32. Admission to School. — Children shall, before admission to the higher department of the school, pass an examination of such nature as shall be fixed by the governors, conducted by or under supervision of the head master. Subject to this condition, the school shall be open to all children of good health and character so far as there is room for them.

33. School Fees.—The governors shall charge school fees except as hereinafter provided. The fees charged in the lower or preparatory department shall cover the whole cost of education in

that department.

34. Appointment of Head Master.—The governors shall appoint a head master to the school. In all appointments after the first the head master shall be a graduate of some University of the United Kingdom. The governors shall appoint the head master at a meeting to be specially called for the purpose, after having taken such steps, by advertisement or otherwise, as they shall deem best calculated to obtain suitable candidates.

35. Dismissal of Head Master.—The governors may dismiss the head master without assigning cause, after three calendar months' written notice

given to him in pursuance of a resolution passed at two consecutive special meetings, held at an interval of at least fourteen days, such resolution being affirmed by at least two-thirds of the governors, present on each occasion. The governors, for what in their opinion is urgent cause, may, by a resolution passed at a special meeting, and affirmed by not less than two-thirds of the whole number of governors for the time being, declare that the head master ought to be dismissed from his office without notice, and in that case they may appoint another special meeting, to be held not less than seven days after the former one, and may then dismiss him by a like resolution, affirmed by not less than two-thirds of the governors for the And if the governors assembled at time being. the first of such special meetings think fit at once to suspend the said head master from his office until the next meeting, they may do so by resolution affirmed by not less than two-thirds of the whole number of governors for the time being. Due notice and opportunity for explanation and defence shall in each case be given to the head

36. Management of School.—Subject to the approval of the governors and to the rules prescribed by or under the authority of this Scheme, the head master shall have under his control the choice of books, the methods of teaching, the arrangement of classes and school hours, and generally the whole organisation, discipline, and management of the school; and shall have the power of expelling children from the school or suspending their attendance thereat for any cause that appears to him sufficient, subject to an appeal to the governors.

37. Assistant Teachers.—The head master shall have the power of appointing and dismissing all assistant teachers; but no appointment or dismissal of an assistant teacher shall be final until approved by the governors, and in all such cases the approval or disapproval of the governors shall be entered in the minutes.

38. Head Master's Salary.—The head master shall have a fixed yearly salary of not less than £200, and in addition, if the governors think fit, a capitation grant on such scale as may be fixed

by them.

39. General Supervision.—Subject to the provisions of this Scheme, the governors shall, after due consultation with the head master, prescribe the general subjects of instruction, the relative prominence and value to be assigned to each subject, the school terms, vacations, and holidays. They shall take the general supervision of the school buildings and arrangements. They shall determine the number of assistant teachers, and fix their salaries and mode of payment.

fix their salaries and mode of payment.

40. Inspection.—The school shall be periodically inspected in such manner as the Scotch Education Department may from time to time prescribe, and the cost of such inspection shall be paid out of the funds of the Endowment.

- 41. Forfeiture of Bursaries.—If, in the judgment of the governors, the holder of any bursary shall be guilty of serious misconduct, or fail to make reasonable progress, they may withdraw such bursary, and their determination in such case shall be final.
- 42. Annual Distribution of Bursaries.—The governors shall establish the bursaries herein provided for in such manner as to secure that they shall be awarded in as nearly as possible equal numbers in each year.

43. Residue of Income.—The residue of the free annual income, in so far as it has not been applied under the provisions of this Scheme, shall be invested by the governors as soon as it shall amount to £50 and form part of the capital fund of the Endowment.

Application of Income. — The governing body shall apply a sum of £10 of the income to one or other or all of the following objects as from time to time they see fit:—(a) They may establish one or more bursaries of the annual value of not less than £3, to be awarded by competitive examination among children attending the public or State-aided schools in the parish of Bargrennan, who have passed the fifth standard of the present Scotch Code, or such standard as may be from time to time fixed by the Scotch Education Department, pursuant to the Education (Scotland) Acts, as that entitling children to total exemption from the obligation to attend school, and whose parents or guardians are in such circumstances as to require aid in giving them a higher education. These bursaries shall be tenable for two years at public or State-aided schools to be approved by the governing body; or (b) They may pay the fees of poor and deserving children, with books and stationery, at public or State-aided schools in the parish of Bargrennan, who have passed in the third standard of the present Scotch Code, and whose parents or guardians are in such circumstances as to require aid in giving them higher education. These free scholarships shall be awarded on the result of a competitive examination, or as a reward for regularity of attendance, industry, general merit, and good conduct, all to be ascertained by the report of the teachers, and otherwise as the governing body may determine. Any payment under this sub-section shall be withdrawn in the case of children who fail to give regular attendance or make satisfactory progress at school; (c) They may award a sum not exceeding £2, 10s. annually in prizes to the children attending public or State-aided Schools in the parish of Bargrennan. Such prizes may be awarded upon the report of the teacher, or on the result of an examination, but the governors shall in any case satisfy themselves that the prizes are awarded as the result of good conduct and progress in school work.

10. Gratuitous Instruction beyond Standard V.—The governing body may pay the balance of the free annual revenue of the Endowment into the School Fund on condition always that they shall be bound to give gratis instruction at the public schools in the parish of Bargrennan to children who have passed the fifth standard, and whose parents or guardians are in such circumstances as to require aid in providing such instruction.

11. Forfeiture of Bursaries. — If, in the judgment of the governing body, the holder of any bursary or of other benefits under this Scheme shall be guilty of serious misconduct, or fail to make reasonable progress, they may withdraw such bursary or other benefit, and their determination in such case shall be final.
