

Scheme under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Endowment in the Parish of Gourock and County of Renfrew, known as the Rainy Endowment, at present administered under a Deed of Trust and nomination, dated 29th, and recorded in the Books of Council and Session 30th, both days of January 1856.

Preamble.

1, 2. Transference of Property, and Discharge of present Governing Body.

3-8. Business Arrangements; Powers of Sale and Investment; Casual Profits; Accounts; Audit; Vested Interests.

9. Application of Income. — The governing body, after paying the necessary expenses of management and the burdens and taxes affecting the Endowment, shall apply the free annual income to the purposes specified in the following clauses.

10. Prizes.—The governing body may apply, if they shall see fit, a sum not exceeding £5 per annum in providing prizes of such number and amount as they may from time to time determine, to be awarded among pupils attending public or State-aided schools in Gourock for proficiency in religious knowledge, or in such other subject as the governing body may from time to time determine. These prizes shall be awarded under such regulations and conditions as the governing body may from time to time prescribe, provided always that they shall have due regard to merit as ascertained by examination or otherwise.

11. Bursaries.—The governing body shall apply the residue of their free annual income to one or other or both of the following objects, as from time to time they see fit:—(a) They may establish one or more bursaries of the annual value of not less than £3, to be awarded by competitive

examination among girls or, failing any girl properly qualified, among boys attending the public or State-aided schools in the parish of Gourock, who have passed the fifth standard of the present Scotch Code, or such standard as may be from time to time fixed by the Scotch Education Department, pursuant to the Education (Scotland) Acts, as that entitling children to total exemption from the obligation to attend school, and whose parents or guardians are in such circumstances as to require aid in giving them a higher education. These bursaries shall be tenable for two years at public or State-aided schools to be approved by the governing body; or (b) They may accumulate the said residue, or a part thereof, and apply the accumulations or the said residue in giving a bursary of not less than £10 nor more than £15. The bursary shall be awarded by competition among girls or, failing any girl properly qualified, among boys attending public or State-aided schools in the parish of Gourock, whose parents or guardians are in such circumstances as to require aid in giving them a higher education, under such conditions and regulations as to age or otherwise as the governing body may from time to time determine. It shall be tenable for a period not exceeding two years at such school for higher education or technical instruction as the governing body may approve, or at a Scottish University.

12. Forfeiture of Bursaries .- If, in the judgment of the governing body, the holder of any bursary shall be guilty of serious misconduct, or fail to make reasonable progress, they may withdraw such bursary, and their determination in

such case shall be final.

13-15. Power to apply to Court of Session for Alteration; Power to make Regulations. Scheme to be Printed.

the Endowments known as John Lorimer's Mortification, at present held and administered under a Deed of Mortification, dated 8th August 1677, by John Lorimer, Town Clerk of Cullen; the Tochieneal Mortification, at present paid to the School Board of Cullen, and administered by them; the Birdsbank Mortification, mortified by William Leslie, of Birdsbank, for behoof of the Schoolmasters of Cullen, by Deed, dated 24th January, 1676; Hay's Rood or the Schoolmaster's Croft, mortified by James Smith, merchant, Norwich, in fulfilment of the intentions of his father, the Rev. James Smith, of Lowestoft, Suffolk, by Deed, dated 9th July 1714; Watson's Mortification, bequeathed by John Watson, merchant, Edinburgh, dated 24th February 1721; and Duncan's Bequest, at present held and administered under a Deed of Mortification by Alexander Duncan, blacksmith, Cullen, dated 16th October 1845, and recorded 13th October 1862.

Preamble.

1, 2. Future Administration; Transference of Property.

3. Constitution and Election of Governing Body.—The governing body, hereinafter called the governors, shall consist of five persons, of whom

Two shall be elected by the Magistrates and Council of Cullen;

Two shall be elected by the School Board of Cullen;

One shall be elected by the Kirk-Session of Cullen.

The governors may be elected by the several electing bodies, either out of their own number or otherwise. The governors elected by the Magistrates and the Kirk-Session shall, in the case of the first election, hold office for a period of five years, and thereafter until the first day of August after the expiration of that period. The governors elected by the School Board shall, in the case of the first election, hold office for a period of three election, hold omce for a possession, and thereafter until the first day of years, and thereafter until the first day of that period. The August after the expiration of that period. The governors shall, in the case of all elections subsequent to the first, hold office for a period of five years from and after the expiration of the term of office of their predecessors, except as hereinafter provided. Each election shall be made at a meeting convened and conducted according to the ordinary rules and practice of the electing body. Any governor may be reelected. The first governors shall be elected as soon as conveniently may be after the date of this Scheme. The clerk or other officer of the governors shall, at least one month before the expiration of the term of office of any governor, give notice to the proper electing body, and the electing body shall, as soon as conveniently may be after such notice, elect a governor to hold office from the expiration of said term. Any election not made as aforesaid within three months from the date of this Scheme, or from the date of the land) Act, 1882, for the Administration of notice of expiration of a term of office, or from the date of the notice of a vacancy, as hereinafter prescribed, shall in that case be made by the then existing governors:

4-11. Vacancies; Meetings; Chairman; Quorum and Execution of Deeds; Minutes; Power to appoint Committees.

12-17. Accounts; Business Arrangements; Casual Profits; Powers of Sale and Investment; Audit.

18. First Meeting.—Within two months from the date of this Scheme, a meeting of the governors shall be held upon the summons of the Provost of Cullen. At this meeting they shall make arrangements for the conduct of business, and shall elect a chairman; but they shall not at this, or any subsequent meeting, transact any business that is not necessary for the immediate administration of the Endowment until the whole of the first governors are elected or appointed.

19-22. Clauses relating to Transference of Administration and Discharge of Governing Bodies; Vested Interests.

Application of Income.

23. Application of Income.—The governors, after paying the necessary expenses of management and the burdens and taxes affecting the Endowment, shall apply the free income of the Endowment in the manner hereinafter provided.

24. Free Scholarships.—The governors may apply a sum not exceeding £15 yearly in paying, in whole or in part, as they may think fit, the fees of scholars, with books and stationery, at public or State-aided schools in the burgh and parish of Cullen, for elementary education as defined in the Educational Endowments (Scotland) Act, 1882. The free scholars shall be children whose parents or guardians, not being in receipt of parochial relief, are in such circumstances as to require aid for providing elementary education, and are persons who, in the opinion of the governors, ought not to be required to apply to the Parochial Board for such aid.

In the case of children under ten years of age, the selection of free scholars shall be made with due regard to merit, as ascertained by such examination, suited to the age of the candidates, as the governors may from time to time prescribe; or in the case of children for whom such examination is unsuitable, by evidence that the children possess such qualifications as to justify their selection; and in the case of children who have been in attendance at school during one or more school years, the governors shall, in making their selection, give special weight to good conduct, attendance, and progress at school during the previous year. The fees in respect of children under ten years of age shall not be paid for more than one school year without re-appointment, and the amount to be expended in paying fees for such children shall not exceed one-third of the amount to be applied under this section.

In the case of children of ten years of age and upwards, the free scholars shall be selected by competitive examinations, which shall be open to all of the same age who are eligible in terms hereof, whether they have or have not previously been beneficiaries; and for such children the school fees may continue to be paid for such period, not exceeding three years, as the governors may determine. If any scholar gain a school bursary, his school fees shall no longer be paid under this section.

The governors, at the end of every school year, shall obtain from the teacher or teachers a special report as to the conduct, regularity of attendance, and progress of all scholars whose school fees are paid in whole or in part under this section, and the fees of no scholar shall continue to be paid in regard to whom such report is not satisfactory.

25. University or Technical School Bursaries. The governors may from time to time, as they shall see fit, apply an annual sum, not exceeding £20, in establishing a bursary for university or technical education, which shall be called the Lorimer Bursary. This bursary shall be awarded by competitive examination among those who have been pupils in public or State-aided schools in the parish or burgh of Cullen for at least six months before the date of examination; it shall be tenable for such period, not exceeding four years, as the governors may determine, at a university or technical school to be approved by the governors. The governors shall have power to apply such part of the residue of their annual income in any one year not exceeding £20, as they shall see fit, to the purposes of this section, or to accumulate for a series of years such smaller portion of the said residue as they may consider necessary to provide for the said bursary when it shall in their opinion be expedient to award it.

26. School Bursaries.—The governors shall apply the residue of their annual income, in so far as it shall not be applied or accumulated under the powers of the immediately preceding section, in establishing school bursaries, each of the yearly value of not less than £5 nor more than £10. These bursaries shall be awarded by competitive examination among pupils attending public or State-aided schools in the parish and burgh of Cullen, who have passed the fifth standard of the present Scotch Code, or such standard as may from time to time be fixed by the Scotch Education Department, pursuant to the Education (Scotland) Acts, as that entitling children to total exemption from the obligation to attend school, and whose parents or guardians are in such circumstances as to require aid for giving them higher education; these bursaries shall be tenable for two years at public or State-aided schools in which efficient instruction is given in the higher branches.

27. Forfeiture of Bursaries.—If, in the judgment of the governors, the holder of any bursary shall be guilty of serious misconduct, or fail to make reasonable progress, they may withdraw such bursary, and their determination in such case shall be final.

28. Annual Distribution of Bursaries.—The governors shall establish the bursaries herein provided for in such manner as to secure that they shall be awarded in as nearly as possible equal numbers in each year.
