REGULATIONS

TO BE OBSERVED AT THE QUEEN'S LEVEES TO BE HELD BY HIS ROYAL HIGHNESS THE PRINCE OF WALES, ON BEHALF OF HER MAJESTY, AT ST. JAMES'S PALACE.

By Her Majesty's Command,

The Noblemen and Gentlemen who propose to attend Her Majesty's Levee, at St. James's Palace, are requested to bring with them two large

cards, with their names *clearly written* thereon, one to be left with The Queen's Page in attendance in the Corridor, and the other to be delivered to the Lord Chamberlain, who will announce the name to His Royal Highness.

PRESENTATIONS.

Any Nobleman or Gentleman who proposes to be presented must leave at the Lord Chamberlain's Office, St. James's Palace, *before twelve o'clock*, two clear days before the Levees, a card with his name written thereon, and with the name of the Nobleman or Gentleman by whom he is to be presented. In order to carry out the existing regulations that no presentation can be made at a Levee, excepting by a person actually attending that Levee, it is also necessary that an intimation from the Nobleman or Gentleman who is to make the presentation, of his intention to be present, should accompany the presentation card above referred to, which will be submitted to The Queen for Her Majesty's approbation. It is Her Majesty's command that no presentations shall be made at Levees, except in accordance with the above regulations.

It is particularly requested that in every case the names be *very distinctly written* upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them to His Royal Highness.

The State Apartments will be open for the reception of Company coming to Court at half-past one o'clock.

Scheme under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Endowments in the Parish of Campbeltown and County of Argyll, known as the Argyll Street Female School of Industry, and the Endowment left in the hands of the Minister and Kirk-Session of Campbeltown for behoof of the said School under the Will of Miss Lucy Campbell, dated 29th September 1841, being originally a sum of £600 with all interest and accumulations thereon.

Preamble.

1. Transference of Property and Administration to New Governing Body.—From and after the date of this Scheme the said Endowments shall be amalgamated, and the whole rights, funds, and estates, heritable and moveable, belonging thereto or vested in the present governing bodies thereof, shall be transferred to and vested in the governing body created under a Scheme prepared under the provisions of the said Educational Endowments Act, for the tenure and administration of the Campbell Trust in the said parish of Campbeltown, without the necessity of any new conveyance or instrument, to be held and administered by them under the conditions and provisions of that Scheme, it being declared that the provisions of the 9th section of that Scheme shall apply to the case of the teacher of the Female School of Industry hereby transferred.

2. Discharge of Present Governing Body.—The present trustees of the Endowments shall transfer and make over to the clerk, treasurer, or other proper officer of the said governing body, all cash balances, books, deeds, and papers to which they have right as trustees foresaid. On such payment or transference, the governing body shall discharge such lawful debts of the Endowment as may remain unpaid by the said trustees, and shall, after satisfactory examination and

audit of their accounts, grant them a discharge for their intromissions with the funds of the Endowment.
