Scheme under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Endowments in the Parish of Troqueer and County of Kirkcudbright, known as the Patterson Endowment, at present held and administered under the Trust Disposition of Robert Patterson, dated 30th September 1862, and recorded in the Register of Sasines at Dumfries on 2nd October of that year; the Dalskairth Bequest, at present held and

administered under the last Will and Testament of David Milligan, Esq. of Dalskairth, dated 21st, June 1797; the Lawrie Bequest, at present held and administered under the Trust Disposition and Settlement of Miss Elizabeth Lawrie, dated 9th November 1870, who died on 6th April 1872; the Hamilton and Gibson Prizes, at present held and administered in terms of a gift by James Starke, of Troqueer Holm, and under a Holograph Codicil to his Settlement, dated 8th October 1868, and recorded in the Books of Council and Session 18th November 1879; and the Carrick Bequest, at present held and administered by

under of John Carrick, of Gibbon Hill.

Preamble.

1. Transference of Property and Administration to New Governing Body.-From and after the date of this Scheme the said Endowments shall be amalgamated, and the whole rights, funds, and estates, heritable and moveable, belonging thereto or vested in the present governing bodies thereof shall, without the necessity of any new conveyance or instrument, be transferred to and vested in the School Board of the parish of Troqueer along with a person to be elected after the date of this Scheme by the trustees of Miss Elizabeth Lawrie, to hold office for life, and a person to be elected from time to time by the Kirk-Session of Troqueer, for such period as they may determine, with power to the said person to resign his office, and with and under this declaration that if the person so elected shall for a period of two years not attend at least one of the meetings of the governing body, he shall ipso facto be held to have vacated his office, and the Kirk-Session may make a new appointment. Any person shall be capable of re-election. The said School Board, with the persons so elected, shall be the governing body of the Endowment to hold and administer under the conditions and provisions of this Scheme.

2. Discharge of Present Governing Body.—
The present trustees of the Endowments shall transfer and make over to the clerk, treasurer, or other proper officer of the School Board, who shall after the date of this Scheme act as officers of the governing body of the Endowment, all cash balances, books, deeds, and papers to which they have right as trustees foresaid. On such payment or transference the governing body shall discharge such lawful debts of the Endowments as may remain unpaid by the said trustees, and shall, after satisfactory examination and audit of their accounts, grant them a discharge for their intromissions with the funds of the Endowments.

3-8. Conduct of Business; Power of Sale and Investment; Casual Profits; Accounts; Audit; Vested Interests.

9. Application of Income.—The governing body, after paying the necessary expenses of management and the burdens and taxes affecting the Endowment, shall apply the free annual income as hereinafter directed.

10. Fees for Children on Estate of Dalskairth.The governing body may apply an annual sum

not exceeding £2, 10s., in paying the fees of poor and deserving children, with books and stationery, at public or State-aided schools in the parish of Troqueer, who have passed in the third standard or of the present Scotch Code, and whose parents guardians are resident on the estates of Dalskairth or Light Waterford, and are in such circumstances as to require aid in giving them higher education. These free scholarships shall be awarded on the result of a competitive examination, or as a reward for regularity of attendance, industry, general merit, and good conduct, all to be ascertained by the report of the teachers, and otherwise as the governing body may determine. Any payment under this sub-section shall be withdrawn in the case of children who fail to give regular attendance or make satisfactory progress at school.

11. Payment for Religious Knowledge.—The governing body may apply a sum not exceeding £5 annually, in awarding prizes for religious knowledge, among the children attending public or State-aided schools in the parish, and that under such conditions as the School Board and Managers of such schools may from time to time, with approval of the governing body, see fit to arrange.

12. Bursaries, &c.—The governing body shall apply the residue of the free annual income to one or other or both of the following objects, as from time to time they see fit, and that in such proportions as they shall from time to time determine:—(a) They may establish one or more bursaries of the annual value of not less than £3 and not more than £7, to be awarded by competitive examination among children attending the public or State-aided schools in the parish of Troqueer, who have passed the fifth standard of the present Scotch Code, or such standard as may be from time to time fixed by the Scotch Education Department, pursuant to the Education (Scotland) Acts, as that entitling children to total exemption from the obligation to attend school, and whose parents or guardians are in such circumstances as to require aid in giving them a higher education. These bursaries shall be tenable for two years at the Dumfries Academy, or at such other public or State-aided school as may be approved by the governing body; or (b)
They may apply the income in paying the fees of poor and deserving children, with books and stationery, at public or State-aided schools in the parish of Troqueer, who have passed in the fifth or higher standard of the present Scotch Code, and whose parents or guardians are in such circumstances as to require aid in giving them higher education. These free scholarships shall be awarded on the result of a competitive examination, or as a reward for regularity of attendance, industry, general merit, and good conduct, all to be ascertained by the report of the teachers, and otherwise as the governing body may determine. Any payment under this sub-section shall be withdrawn in the case of children who fail to give regular attendance, or make satisfactory progress at school.

13. Forfeiture of Bursaries.—If, in the judgment of the governing body, the holder of any bursary shall be guilty of serious misconduct, or fail to make reasonable progress, they may withdraw such bursary, and their determination in such case shall be final.

Two shall be elected by the School Board of

the Burgh of Alloa;

Two shall be appointed by Messrs. John Paton, Son, & Company, Kilneraigs Factory, Alloa, or by any firm or person who may succeed them in the said works; and

One shall be elected by the workmen at the Kilneraigs Factory, who are twenty-one years of age, and have been employed in the works for upwards of six months.

The governors elected by the Burgh School Board of Alloa shall, in the case of the first election, hold office for a period of five years, and thereafter until the first day of August after the expiry of that period. The governors may be elected by the several electing bodies either out of their own number or otherwise. Any governor may be re-elected or re-appointed. Any payment under this clause shall be withdrawn in the case of children who fail to give regular attendance or make satisfactory progress at

24. Free Scholarships for Half-Time Workers.—The governors may expend a sum of £60 in paying, in whole or in part, the fees, with books and stationery, for half-time workers attending the Paton School. These free scholarships shall be awarded on the result of a competitive examination, or as a reward for regularity of attendance, industry, general merit, and good conduct, all to be ascertained by the report of the teachers, and otherwise as the governors may determine. School Bursaries.—The governors shall apply an annual sum of £40 in establishing school bursaries, to be called the Paton School Bursaries, each of the yearly value of not less than £5 nor more than £10. require aid for giving their children higher education; these bursaries shall be tenable for two years at public or State-aided schools in which efficient instruction is given in the higher branches.

26. Evening Classes.—The governors shall apply the remainder of the free income of the Endowment in maintaining evening classes in Alloa for such scientific or literary subjects as they may determine. All workers employed in Kilneraigs Factory shall have free admission to the said evening classes, but only under such conditions and regulations as to regularity of attendance, conduct, and progress as the governors may see fit to make.
