## PRESENT,

The QUEEN's Most Excellent Majesty in Council.

THEREAS by an Act passed in the forty-fifth and forty-sixth years of Her Majesty's reign, intituled 'The Militia Act, one thousand eight hundred and eighty-two,' it is amongst other things enacted that, save as therein otherwise provided, the Militia shall be trained and exercised for not less than twentyone days, and not more than twenty-eight days in every year, at such times and at such places in every part of the United Kingdom as Her Majesty may appoint, and also that Her Majesty may, from time to time, with the advice of Her Privy Council, order that the period of training and exercise in any year of all or any part of the Militia be extended, but so that the whole period of training and exercise be not more than -fifty-six days.

And whereas it is expedient that the training of the 2nd Brigade, Lancashire Division, Royal Artillery (formerly the Royal Lancashire Artillery Militia), and the 6th Brigade, Scottish Division, Royal Artillery (formerly the Argyll and Bute Artillery Militia), and also of the Royal Anglesey Engineer Militia, the Royal Monmouthshire Engineer Militia, and the Southern Submarine Mining Militia, should be extended beyond the period of twenty-eight days for the year one thousand eight hundred and eighty-eight.

Now, therefore, Her Majesty, with the advice of Her Privy Council, is pleased to order and direct that the period of training and exercise of the before-specified regiments and brigades of Militia shall, for the year one thousand eight hundred and eighty-eight, be extended, under the provisions of the before-cited Act, from twenty-eight days to the number of days in each case hereinafter mentioned; that is to say,—

2nd Brigade, Lancashire Division, Royal Artillery, thirty-four (34) days.

6th Brigade, Scottish Division, Royal Artillery, thirty-four (34) days.

Royal Anglesey Engineer Militia forty-one (41) days.

Royal Monmouthshire Engineer Militia forty-one (41) days.

Southern Submarine Mining Militia fifty-six (56) days.

### PRESENT, OF LOCALISIS

The QUEEN's Most Excellent Majesty in Council.

Whereas by the 'Burial Grounds (Scotland) Act, 1855,' as amended by 'The Secretary for Scotland Act, 1885,' it is enacted that it shall be lawful for Her Majesty from time to time, by Order in Council, upon the representation of the Secretary for Scotland, that a copy of an Interlocutor of a Sheriff of a County of Scotland under certain provisions of the said Act has been received, in pursuance thereof, to order that no new Burial Ground shall be opened within certain limits specified in such Order, save with the previous approval of the Secretary for Scotland (or as the case may require), that after a time mentioned in such Order, Burials within certain limits, or in certain Burial Grounds or Places of Burial, shall be discontinued wholly or subject to any exceptions or qualifications mentioned in such Order, and that such Order in Council shall thereupon have like force and effect as if the same were embodied in the said Act: Provided always, that notice of such representation, and of the time it shall please Her Majesty to order the same to be taken into consideration by the Privy Council, shall be transmitted to the Crown Agent in Edinburgh, and the Sheriff-Clerk of the County in which such Burial Ground is situated; and that the same shall be by them respectively published in the Edinburgh Gazette, and fixed on the doors of the Church of, or on some conspicuous places within, the Parishes affected by such representation, one month before such representation is so considered:

And whereas the Secretary for Scotland has, under the provisions of the Burial Grounds (Scotland) Act, 1855, made a representation stating that he has received a copy of an Interlocutor of the Sheriff-Substitute of Fifeshire, finding, on a Petition presented to him by certain Members of the Parochial Board of Ferry-Port-on-Craig, 'that the Churchyard or 'Old Burying Ground of the Parish of Ferry-'Port-on-Craig in question is, and has been for 'several years, in an overcrowded state, and

that it is dangerous to health, and offensive and

contrary to decency:

And whereas in the said representation it is recommended that the said Burial Ground be closed for Burials with certain exceptions:

And whereas notice of the said representation, and of the time when it pleased Her Majesty to order the same to be taken into consideration by a Committee of the Lords of the Privy Council, has been duly published in the Edinburgh Gazette, and has been fixed as required by the said Act:

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, is pleased to order, and it is hereby ordered, that Burials be forthwith discontinued in the said Churchyard or Old Burying Ground of the Parish of Ferry-Porton-Craig, with the following named exceptions, viz.:—

- As regards common ground, in favour of Widows and Widowers whose spouses have been buried there;
- (2) As regards private burying grounds within the Churchyard, in favour of—
  - A. Widows and Widowers whose spouses have been buried there;
  - B. Unmarried Members of families whose parents have been interred in the ground;
  - C. The following named persons at their decease, viz.:—
    - James Simpson, residing in Dalgleish Street, Tayport, and his wife, Ann Baldie or Simpson.
    - Andrew Lawrie and Mrs. Elizabeth Kidd or Lawrie.
    - David Harley, Mason, Tayport, and Ann Pattie or Harley.
    - John Jolly, Sheriff Office, Tayport, and Marjory Imrie or Jolly, his wife.
    - James Laing, Merchant, Tayport, and Mrs. Jack or Laing, his spouse.
    - Mrs. Ann Thomson, Glasgow, widow of Alexander Thomson.

Provided that no grave shall be less than five feet deep, that no grave shall be buried in unless it can be opened to that depth without the exposure of coffins, and that notice shall be given to the Sanitary Inspector of the Parish of Ferry-Port-on-Craig on the day preceding that on which the grave is to be opened; provided also, that the permission to inter is revocable at any time.

- Scheme under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Endowment known as Cauvin's Hospital, at present held and administered under the Trust Disposition and Settlement of Louis Cauvin, teacher in Edinburgh, dated 26th March 1817, with relative Codicils, and the Statutes 7 and 8 Geo. IV. c. xi. and 5 and 6 Vic. c. xxxix.

#### Preamble.

1, 2. Future Administration; Transference of

Property.

3. Constitution and Election of Governing Body.—The governing body, hereinafter called the governors, shall consist of the following persons, viz. :-

One person to be elected by the Magistrates and Town Council of Edinburgh;

Two persons to be elected by the Senatus of the University of Edinburgh;

Two persons to be elected by the Directors of the Highland and Agricultural Society;

Two persons to be elected by the existing Trustees of Louis Cauvin, to hold office for life;

Two persons to be elected by the other governors, who shall be interested in agricultural matters either as proprietors or as tenant-farmers.

The governors other than those elected by the governors themselves may be elected by the several electing bodies either out of their own number or The governors elected by the Magisotherwise. trates and Town Council of Edinburgh and the Directors of the Highland and Agricultural Society shall, in the case of the first election, hold office for a period of five years, and thereafter until the first day of November after the expiration of that period. The governors elected by the Senatus and the other governors shall, in the case of the first election, hold office for a period of three years, and thereafter until the first day of November after the expiration of that period. The governors to be elected by the other governors shall be elected at the first meeting held after the election of the other governors. The governors shall, in the case of all elections subsequent to the first, hold office for a period of five years from and after the expiration of the term of office of their predecessors, except as hereinafter provided. Each election shall be made at a meeting convened and conducted according to the ordinary rules and practice of the electing body. Any governor may be re-elected. The first governors shall be elected as soon as conveniently may be after the date of this Scheme. The clerk or other officer of the governors shall, at least one month before the expiry of the term of office of any governor, give notice to the proper electing body, and the electing body shall, as soon as conveniently may be after such notice, elect a governor to hold office from the expiration of said term. Any election not made as aforesaid within three months from the date of this Scheme, or from the date of the notice of expiry of a term of office, or from the date of the notice of a vacancy, as hereinafter prescribed, shall in that case be made by the then existing governors.

4-12. Vacancies; Meetings; Chairman ; Quorum and Execution of Deeds; Minutes; Power to appoint Committees; Accounts.

13-17. Business Arrangements; Powers of

Sale and Investment; and Audit.

18. First Meeting.—Within two months from the date of this Scheme, a meeting of the governors shall be held upon the summons of the clerk to the present trustees. At this meeting they shall make arrangements for the conduct of business, and shall elect a chairman; but they shall not at this, or any subsequent meeting, transact any business that is not necessary for the immediate administration of the Endowment until the whole of the first governors are elected or appointed.

19-21. Clauses relating to Transference of Administration and Discharge of Governing

Body.

22. Discontinuance of School.—The governors shall, within twelve months after the date of this Scheme, discontinue the school presently maintained by Cauvin's Trustees, and shall, except in the event hereinafter mentioned, either sell or let the school buildings and pertinents at a fair rent, as

to them may seem best.

23. Scholars presently receiving Education.—
The governors shall have power to board out the children receiving education at the date of this Scheme in Cauvin's Hospital, and to pay to or for each of the said foundationers or to the persons with whom they are boarded, or to their parents or guardians, for their behoof, for the time during which they would have remained in the Hospital, an annual sum not exceeding £20 in any case for their maintenance and clothing, which sum shall be expended subject to the control of the governors. The governors may also pay for the education, with books and stationery, of such children at such schools as the governors may approve, and that for such period as they would have remained in the Hospital.

24. Vested Interests.

# Application of Income.

25. Application of Income.—The governors, after paying the necessary expenses of management and the burdens and taxes affecting the Endowment, shall apply the free income of the Endowment in the manner hereinafter provided.

26. Board and Education of Beneficiaries .-The governors shall select such number of boys as the state of their funds, having regard to the whole purposes of this Scheme, will admit, but in any event not more than twenty, who shall be the sons of respectable but poor teachers, or the sons of poor but honest farmers. The governors shall apply an annual sum not exceeding £10 for the clothing, maintenance, and education of each boy so selected. The said annual sum shall be spent in such manner and paid to such persons, and under such conditions, as the governors may in each case direct. No boy shall be selected until he has attained the age of nine years, and if there be a greater number of candidates than vacancies, the governors shall, in selecting the boys, have due regard to merit, and in the case of boys who have been in attendance at school they shall give special weight to good conduct, attendance, and progress at school. Each boy selected shall enjoy the benefits conferred by this section for such period as the governors shall determine, but not in any case after he has passed the fifth standard of the Scottish Code, or attained the age of thirteen years.

27. Power to give Higher Education.—The governors may, in the case of any of the boys so selected who may have shown himself of such

promise as to make it desirable that he should obtain further education, continue to pay to him or for his behoof, for a period of not more than three years, sums not exceeding £20 a year, on condition that he shall attend such school for higher or technical instruction as the governors may approve. The governors shall have power to grant to such boy, in place of the foresaid allowance, an allowance for the same period at a rate not exceeding £10 a year, in cases where such boy shall be bona fide engaged in farming work and shall attend evening classes or some other course of instruction in agriculture approved by the governors.

28. Alternative Scheme for Residue.—After making due provisions for the purposes of the foregoing sections, the governors shall expend the whole residue of their free annual income in establishing one or other of the systems of agricultural education hereinafter specified.

29. I. Practical Instruction.—The governors shall have power to enter into an agreement with the Highland and Agricultural Society of Scotland to join in establishing and maintaining, in a situation as near Edinburgh as conveniently may be, a school or college for practical and theoretical instruction in agriculture, including sheep and dairy farming and cattle and horse breeding and rearing, and any other branches of farming industry practised or practicable in Scotland, along with a farm connected with it or in immediate proximity to it, and to expend the residue of their free annual income on such school or college and farm. Any agreement so entered into may provide for buying or renting and furnishing and stocking such land or premises as may be necessary for such school or college and farm and the various farm-buildings and laboratories connected therewith, and for the borrowing of such capital sums as may be necessary for these purposes, provided always that any loans to be so contracted shall be paid off within a period of thirty years from the date of borrowing. In the event of the governors adopting this alternative of the Scheme, it shall be in their power to retain and keep up the present buildings and pertinents of Cauvin's Hospital as part of such school or college. The governors shall, along with the Highland and Agricultural Society as aforesaid, arrange for lodging and boarding in the said school or college such boys, who have been foundationers under the 26th section hereof. as they may select, so long as they attend the said school or college, and engage in the practical work of the farm. They shall also arrange for the board and lodging of such other lads, sons of poor farmers or teachers, as the buildings of the said school or college will accommodate. The charges for the board and lodging of such foundationers and others shall not exceed the cost of their board, and the governors shall give them credit, in computing the cost of their board, for the value of their labour in the practical work After making due provision for the of the farm. board and lodging of such lads, the governors may receive as boarders such, other pupils in the said school or college as they may think fit, at such charges as they may fix, but in no case at a less charge than the cost of their board and lodging. The governors along with the Highland and Agricultural Society as aforesaid may place the course of instruction in the said school or college under the general direction and superintendence of the Professor of Agriculture in the University of Edinburgh.

30. II. Theoretical Education, &c. — The governors in place of establishing such school or college and farm may, and failing an agreement with the Highland and Agricultural Society to establish such school or college and farm shall, expend their free annual income in all or any of the following purposes, and that in such proportions as they may from time to time determine: -(a) They may pay sums of money, not exceeding £10 per annum in any one case, to teachers in public or State-aided schools in Scotland, on condition that they shall attend a course of lectures on agricultural or kindred sciences for at least one month, to be delivered by the Professor of Agriculture in the University of Edinburgh. The said sums shall not be paid except upon the certificate of the said Professor that the student has been regular in his attendance, and no student shall receive a payment under this head for more than two years. In the event of there being more applicants in any one year than the funds at the disposal of the governors for this purpose will provide for, they shall select the candidates as far as possible from districts of the same agricultural character; (b) the governors may give grants to School Boards or to Educational Trusts estab-lished by Schemes under the provisions of the Educational Endowments (Scotland) Act, 1882, to enable such boards or trusts to establish in country districts and carry on evening classes or other courses of instruction in agricultural subjects, and to supply apparatus, models, plans, or drawings for such classes, and in all such cases the governors shall stipulate that a certain number of poor farmers' or teachers' sons shall be admitted gratis to such classes or courses of instruction; (c) the governors may from time to time give grants to libraries in country districts to assist them in obtaining standard works on agriculture, agricultural periodicals or reports, or models or drawings of agricultural implements or machinery; (d) the governors may pay an annual salary from time to time to a person skilled in agriculture or any of the kindred sciences, who shall, as the governors may from time to time approve, give a course or courses of lectures in such subjects in such part or parts of Scotland as may be agreed upon between him and the But it shall always be a condition governors. of any such appointment that the sons of farmers or teachers shall be admitted free to the lectures to be delivered by such lecturer.

31. Forfeiture of Bursaries.—If, in the judgment of the governors, the holder of any of the educational benefits under this Scheme shall be guilty of serious misconduct, or fail to make reasonable progress, they may withdraw such benefit, and their determination in such case shall be final.

32. Annual Distribution of Bursaries.—The governors shall establish the bursaries or other classes of benefits herein provided for in such manner as to secure that they shall be awarded in as nearly as possible equal numbers in each year.

33. Residue of Income.—The residue of the free annual income, in so far as it has not been applied under the provisions of this Scheme, shall be invested by the governors as soon as it shall amount to £50, and form part of the capital fund of the Endowment.
