Leicester-House, February 8. This Day the Baron de Cramm, Envoy Extraordinary from the Duke of Brunswick, had his Audience of Leave of her Royal Highness the Princess Dowager of Wales.

To all which he was introduced by Sir Charles Cottrell Dormer, Knt. Master of the Ceremonies.

Admirally-Office, February 10. Rear Admiral Holmes, in his Letter from Iamaica, of the 11th of November last, to Mr. Clevland, gives an Account, of having Intelligence, that five French Frigates, with other Vessels, were getting ready at Cape François, to fail in the Month of October for Old France ; he made a proper Disposition of His Majesty's Ships under his Command to intercept them ; and having stationed them accordingly, the Enemy failed from the Cape the 16th of the faid Month of October, with the five Frigates and other Veffels, to the Number of Eight Sail.

That on the 17th, at Sun-rife, the Hampshire, Lively, and Boreas, faw them due East, and gave Chace; Cape Nicholas bearing S. by E. eight Leagues. They difcovered them foon to be the Enebut their utmost Efforts were buffled all Day my; by little and variable Winds, fo that they neared them but flowly.

In the Evening the Breeze freshned, which brought them fast up with the Chace; and at Twelve at Night, the Boreas, being the headmost Ship, got along fide the Sirenne, commanded by Commodore M'Cartie. They engaged very fmartly for 25 Mi-nutes, when the Sirenne declined the Action, shot a-head, and wanted to get off. The Boreas, difabled in his Rigging, could not again close with her till Two in the Afternoon of next Day; when a vigcrous Action recommenced off the East End of Cuba, and continued till 40 Minutes past Four, when the Sirenne struck.

At the Time the Boreas first engaged the Sirenne, she was to the Northward of the Hampshire and Lively, who were in Chace of the other four Frigates, that were making the beft of their Way to the Southward; but the Night being dark and fqually, they were only able to keep Sight of them.

On the 18th, at Day-light, the Enemy were fix Miles a head of the Lively, exerting all their Skill to make the Welt End of Tortuga, and get into Port au Paix. The Lively, who made good Use of her Oars, was confiderably a-head of the Hampshire, and got up along-fide the Valeur, the fternmost of the Enemy, at Half an Hour paft Seven, when a very fmart Action enfued, and continued for an Hour and a Half, when the Valeur struck.

The Hampshire kept on after the other three Frigates ; and the Wind freihning, the gained to fast upon them, that, at Half paff I hree in the After-noon, fhe got between the Duke de Choifeul and the Prince Edward, the two headmost Ships, and open'd her Fire upon them ; but the first having the Advantage of the Wind, made her Retreat good into Port au Paix; the other run on Shore about two Leagues to Leeward, when the ftruck her Colours; and, on the Hampshire preparing to take Possession, the Enemy set her on Fire, and the blew up.

On the 10th, in the Morning, the Hampfhire, having the Lively and her Prize in Company, made Sail towards Fresh-Water Bay, which lies a little further to the Leeward of Port au Paix, to take or destroy the Fleur de Lis, their sternmost of the three Figates fhe had chafed the Day before; but on his

Approach, the Enemy likewife fet her on Fire, and the blew up.

Three of the five Frigates, viz. the Sirenne, the Fleur de Lis, and the Valeur, were King's Frigates, and landed 643 Veteran Troops, with a Brigadier-General, at Martinico, in their Way from France to Cape François; the other two belonged to Merchants; and they were all loaded with Indigo and Sugar.

I have annexed an Account of the Five Frigates intercepted by the Detachment posled, as above, in the Western Passage; and beg Leave to congratulate their Lordships on our Success, and the interesting Lofs fuftained by the Enemy, on this Occafion. At the fame Time, it gives me the agreeable Opportunity of expressing my perfect Effeem and Approbation of the Conduct and Spirit of the three Com-manders, aad the Officers and Men of His Majefty's three Ships, who fell in with the Enemy; and I have no lefs Efteem for the Officers and Men of all the other Ships, who shewed the greatest Diligence and Attention, in guarding the other Paffages, upon the fame Service.

The Duc de Choifeul, a Merchant Frigate, Capt. Bellevan, of 32 Guns and 180 Mer, efcaped into Port au Paix.

The Prince Edward, a Merchant Frigate, Capt. Dubois, of 32 Guns and 180 Men, burnt and destroyed to Leeward of Port au Paix, the 18th of October.

The Fleur de Lis, a King's Frigate, Capt. Diguarty, of 32 Guns and 190 Men, burnt and destroyed in Fresh Water Bay, to Leeward of Port au Paix, Lthe 19th of October.

Captain Levifon Gower, of His Mzjefty's Ship Quebec, brought into Gibraltar Bay, the 27th of December, a French Privatier called the Phoenix, of 18 Guns and 125 Men, which he had taken off Cape Palos.

Captain Loggie, of His Majefty's Ship Brilliant, gives an Account, in his Letter of the 2d Iuftant, of his having that Day, in Latitude 49°. 23', and Longitude 9°. 10'. W. retaken and fent into Plymouth, the John and Elizabeth, of London, from GuarGuardeloupe, Andrew Cornish, Master, which was taken at Noon by the Many, a French Privatier of St. Maloes, of 22 Guns.


