The KING's most Excellent Majesty in Council.

THEREAS the Time limited by His Majesty's Order in Council of the 27th of October last, for prohibiting the Exporting out of this Kingdom, or carrying Coastwife, Guntowder, Salt Petre, or any Sort of Arms or Ammunition, expired upon the 29th Day of this Instant April whereas it is judged expedient for His Majesty's Service, and the Safety of this Kingdom, that the said Prohibition should be continued for some longerTime: His Majesty doth therefore, by and with the Advice of His Privy Council, hereby Order, Require, Prohibit and Command, That no Person or Persons whatsoever (except the Master General, Lieutenant General, or Principal Officers of the Ordnance for His Majesty's Service) do, at any Time, during the Space of Six Months, to commence from the fall 29th Day of this Instant April, presume to transpost into any Parts out of this Kingdom, or carry Coastwife, any Gunpowder, Salt Petre, or any Sort of Arms or Ammunition, or thip or lade any Gunpowder, Salt Petre, or any Sort of Arras or Amagnition, on Board any Ship or Vessel, in order to deniporting the same into any Parts beyond the Seas, or carrying the fame Coastwise, without Leave or Permission in that Behalf first obtained from His Majesty, or His Privy Council, upon Pain of incurring and suffering the respective Forfeitures and Penalties inflicted by an A& paffed in the Twenty Ninth Year of His late Majesty's Reign, entituled, "An Act to impower His Majesty to pro"hibit the Experiment of Salt Petre, and to enforce " the Law for impowering His Majesty to provious " the Exportation of Gunpowder, or any Sort of Arms and Ammunition; and also to impower His " Majesty to restrain the carrying Coastwife of Sal: "Petre, Gunpowder, or any Sort of Arms or Ammuinition." And the Lords Commissioners of His Majesty's Treasury, the Commissioners for Executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master General of the Ordnance, and His Majesty's Secretary at War, are to give the necessary Directions herein, as to them may respectively appertain.

And the Governors of the faid Charity intending to distribute to the Widows of Sea Officers who died before the 30th of August 1732, as well as to the Widows of those who ried since that Time, whose Circumstances come within the Rules of the Establishment, such Monies as may be aue to them on the 31st of May Instant; This is to give Notice thereof, that any Widows who have not yet applied, and intend to lay in their Claims, may do so as soon as possible; and that all such Widows whose Claims have been already allowed, may send or bring to this Office, by the 31st of this Instant, the Affida-vits required by the Rules, in order to their being continued upon the Pension or Bounty.
